

SUMMARY OF COUNTY VETERANS' SERVICE OFFICER, VETERANS' CLAIMS, AND  
TRANSPORTATION AID INFORMATION BY COUNTY

This memorandum provides a summary of county veterans' service officer full-time equivalent (FTE) positions, county veterans' service officer salaries, county veterans' service officer mill levies, veterans' population, veterans' claims, and transportation aid by county.

More information regarding the expenditures is attached as an appendix.</p> <p><sup>6</sup>North Dakota has eight vans located around the state--two in Bismarck and one each in Williston, Cavalier, Fargo, Jamestown, Stanley, and Lidgerwood--that provide veterans' transportation to Fargo. The vans were purchased through the veterans' postwar trust fund and the DAV Colorado trust fund. For 2007 the cost of the program was funded 65 percent from the veterans' postwar trust fund and 35 percent from the DAV Colorado trust fund. In years previous to 2007 the cost of the program was split evenly between the veterans' postwar trust fund and the DAV Colorado trust fund. The Administrative Committee on Veterans Affairs has obligated \$69,000 from the veterans' postwar trust fund for the transportation program for the 2007-09 biennium.</p> <p><sup>7</sup>The county veterans' service officer for Stark County also serves Dunn County.</p> <p><sup>8</sup>The county veterans' service officer for Morton County also serves Oliver County.</p> <p><sup>9</sup>The county veterans' service officer did not respond to the Legislative Council survey.</p> <p><sup>10</sup>In addition, the Department of Veterans Affairs processed 785 claims in calendar year 2007.</p>
