



#### Comparison of Federal Fund Expenditures and General Fund Ongoing Revenues and Appropriations





Federal fund expenditures include retirement and disability, other direct payments, grants, procurement contracts, and salaries and wages, but does not include direct loans, guaranteed loans and insurance, interest paid on federal government debt, travel expenses when not provided under procurement contracts, and international payments and foreign aid.

#### Comparison of North Dakota Crop Production Values and General Fund Ongoing Revenues and Appropriations





# Comparions of North Dakota Farm Real Estate Values Per Acre and General Fund Ongoing Revenues and Appropriations





# Comparison of Prices Per Barrel of Oil in North Dakota and General Fund Ongoing Revenues and Appropriations





# Comparison of North Dakota Oil Production and General Fund Ongoing Revenues and Appropriations





### Comparison of North Dakota's Gross State Product and General Fund Ongoing Revenues and Appropriations





# Comparison of Beef Cattle Values Per Cwt and General Fund Ongoing Revenues and Appropriations




