- 1 A BILL for an Act to create and enact a new section to chapter 54-52.1 of the North Dakota
- 2 Century Code, relating to public employees retirement system health insurance coverage of
- 3 colorectal cancer screening; to provide an appropriation; and to provide an expiration date.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 **SECTION 1.** A new section to chapter 54-52.1 of the North Dakota Century Code is 6 created and enacted as follows:

Insurance to cover colorectal cancer screening. For all contracts or plans for health

insurance which become effective after June 30, 2009, and which do not extend past June 30,

2011, the board shall provide medical benefits coverage under a contract for insurance

10 pursuant to section 54-52.1-04 or under a self-insurance plan pursuant to section 54-52.1-04.2

11 of the same type offered under the policy or contract for illnesses for colorectal cancer

12 screening examinations and laboratory tests of asymptomatic individuals in accordance with

13 generally accepted standards of medical practice for colorectal cancer screening, such as the

14 guidelines established by the American cancer society or the American college of

15 gastroenterology. For purposes of this section, the determination of an individual's screening

risk factors upon which the individual's screening strategy is based must be made by the

individual's physician.

SECTION 2. PUBLIC EMPLOYEES RETIREMENT SYSTEM - COLORECTAL

19 CANCER SCREENING HEALTH MANDATE DIRECTIVE. Pursuant to section 54-03-28, the

20 public employees retirement system shall prepare and request introduction of a bill to the

21 sixty-second legislative assembly to repeal the expiration date of section 1 of this Act and to

22 extend the colorectal cancer screening coverage to apply to all group and individual accident

23 and health insurance policies. The public employees retirement system shall append to the bill

24 a report regarding the effect of the colorectal cancer screening coverage requirement on the

- system's health insurance programs, information on the utilization and costs relating to the
 coverage, and a recommendation on whether the coverage should continue.
- 3 **SECTION 3. APPROPRIATION.** The funds provided in this section, or so much of the funds as may be necessary, are appropriated out of any moneys in the general fund in the state
- 5 treasury, not otherwise appropriated, and from other funds derived from federal funds and other
- 6 income, to the following agencies for the purpose of defraying the cost of additional health
- 7 insurance premiums necessary to provide the coverage under section 1 of this Act, for the
- 8 biennium beginning July 1, 2009, and ending June 30, 2011, as follows:
