1 A BILL for an Act to provide an appropriation for defraying the expenses of the securities
2 commissioner; and to provide for a report to the legislative assembly.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. BASE LEVEL FUNDING INFORMATION.** The amounts identified in this
5 section represent the base level funding component appropriated to the securities
6 commissioner in section 3 of this Act as follows:

7 Salaries and wages	\$1,105,588
8 Operating expenses	<u>570,855</u>
9 Total all funds - Base level	\$1,676,443
10 Less estimated income - Base level	<u>217,199</u>
11 Total general fund - Base level	\$1,459,244

12 **SECTION 2. FUNDING ADJUSTMENTS OR ENHANCEMENTS INFORMATION.** The
13 amounts identified in this section represent the funding adjustments or enhancements to the
14 base funding level for the securities commissioner which are included in the appropriation in
15 section 3 of this Act as follows:

16 Salaries and wages	\$160,933
17 Operating expenses	<u>4,456</u>
18 Total general fund - Adjustments/enhancements	\$165,389

19 **SECTION 3. APPROPRIATION.** The funds provided in this section, or so much of the
20 funds as may be necessary, are appropriated out of any moneys in the general fund in the state
21 treasury, not otherwise appropriated, and from special funds derived from other income, to the
22 securities commissioner for the purpose of defraying the expenses of that agency, for the
23 biennium beginning July 1, 2007, and ending June 30, 2009, as follows:

6 **SECTION 4. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO**
7 **SIXTY-FIRST LEGISLATIVE ASSEMBLY.** The total general fund appropriation line item in
8 section 3 of this Act includes \$16,876 for the one-time funding identified in this section. This
9 amount is not a part of the agency's base budget to be used in preparing the 2009-11 executive
10 budget. The securities department shall report to the appropriations committees of the
11 sixty-first legislative assembly on the use of this one-time funding for the biennium beginning
12 July 1, 2007, and ending June 30, 2009.
