Dear Committee Members:

My name is Ray Wilkens and my family and I moved to the Grand Forks area in 1976. We lived in the City of Grand Forks for nine months which is the time it took to find a place in the country. We purchased 29 acres of farm land in Rye Township, Section 12 and made it our home. We preferred not to live in the city then and we still feel the same way.

In the past six months the residents of Rye Township have been TOLD many things.

- (a) We have been TOLD that the ET zoning around Grand Forks has been extended another two miles around the City. That zoning includes one half of my land.
- (b) We have been TOLD that the City is going to place its new landfill in Section 13 of Rye Township.
- (c) The Rye Township Board of Supervisors has TOLD the City that the "township" is in agreement with the City's plans.
- (d) A meeting was held for the Rye Township residents to vote "for" or "against" the proposed landfill, but we were TOLD the vote would not count.

Apparently, the ET zoning issue began a couple of year's ago, but did not come to the attention of the residents of Rye Township until last year. For this reason I have been researching the issue to better inform myself. The following are items I found interesting:

- 1. A quote from the website of GF Herald reporter, Tu-Uyen Tran, on 01/22/08. "The city doesn't need the ETZ out to four miles. It doesn't even expect to grow out to the two-mile line in the next several decades. Council member Eliot Glassheim once figured it'd take another 200 years to get to the four-mile line." (The north edge of town 32 years ago is still the north edge of town today. I believe that the city implemented that zoning with the landfill in mind.)
- 2. From the GF Herald dated March 2006, Final Edition, Section A, Page 1 CITY EXPANDS ITS ZONING AUTHORITY Author: Tu-Uyen Tran, Herald Staff Writer: "Council members Eliot Glassheim and Bob Brooks, the dissenters on the council on this issue, said they'd rather see the city finish figuring before expanding its zoning authority. "I keep hearing from staff and proponents: 'We're going to pass it tonight and then we're going to refine it,'" Glassheim said. "Huh?" "This is the craziest way to pass an ordinance I've ever heard of," he said."
- 3. And one last quote from Tu-Uyen Tran's website, posted 7/21/08. "The Grand Forks City Council had some great discussion tonight on the Adventureland amusement park proposed for the south end of town. The long and short of it is the council said "no" when originally it gave every indication of saying "yes" all because some area residents said "not in my backyard."" Why do they have a say and not us?

- 4. I had heard that the Grand Forks County Commissioners were opposed to the ET zoning without a vote from the townships, but the City Council passed the zoning anyway. I contacted chairwoman, Constance Triplett, to confirm this in writing and was invited to the County Commissioner's meeting on August 5th. At that meeting it was agreed 4-0 to send such a letter to this committee's chairman, Lee Kaldor.. This letter might have already been received by you or should be shortly.
- 5. At a Rye Township meeting held July 29th a motion was made and voted upon that our Board of Supervisors also write a letter opposing the zoning and the landfill. It was to be ready for me to bring here to Bismarck. To date no letter has been received. Apparently, they prefer to back the City over keeping their word and representing our township.
- 6. The city TOLD us it wants to preserve farmlands, yet it has decided to use the only section in Rye Township that is 100% farmed. The map that is included in your packet shows that there are only 2 homes in the sections surrounding the current landfill. None of the sections in Rye Township surrounding this landfill are farmed. The landfill has ruined the land around it. There are 104 homes within one mile of the proposed new landfill. I am checking with the Department of Health on the environmental ramifications of this on our families and the well water which some of us drink. I realize that the landfill issue is separate from the ET zoning but it's that zoning that is giving the City the power to bully us.

I, for one, do not agree with the things that are happening. and I didn't feel that my neighbors did either. For this reason I decided to take a survey of the residents of Rye Township. During the past several weeks I spoke personally with as many residents as I could find at home. This is what I found:

- 1. I visited approximately 93 homes and received signatures from 176 residents who are opposed to the ET zoning and the Rye Township landfill. (A list of people that signed is included in your packet. A copy of the actual signatures is included in the Chairman's packet). I spoke with four residents who refused to sign. Of these, one was opposed to the ET zoning but had no problem with the landfill unless it would be in his backyard. (His home is on the opposite end of the township.) One was opposed to both the zoning and the landfill, but said signing it would be a conflict of interest with their job. One family wants to be bought out so they can move. One individual said the City can put the landfill in his backyard, however, his wife and neighbors did not feel the same.
- 2. There are 120 homes in Rye Township several parcels of land have more than one home. (A map showing how many homes are in each section is included in your packet.)
 - 1. 8 are unoccupied
 - 2. 4 are for sale
 - 3. 2 are under construction
 - 4. 1 is being moved in
 - 5. Several have purchased land with the intent to build a home.

Many residents could not get away from jobs or farming to attend this meeting. I hope this survey will convey their feelings to you. I wonder ... if this same survey were taken in the rest of the surrounding townships, would the results be the same. I think so.

Conclusion: As I was growing up, my father often told me the story about there only being two things in life about which we can do nothing. Those things are dying and paying taxes. In all other things we should have a say. It's been over 50 years since I was in school, but as I recall, I learned that the Constitution gave us that right to vote or has that changed? Our voice should be heard. Our vote should count, and I urge you to vote to move back the four-mile ET zoning.


