Policy 207 - Promotional Expenses

Vouchers for promotional expenses will be permitted only for those groups involved in promoting North Dakota, its goods, or services. Agencies are expected to use restraint and common sense in authorizing these types of expenses.

All requests to be classified as a promotional agency must be made in writing to the Director of the Office of Management and Budget and must provide the reason(s) for being classified as such.
