Once a release of information by the injured worker has been received, WSI Constituency Services records, reviews, and responds to all inquiries from public officials throughout the state and addresses concerns presented to their offices by their constituents. Customary inquiries typically originate from the governor's office, congressional offices, and state senators and representatives. Constituent requests are logged with the public official that made the initial inquiry.
