JDA History -- Hazen

Honorable Members of the ND Legislature:

Thank you for the opportunity and honor to be invited to visit about Hazen's Job Development Authority (JDA). I have been privileged to work for the City of Hazen since 1999.

Hazen's JDA was formed on April 18, 1988 by the City of Hazen. The city commission entered into a contract on that date with Hazen Community Development, Inc. (HCD) to conduct the functions of a city Job Development Authority, including advertising, promoting and developing industrial and business expansion within the City of Hazen. A tax levy of 4 mills was authorized. In 1995 when Hazen (using Home Rule) voted in a 1 cent sales tax of which the JDA was designated 50 percent.

From June 16, 1995 to August 14, 2007 Hazen's one-cent sales tax totaled \$1,586,791.95 of which the JDA has controlled 50 percent.

The City of Hazen supported the HCD office fiscally until 2006 at which time the authorized 4 mill levy was implemented and the financial assistance from the city was decreased accordingly.

All sales tax funds are approved first by the HCD board and then submitted to the City Commission of Hazen for final approval. In many cases the process starts with recommendations from the executive committee of HCD – then with recommendation to the full board of HCD – and finally with recommendation to the Hazen City Commission.

It's my opinion that the City of Hazen is a better community as a direct result of JDA and later the Home Rule, Sales Tax, Renaissance Zone, and the Renaissance Fund Organization. When I came to Hazen our Main Street had several vacated buildings. They are now filled with businesses and more are being built new. However, we still have a long way to go.
