REGARDING COUNTY JOBS DEVELOPMENT ACTIVITY

Chairman Grindberg and members of the Workforce Committee, thank you for your request to compile information regarding business incentives provided in whole or in part through funding generated by County Jobs Development Authorities. As the Committee may be aware, 35 counties currently levy a property tax for this purpose, and several other counties have indicated they use General or other funds to support JDA activities. A list of county 2006 JDA levies is attached at the end of this testimony.

Our office surveyed the County JDA's and asked a number of specific questions about business incentives granted in Calendar Year 2006. Unfortunately, the timing of this request was such that much of the data is still arriving. We were able to provide the survey to each JDA by Thursday, October 18th, but the Economic Developers' statewide training conference began that next Monday – limiting the time available to many for responding to our request. From the data provided to-date, the Committee can possibly make some projections and assumptions.

In general, the funding generated by JDA levies is a crucial, but relatively minor component of the business incentives provided Statewide. Several responses included comments suggesting that the JDA Levy funds are "just the tip of the iceberg" when it comes to local economic development. It is also obvious; however, this funding is much more important in the smaller counties with fewer alternative resources. Whereas, some of the larger City/County economic development efforts rely almost exclusively on dedicated sales tax revenue for incentives, and the relatively small amount generated by dedicated property taxes is only a minor factor.

From the surveys received to-date – representing approximately 35 percent of the counties with JDA levies – the following summary data was compiled.

The Committee additionally requested information on the prevalence of local JDA organizations taking equity positions in supported businesses, as addressed by SB2149 in the past Legislative Session. From the survey responses we learned that 1 (10%) of the responding entities have an equity position in one or more businesses. The following table lists the number and types of businesses involved, and the average share of the business held by the JDA.
