Chairman Keiser: Opened the hearing on HB relating to the worker's compensation definition of artificial members as it relates to compensable injuries.

Jennifer Clark~Legislative Council. Go over the changes of HB 1061. We are changing the definition of artificial members.

Representative Ruby: Since this would be damage to the devise accompanied by the injury, it wouldn't have repaired the scratched of the duties earlier.

JClark: That's correct.

Representative Gruchalla: This is a bill that increases benefits for injured workers and there is no cost to it.

JClark: The first part is correct, it designed expand the benefits that are currently offered in the WSI program. I can't speak for the fiscal impact.

Representative Ruby: I have a question about the fiscal impact. I know is doesn't affect the reserve because it's perspective but, what is the estimated adjustment to the premium in future of ongoing?

Green: No adjustment to the premium. It will not have a fiscal impact.

Sebald Vetter~C.A.R.E. The bill was here in the 60's. Why was the bill taken out? I support HB 1061.

Sylvan Loegering~ North Dakota Injured Worker Support Group. This bill fits into the bigger picture. It brings the pendulum back. I've figured out that WSI does exactly what you tell them to do. If you tell that you want artificial members to do it, they will do it. Your work is extremely critical for injured workers of North Dakota.

Representative Nottestad: Move a Do Pass on HB 1061.

Representative Thorpe: The bill seems to be a no brainer to me. I've been on this committee a long time and I don't recall taking it out. It's time to put it back in.

Chairman Keiser: Mr. Sylvan has come to an important recognition; WSI does have to follow the law in terms of applying benefits. We do set the policy of the legislature and they follow that policy.

BILL DESCRIPTION: Artificial Members Bill

SUMMARY OF ACTUARIAL INFORMATION: Workforce Safety & Insurance, together with its actuary, Glenn Evans of Pacific Actuarial Consultants, has reviewed the legislation proposed in this bill in conformance with Section 54-03-25 of the North Dakota Century Code.

The proposed legislation provides for payment of "artificial members" such as eyeglasses, contact lenses, dental braces, and orthopedic braces if an injury occurs and damages those prescriptive devices.

Reserve Level Impact: The proposed legislation will have no reserve level impact as it applies to prospective injuries only.

Rate Level Impact: The proposed legislation will increase future benefit costs in the State, but it is anticipated the potential increase is not likely to be material in relation to current premium rate levels. To the extent that costs increase, future rate levels will be adjusted accordingly.

Mr. Chairman, Members of the Committee:

My name is Anne Green, Staff Counsel with WSI. I am here today to testify in support of this bill and to provide information to the Committee to assist in making its determination. WSI's Board of Directors unanimously supports this bill.

WSI staff attended the Interim Workers Compensation Review Committee and provided information to the Committee regarding a number of issues which surfaced during the testimony. One of those issues is the bill before you.

This bill provides for the payment of an "artificial member" under workers compensation law. Examples of artificial members are eyeglasses, a leg brace, and dentures. Under current law, if an artificial member is damaged or ruined in an otherwise compensable work incident, WSI generally does not have the authority to repair the leg brace or replace the dentures.

News of this benefit enhancement was well received by WSI's claim adjusters who consider this a meaningful and common sense workers' compensation benefit.

This bill is intended to apply to future injuries occurring after the effective date of this Act and is not anticipated to have a material impact on state-wide premium levels. That concludes my testimony. I am happy to answer any questions that you may have.
