Representative Uglem: Do many people call in their own prescriptions?

Howard Anderson: Yes. Unfortunately that happens. One person kept calling in a prescription for a drug throughout the state. All he can be charged with is practicing medicine without a license and no district attorney wants to prosecute a case like that.

Chairman Weisz: Thank you Howard.

Joe Cichy, from the North Dakota Dental Association: In support of HB 1091. To answer Representative Nathe's question, registered hygienist and registered dental assistance are required to receive 15 hours of continuing education.

HOUSE BILL 1091 - CONTINUING PHARMACEUTICAL EDUCATION

Chairman Weisz, Members of the House Human Services Committee, for the record I am Howard C. Anderson, Jr, R.Ph., Executive Director of the North Dakota State Board of Pharmacy. Thank you for the opportunity to speak with you today.

The first part of this bill is a straight forward clarification of the existing law mandating Continuing Pharmaceutical Education for Pharmacists. It requires 15 hours every year to renew a pharmacist's license.

The original version of 43-15-25.1 required constant interpretation as to when it started and stopped as it read 30 hours every two years.

The second part, 43-15-31.3 Oral Transmission of Prescriptions adds registered dental hygienists and registered dental assistants to the list of professionals who are allowed to call prescriptions into a pharmacy. This addition was made at the request of the Board of Dental Examiners.

The pharmacists do not have any problem with this change, as long as the prescribing dentist is willing to take responsibility for the actions of the person they have asked to call in their prescriptions and the authority of the individual is clear in this statute.

HB 1091 – Senate Human Services Committee March 18, 2009

Good morning Chairman Lee and members of the Committee.

My name is Rita Sommers and I currently serve as the Executive Director of the NDSBDE. I would like to speak in favor of HB 1091, which in part addresses the issue of who may transmit a prescription in the dental office setting.

The registered dental hygienists and registered dental assistants are educated and tested on issues that address pharmacy-related issues:

- Collection and Recording of Clinical Data
 - Treatment Documentation
 - Record treatment and prescriptions
 (e.g., medications, instructions) on the patient's chart.
 - 2. Recognize present treatment and/or medication including anesthetics.
 - Patient Management; RDH and RDA may monitor and record patient's response to drugs/medications.
- II. Patient Education and Oral Health Management
 - Provide Oral Health Information such as development implementation of patient dental health education presentations on topics such as effects of systemic disease on the healing process.
 - Pre/Post-Treatment Instruction such as providing the patient with oral and written preand post-treatment instructions, including instruction on prescribed medication.
- III. Prevention and Management of Emergencies
 - Recognize how medications affect the patient's dental treatment.
 - Demonstrate preventive measures to be used following drug administration to avoid druginduced emergencies.
 - Recognize the signs and symptoms related to specific medical conditions/emergencies likely to occur in the dental office, including reactions to drugs, anesthetics.
 - Assemble and maintain appropriate emergency supplies, drugs, and equipment.
 - Recognize the uses of drugs in the prevention and/or effective management of an emergency.
- IV. The dental hygiene curriculum includes a minimum of 3 college credits in Pharmacology.
