Senator Dever: The contract for the legislative council software, did it go through OMB?

Pam Sharp: Did not go through OMB at all.

Senator Dever: Generally ITD would involve computer related services.

Pam Sharp: That is correct.

Pat Forester: My name is Pat Forester from the IT Department.

Testimony on HB 1122 Pam Sharp Director Office of Management and Budget January 15, 2009



Chairman Grande and members of the Government and Veteran's Affairs

Committee, my name is Pam Sharp and I am the Director of the Office of Management
and Budget. I appear today to provide information on House Bill 1122.

N.D.C.C. § 32-12.2-15 was passed by the 2005 Legislature to address circumstances the State was facing when it was attempting purchase software and electronic and communications equipment where the vendors were refusing to do business with the State unless the State agreed to a limitation of liability clause in the contract. This legislation allowed the State to agree to contracts that limited a software, electronic and communication equipment vendor's liability for consequential damages. In order to limit this practice to only those situation where it was strictly necessary, the legislation required the approval of the Director of OMB and the Attorney General.

Line 12 of this Bill provides that contracts for services related to the purchase or lease of software, electronic and communications equipment are within the scope of what is authorized under this statute. Software and electronic and communications equipment purchases or leases often require ongoing servicing agreements. This clarifies that the interrelated services provided as part of a purchase or lease of software or electronic or communications equipment are within the scope of what the State may agree to limit the liability of the vendor.

Starting at line 15, the first sentence adds that contracts for economic forecasting on behalf of OMB may also contain a provision limiting the vendor's liability to the State for consequential damages if the Director of OMB and the Attorney General determine it is necessary and the risk of loss to the State is not significant and is in the best interest of the State. Those limited vendors that undertake the type of economic forecasting that OMB needs have also begun to insist on contractual limitations of liability. This amendment will allow the State to continue receiving these important services.

Finally, the last sentence starting in line 20 clarifies that the only limitation of liability the State may agree to under this section is for indirect consequential damages, not direct loss resulting from property damage or personal injury.
