Chairman Wrangham opened the hearing on HB 1181.

Rep. Metcalf: I have changes to the bill. (see attached #1). Rep. DeKray has other engagements tonight so I signed on with him. We have in the active duty side we have what we call USARA (Uniform Serviceman Employment and Reemployment Rights Act). In ND we don't have that right. We don't have rights for employment and reemployment when we get called up as National Guardsmen and Civil Air Patrol for a disaster or emergency. This bill outlines what the definition of a disaster is and the duties of the employees and employers when it comes to this call up.

Dave Sprynczynatky: Adjutant General: We have National Guard and Civil Air Patrol as well. I am here in support of this bill since we do not have in law a means to protect the men and women in uniform that serve through the National Guard with employee's rights when they are called on to serve. Within the last couple of years we have had Northwood and within a matter of 24 hrs. we had approx. 100 soldiers and airmen helping for the next several days. Within the last month or so we had about 6 soldiers that we involved in the bovine TB in the state to dispose of the cattle that we suspect. We are now also in process of planning for the winter snow and thaw and whether we need to do something for flooding if necessary. This

bill is patterned after USARA as Rep.Metcalf said and the intent is to insure that we can call on employees whether public or private sector and put them on state active duty during missions that are asked of them when there is a disaster or emergency and not have to worry about what their employer might do to them as a result of them being call upon by the state. Those six bill sponsors represent in excess of 150 years of service in the ND National Guard.

Rep. Klemin: Does this cover volunteers?

Dave Sprynczynatky: I would have to look at that, but I think they would have to have been called up.

Rep. Nancy Johnson: Has there been a problem in the past with this employment.

Dave Sprynczynatky: I am not aware of any problems. The people of ND are all very supportive of our men and woman in uniform. USARA has been around for quite a while and when someone goes on Federal active duty we want no problems.

Rep. Conrad: I thought we had this, but it is just for federal events so if someone is called to Iraq then they are guaranteed they will have a job, but if someone goes to a local even that is what we are doing.

Dave Sprynczynatky: Yes.

Rep. Zaiser: I hear personal stories that in reality many people are turned down on the job they held and many veterans are homeless.

Dave Sprynczynatky: we do have people that work within USARA and we have people that help veterans with these employment problems called anbudmansen's; Often times we find that not all employers are aware of the law and when we set down and explain it we are able to work out the issue. When you think of an employer's standpoint we understand because we have had instances where soldiers in particular have been mobilized and deployed away from

home 16-18 months. It is harder to enforce that law when someone applies for a job and is in the National Guard and being able to determine an employer has discriminated against him.

Rep. Corey Mock: Are there any protections in place for a member of the National Guard that is employed in a border state like Minnesota?

Dave Sprynczynatky: The only protections are under USARA and federal activation. If they are a member of the ND National Guard and they were activated then USARA would protect them. I don't think this would have any bearing for ND Guards men.

Dave Sprynczynatky: Will they take an employer to court if they blithely disregard the law and not hire back or refuse to hire someone.

Dave Sprynczynatky: To my knowledge we have had to take anyone to court.

Rep. Jerry Kelsh: If someone re ups for another tour, is there any time line that the employer has to guarantee that job?

Dave Sprynczynatky: No there is not.

Rep. Koppelman: What is the longest state call up?

Dave Sprynczynatky: It is hard to put that exact number, but in 97 we had people activated from January through April.

Major Sean Johnnson, Commander, Bismarck Composite Squadron, Civil Air Patrol: (see testimony #2).

Rep. Koppelman: Is the Civil Air Patrol subject to call up federally and if so are they covered by federal law?

Major Johnson: We are different from the National Guard. We are called up by the Air Force Rescue Coordination Center, but we are not subject to deployment. We are true volunteers and we do not receive a paycheck.

Rep. Koppelman: ND is full of volunteers and we have great respect for the uniformed people. This includes all local volunteers that are called up to fight fires etc. To my knowledge we have no law that covers this kind of thing. If there is a flood or fire volunteers go out. I have heard of no problems with ND employers having an issue with that. Maybe we should include some of those things.

Major Johnson: First, it would be wonderful if we could satisfy this protection for all these volunteers. The majority of our members in the Civil Air Patrol are from larger cities. Often smaller towns depend upon us for assistance. We are part of the adjutant general.

Rep. Klemin: What is the difference between the National Guard and Civil Air Patrol being called up? Is there a choice?

Major Johnson: Our volunteers have special training like our firefighters etc.

Rep. Conrad: Do I understand this does not require a governor's declaration or the adjutant general. Who decides?

Major Johnson: Civil Air Patrol is unique. We have certain missions that are given to us by congress. Search and rescue being the key one. We are also a lead agency for emergency operations for certain missions in ND so the Civil Air Patrol does not have to have a Governor 's declaration.

Rep. Conrad: Who decides these folks should be pulled out of their jobs?

Major Johnson: We get a mission from Air Force Coordination Rescue Center or we will get one from the Dept. of Emergency Services but it is a state or local emergency

Rep. Conrad: Who decides you should go out and search for this child?

Major Johnson: the local sheriff.

Rep. Jerry Kelsh: I see you have those cadets from 12 to 21. I understand they are not required to do anything; would they have any consideration to be called out of class would they get any consideration?

Major Johnson: Not under the bill as it is written, but our school districts have been very supportive of letting our younger members out of class for a limited amount of time.

Rep. Nancy Johnson: What is the length of time are we talking about usually when someone is going to be gone. Then the second one is do they visit with their employers on length of time they might be gone.

Major Johnson: I hate to say what the average search is? The longest search that I remember us doing in recent history was two weeks. An average is 3-4 days. To answer your questions about the amount of time we are envisioning the bill does state 10 days.

Rep. Nancy Johnson: Do you encourage your members to visit with their employers about the amount of time they might be gone and when?

Major Johnson: Yes we do. They are not punished.

Rep. Kilichowski: How many stations do you have in the state and how many volunteers and how well are they spread out?

Major Johnson: We have flying squadrons in Bismarck, Minot, Dickinson, Grand Forks and Fargo. We also have cadet squadrons in Jamestown as well as Fargo. As far as capable air crews. most of them are in Bismarck followed by Grand Forks, and Dickinson.

Rep. Koppelman: How many other states have this?

Cap Flanagan: No sir, I do not.

Sean Johnson: Commander, Bismarck Composite Squadron, Civil Air Patrol. See attached testimony #1.

Senator Cook: When they are called as a volunteer are they required to go, the civil air patrol.

Sean Johnson: They have the option, but most of them have special skill set and we need them. This bill helps gives a level of insulation, it will help them say yes.

Senator Horne: Is there any time limit on this where they could not be dismissed?

Sean Johnson: The clause is written for 10 working days. We feel is a reasonable amount of time. What we are doing at home, even in the worst of times, 10 days should cut it.

Senator Horne: Can you help us find that?

Sean Johnson: It is on page 2 line 17.

Senator Oehlke: What about training activities?

Sean Johnson: Not covered by the bill, but it is not necessary. Training often occurs on weekends and is not a burden to the employer. They are also set up with enough advanced notice so if there is an impact there is chance to work with their employer to get the time off.

Senator Cook: Was this a big problem out there?

Sean Johnson: There have been issues; I want to point out that North Dakota, by far, is in the top tier when it comes to employer support of the Guard. Civil air patrol volunteers are supportive but this bill will help them.

Senator Nelson: ESGR do you still do that?

Sean Johnson: I would defer that to Mr. Wilz, but I do believe it is still in place.

Senator Horne: Are you a paid employee of the civil air patrol?

Sean Johnson: As far as civil air patrol goes, everyone is an unpaid volunteer. As far as guardsmen go, they are temporary state employees.

Senator Horne: The provisions of this proposed legislation would kick in when?

Sean Johnson: It could be kicked in with a governor's declaration; it could also be activated through the department of emergency services if they decide that they need the civil air patrol for an emergency.


Senator Cook: They are not covered by workforce safety if they are injured.

Sean Johnson: Guardsmen are not covered by workforce safety. Civil air patrol volunteers are covered under federal mission number.

Senator Oehlke: Firemen are provided workforce safety insurance under their regular job if they are injured at a fire activity in North Dakota.
