Minutes:

Rep. Bob Skarphol, District 2, appeared in support of the bill. \$6 million is a lot of money. He spent the interim on the higher education committee and they talked a lot about the needs of the citizens of North Dakota and our workforce. During a meeting at the roundtable when he asked the private sector what one thing we could do in the state of North Dakota that would improve the situation in regard to getting employees, Joe Rothschiller out of Dickinson stated triple the CTE budget. Northwest North Dakota has a vacuum with regard to CTE education. He appropriated this out of the permanent oil tax trust fund. \$6 million is less than one percent of the money of the oil revenue that came into the state this biennium. When you look at the workforce in Williston, 22 ½% of the jobs in Williston are directly related to oil. Dickinson the number is about 4% and Minot is less than 1%. When things begin to happen, the benefit of the oil industry is the need for career training. This would give us the opportunity in northwest North Dakota to have a facility available for our students, both high school and adult. The Minot School District's CTE center is not large enough to accommodate the needs of the surrounding region. Stanley is one of the communities looking forward to this center, because Minot cannot give them the opportunity to utilize their facility. This is a separate proposal. It is not in the Governor's budget.

**Rep. Patrick Hatlestad, District 1, Williston,** appeared in support. Job statistics indicate that 80-83% of all North Dakota jobs require less than a four-year degree. There has never been a time more important than now for this center. The bill also establishes a great

partnership between higher education and the secondary school systems throughout our

region. It offers an enhanced curriculum opportunity at both levels.

Rep. Gary Sukut, District 1, appeared in support. There is a tremendous void in the

northwest region with respect to vocational education and career and technical education.

That exists in both in the secondary level and post secondary level. This bill addresses that

void and addresses that issue.

**Rep. Lee Myxter**: How long would this be before it is up and running?

**Rep. Sukut**: All I can do is guess. There is a wrath of professionals behind me that are going

to testify on this, and they do have the details put together. I think that is a question that will be

answered by them.

Senator John Andrist, District 2, appeared in support. One of the disadvantages is that our

kids have to travel 400-450 miles to attend the university where they would have access to the

trade and technical educational facilities. The Bakken formation discoveries have been a

blessing both for our region and to the state. Along with that fortune, we have a hard time

filling those jobs.

Senator Stan Lyson, District 1, Williston, appeared in support.

**Rep. Lyle Hanson**: Did they ever put the emergency clause on this bill?

**Senator Lyson**: I don't know that it is necessary, but it certainly wouldn't hurt.

David Richter, Coordinator, Great Northwest Education Cooperative, appeared in support.

**Rep. Phillip Mueller**: Do we have anything in the way of career and tech ed. in the Williston area now? Is there any affiliated with the high school systems?

David Richter: Most of the schools in the area have some CTE programs. Most of them have ag. As far as auto, I think there are two high schools that have auto. Most schools have welding. There is a mix of programs, but typically what we see in the schools is that they will have one, two, or three career and tech ed. programs in the round as a school. I think everybody has an office ed. program, things of that nature.

**Rep. Phillip Mueller**: Obviously, there has been lots of activity up in your part of the world and that's all been very good for lots of reasons having to do with the oil business. How are those people being trained now? How are they getting what they need to drive a truck or help on the oil rig, or whatever is that is required?

**David Richter**: Williston State College has a workforce training \_\_\_right now. Oil fields are hiring employees and sending them to workforce training and training on specific things that happen with rigs and things of that nature. As far as trades go, there is a real shortage of workers and what the trades are doing is that they are finding them at the time and training on the job as they go along.

**Vice Chair Lisa Meier**: What are the three programs that Bismarck State College offers to Williston?

David Richter: H graph, building trades, and welding.

**Rep. Bob Hunskor**: I am wondering how students in the far regions of North Dakota, a distance from Williston High School students, how do they fit into this? They could take some courses online when this is up to speed. How far could they progress and what would be available to them if they are not in the immediate Williston area?

**David Richter**: We have talked with the school districts and all the districts are willing to block schedule. It is only feasible to go so far out with having the students come to a location. All career and technical ed. would require an extensive amount of theory also. With block scheduling they would come to campus at Williston State two or three times a week for two hours. He further explained some of the arrangements.

**Rep. Bob Hunskor**: Further east, what happens with the young people and the eastern seaboard of North Dakota? Are they just too far away?

**David Richter**: You mean like Grand Forks? There are the Lake Region Technical Center in Devils Lake, centers at Grand Forks and Red River, a new center in Minot, and centers in Valley City and Bismarck. The eastern kids are already served.

**Rep. Jerry Kelsh**: Is the \$6 million appropriation only for the building? Do you have any idea what it would cost them to fund the programs that would be in this building?

**David Richter**: \$6 million is the building. We are estimating that equipment would run somewhere between—when all said and done, we are looking at about \$10 million. That doesn't include the personnel. We have the personnel in place. We can get personnel from within the existing school districts and the colleges to fill the positions as far as teaching. We have sources to get the welding equipment.

Rep. Jerry Kelsh: There will be some additional cost for that personnel to teach the courses?

Are the high schools and surrounding school districts going to be expected to pay for the personnel to teach these or will that come out of another budget at some point?

**David Richter**: The teachers are already employed by the school so we would be expanding what their offerings are. We don't anticipate coming back and asking for more funding to run the facility.

**Rep. Jerry Kelsh**: Do you anticipate that when a student graduates from high school, they will be ready for some of these jobs? Will they still go on for a couple of more years using this same program? How do you anticipate that to work?

David Richter: We have a hope that probably will happen. We are hoping that a student will take these courses in the junior and senior year and will have basically completed a first year of their college level courses. Then what we are hoping is that they stay with the associate's degree, but in most of these programs there are certificates that are rewarded once they reach a certain level of proficiency. A student has the option once they graduated from high school to either get the diploma and the certificate on the college level. The foundation is going to work pretty hard on creating opportunities so that they actually stay at Williston State and get the two year degree which would take them basically one more year.

Chairman Kelsch: Where is the additional \$4 million coming from?

David Richter: We have various sources. There is an appropriation in Senator Dorgan's budget. We have also been talking with career and tech. ed. as far as some of the virtual elements of it. We have access to a new utility service extending learning technologies.

Chairman Kelsch: What do you anticipate the ongoing costs would be for the future? What are you anticipating that you will need to come back to the legislature each session to ask for

David Richter: I don't think we anticipated coming back and asking for more money.

Rep. John Wall: How many diesel instructors and students you have at Williston State?

additional money to keep the program running and keep the building in appropriate shape?

**David Richter**: In our diesel program right now, we are limited by the space that is in there.

We need that certification. Currently we have two full-time instructors, and the program ranges

from 11 to 25 students. One of the problems we face with the diesel program that once a student gets a certain level of training, they go out. Our diesel program has a very good

relationship with local businesses and what tends to happen is they are taking college course work and also working for an oil service company part time. As soon as they get to a level of proficiency the oil companies have, they \_\_ and work in the oil industry.

**Rep. Mike Schatz**: Being a person who worked in the oil patch for about a year and a half, I definitely appreciate what you are trying to do here. If this becomes a reality, was there any talk of a satellite program in Dickinson and would you be open to such a thing?

**David Richter**: At this point we have not had that conversation yet. Would that kid be willing to make that two-hour commute up to Williston or can we go on theory like we do everywhere else?

**Chairman Kelsch**: How many students do you anticipate in the programs?

**David Richter**: We are anticipating about a total of 150 to 200 per year which I think is realistic. We are looking at 16 students in a lab with the exception of diesel which is 28. If everything goes well, we should be teaching some portions of the program as early spring semester of 2010.

**Rep. Dennis Johnson**: Where do kids working on a certain level fit in?

**David Richter**: With a college level course, they are required to take a certain number of general ed. classes and we would set up a scheduling so that the students are in the lab on the off days. The current tech. programs' general ed. classes that are at Williston State are between 11 and 2. We would set up the high school kids coming in from 9 to 10 and the college students would be in there at that time also.

**Rep. Dennis Johnson** stated something about the 14 student limit at the diesel program at Wahpeton.

**Rep. John Wall**: Do you offer an associate degree at this time at Williston State in welding and air conditioning?

**David Richter**: At the current time the only program that is proposed that has an associate's degree at Williston State is diesel. The other programs would be associate's degree from Bismarck State College.

Rep. John Wall: Have you worked with other colleges cooperatively?

**David Richter**: Yes. If we had the facility right now, we would start in the fall with three programs.

Chairman Kelsch: There was a lot of talk with the higher ed. interim committee about collaboration. I would highly recommend collaboration for science.

Chancellor Bill Goetz, ND University System, appeared to make a few comments relative to HB 1230. We do have a capital construction budget in the university system. That budget is supported through general fund dollars and it was approved by the State Board of Higher Education and the Governor. There is a need in the northwest area for additional technical education training. We need a facility. This is a program developmental policy issue that we need to know how to address. This is not a northwest issue but a state issue. There must be focus on this long term issue and how to deal collaboratively.

**Rep. Jerry Kelsh**: Was this looked at as far as capital improvements? You had not looked at this before?

Chancellor Goetz: No it was not brought forward. No it had not been looked at before.

Murray Kline, Superintendent, Alexander, and Lead Administrator and ITV Coordinator for the Great Northwest REA, appeared in support of HB 1230. (See Attachment 2.)

Vice Chair Lisa Meier: What classes are you offering?

**Murray Kline**: There are three business courses.

Rep. John Wall: Did your REA ever consider a stand alone building from Minot State

College?

**Murray Kline**: We intended to take part in Minot's facility. What has happened is that building is maxed out to the capacity. We did apply for the virtual CTE center in the northwest. We were not successful.

Chris Kittleson, Principal, Williston High School, appeared in support. (See Attachment 3.)

Skip Espeseth, Vice President of the Local School Board, Burke Central School, Lignite, ND, and also chairman of the governing board of Northwest REA appeared in support. In the last three years our REA has spent over \$3 million. Of this \$3 million, over \$700,000 has been local school district contribution and only \$154,000 of that \$3 million has been state appropriated dollars. We feel we have been good stewards of the money that has been available. From the local perspective our students desperately need the technical part of this training that we are talking about.

**Rep. Mike Schatz**: Do you have a vocational agriculture program in your school? Do most of the schools in your REA have them?

**Skip Espeseth**: No not in our school. He said that there was about half and half in regard to the second question. For the record Lignite is about 100 miles from Williston, but we are extremely excited and interested in the program.

Tom Rolfstad, Williston Economic Development Director, appeared in support. This is an investment not just an expense. The oil boom is here to stay. It is going to take 20 years to drill this thing out. My job is to find people. We are going to have needs for housing. This center brings in building trades and for oil trade. This is a marriage between college and high school. There are those students who just aren't going to do the traditional college way. This is a way to pick them up and move them into some very good paying jobs. The cost per

4,000 employees that \_. We are going to need 3,000 workers a year for the next four years.

Chairman Kelsch said there probably will be some amendments drafted for this bill. People see some value in having a CTE Center up in that area. Some of the concerns that legislators should have is duplication of programs, the start of new programs, and eventually what those programs are going to cost. Regardless of what it is said at the hearing, she still sees that there will be recurring costs that will need to be sustained for this center. She thinks there needs to be an arena to make sure there is some collaboration between other campuses.

**Rep. Phillip Mueller**: There is another point to be made here. If you are involved in a university community, there's kind of a pecking order for all these building projects and you are in the cue for a long time before often times your project gets funded. This effort seems to want to circumvent that.

Chairman Kelsch handed out an amendment. (See Attachment 1.) She explained the purpose of the amendment. She had a real problem with appropriating \$2 million especially given the fact that this wasn't even on Williston State College's radar screen, their normal budgeting process with the board of higher education. She can understand and see the need. They do have a couple of other college projects that have come forward. They asked for the dollar for dollar match as part of the funding mechanism. She then realized it is wrong. We will need to amend the amendment. It would say Williston State College may only use the funding for the purpose of constructing a virtual center for career and technical education. Williston State College may only use the virtual center to enhance existing programs and to the extent possible must collaborate with other North Dakota university system institutions to provide the career and technical education programs.

Rep. Jerry Kelsh: You know they testified there would be another \$4 million in operating costs. Does this also you feel will cut that in half?

Chairman Kelsch: No. The \$3 million here would be a dollar for dollar match. If they figure a \$3 million community match, then it would still go up to the \$6 million. I think what they were saying was that there would potentially be some EDC money in Dorgan's budget that would provide for the other \$4 million. The \$6 million is just for the building.

Rep. Jerry Kelsh: Was that to buy machinery and equipment for it, the \$4 million or was that

the offer? I understood that it would take another \$4 million to operate it. I might be wrong.

Chairman Kelsch: The \$6 million would just cover the building. To complete it there would

be \$10 million and the \$4 million is an appropriation in Dorgan's EDC bill and that would

continue the building.

Rep. Phillip Mueller: We are okay with the construction?

Chairman Kelsch: That's where in the amendment we needed the language to be added in.

There was discussion with Pam, the law intern. She indicated that she will have to work on it.

Rep. Phillip Mueller: Is enhancing existing programs include the construction phase and was

that what you were intending?

Chairman Kelsch: No. That is why it is wrong.

Rep. John Wall: I don't want to muddy the water, but doing some further amending...to the

extent possible bothers me. It is quite permissive. I am concerned with duplication.

Rep. Jerry Kelsh: The whole bill kind of bothers me. We do have a school in the state that

provides this. It is a long way across the state, but it is for a lot of students no matter they want

to go. Technical is four to five times the cost for a liberal arts education. One other thing is we

are jerking the money out of the permanent oil trust fund. We are doing some things this

time—property tax relief, education funding, that I kind of want to see us being able to sustain

that. If we keep jerking a few million out of there constantly, I don't know if we are going to be

able to sustain what we do have.

Chairman Kelsch: I can put together amendments. It is totally up to you how you feel about

the bill.

Rep. David Rust: It is for high school kids to use as part of the CTE program where there

basically is no CTE center in the area. I would like to see you support the bill.

**Rep. Jerry Kelsh**: There was another \$4 million without personnel. They said the personnel was already there. I don't understand. Where it is at, I am not sure?

**Rep. John Wall**: The one part I find most troubling is duplication. These programs at least at the college level are nine times as expensive as other programs.

Chairman Kelsch: We understand that the CTE center will be used for high school students. It is much like what we have in Bismarck. The CTE center at Bismarck State is used by the school district. I think some Mandan kids go over. When I drafted this legislation I tightened up the language so that there wasn't the duplication as mentioned by Rep. Wall.

**Rep. Jerry Kelsh**: One thing the state school in Wahpeton you have some collaborative efforts between John Deere and Bobcat. I don't know if they would do that twice for the same programs.

**Rep. David Rust**: He pointed out on the map. When it comes to career and technical education, it is available only for other places but not for our kids.

**Rep. Brenda Heller**: I agree with Rep. Rust that there is this huge vacuum in that part of the state. If we are going to talk about duplication, all we have to do is start writing down on that white board how many programs in our universities all across this state are duplicated. There is only one other place that offers these and that is all the way across the state.

**Chairman Kelsch**: We need to separate the two issues. The CTE center is one thing, but the second part of that is where it is located. Because it is at Williston State College it just begs for duplication.

**Rep. Lyle Hanson**: To have a university you have to have many different areas. That is why there are duplications.

**Rep. John Wall**: We are talking about very expensive to run. An example is the state school recently receiving a large grant of which \$500,000 was spent on two pieces of diagnostic equipment. The second part of the equation is what I am opposed to.

**Rep. Jerry Kelsh**: Do you feel your amendment will do that?

Chairman Kelsch: The purpose for the amendment is if a CTE center is a good idea in that area. I like to see partnerships for communities. If it is warranted, I like to see that partnership. Certainly out in that area I think there are probably some companies that would directly benefit from having a CTE center there. Williston State had to collaborate with other campuses and could not duplicate programs. An example is that Bismarck State College 200 grads received a degree from Dickinson State and had never been on the campus of Dickinson. The first time they were on the campus was to pick up their degree. Bismarck State is looking at working with NDSU. This sort of collaboration. I see the same thing happening with Williston. They would work collaboratively with Wahpeton and Bismarck. We are too small of a state to have those major duplications. We are trying to reign that duplication in our current universities.

Rep. Dennis Johnson: You talk about Bismarck State and Dickinson. Minot is doing that with Bottineau. Devils Lake is doing that with Mayville and Fargo. Devils Lake had good people teaching the program but they only had a fraction of the equipment that they needed to fulfill the program like they had in Wahpeton. I am all for a CTE center. They told us that when they start training these folks, they are so quick to grab them in industry, they are not going to grab those that take those programs in the college level. It is great for the younger kids.

**Rep. Mike Schatz**: I am looking at this map. You have a growing city in Williston. It needs some buildings to complete the education of the people who are working in the Bakken.

Chairman Kelsch handed out the amendments. (See Attachment 1.) This has the \$3 million for the construction of the virtual center for career and technical education that is to be used for providing secondary career and technical education programs. It is a dollar for dollar grant.

Vice Chair Lisa Meier moved the amendment. Rep. Brenda Heller seconded it.

Rep. David Rust: Would you explain the last sentence?

**Chairman Kelsch**: Basically what that says is that it could not be used for new college programs at Williston State.

Rep. David Rust: Is that just the \$3 million, not the other \$3 million?

Chairman Kelsch: This is the \$3 million with the dollar for dollar match.

Rep. David Rust: The first \$3 million is applied for this? The other \$3 million is construction?

Chairman Kelsch: The other \$3 million would be a dollar for dollar match coming out of community oil companies, public funding raising.

Rep. David Rust: If they currently have a program, may they keep?

Chairman Kelsch: Yes.

Rep. Lyle Hanson: That second \$3 million can be used for equipment?

Chairman Kelsch: We were told it is going to cost us \$6 million to construct the building, so we are saying we will take \$3 million out of the permanent oil trust fund and we'll say to the

community you need to find the other \$3 million for your construction. It is something that we do quite frequently if we feel as though we think it is a valuable project but the state doesn't want to put in the full amount.

**Rep. David Rust**: Should the economic stimulus package come through and there is money in the higher education renovation building, whatever, could that money be used for the other \$3 million?

Chairman Kelsch: I was under the impression that it could not be for new construction.

Whenever I have seen the information for K-12 and higher ed., it was for infrastructure improvement and deferred maintenance, but I don't have the final version to know exactly what is in there.

**Rep. John Wall**: The other \$3 million in matched dollars, there would be nothing precluding Williston State from getting that money from various schools?

Chairman Kelsch: That would be permissible.

**Rep. David Rust**: It looks to me that the money at this point and time is to talk about modernization, renovation, and repair.

**Rep. Phillip Mueller**: The last part of the amendment, the last sentence, am I to take that if the Williston State College students would not be able to use..?

**Chairman Kelsch**: The virtual center can only provide the secondary and career education programs. It means they can't expand into the new programs. It is a non duplication.

A voice vote was taken on accepting the amendment. The motion carries.

Rep. Lyle Hanson moved a Do Pass as Amended on HB 1230. Rep. Mike Schatz seconded the motion.

Rep. Phillip Mueller: We heard all the discussion and there is lots of good reason to do this.

I am not going to support the do pass because we have circumvented two important pieces of

our system. We have dealt with some public school funding. We just had a long discussion earlier today about how do we do public school buildings and who votes on it and who doesn't and how you can have them without voting on it. The other part is there is a system in higher ed. whereby all these things go through the cue and some of them wait for five, six, and ten years before they happen. Now you can certainly make the case that is not the way we do business, but it is the way we do business in higher ed. particularly in regard to buildings. I don't question the validity and the necessity for the project. I do not think we are doing it in the way it should be done.

Vice Chair Lisa Meier: If it was such an important issue in interim, why didn't it come before higher ed. at the interim as it was testified it did lose? I think that we are actually duplicating something that we are already offering in higher ed., and I know there is some concern that there is real need. I know they are a little bit of an isolated area there in Williston. I am not going to support the bill.

Rep. Corey Mock: I am going to echo the previous two speakers' comments on that. I will not also being supporting the bill, but mostly because I believe this committee and yourself as chairperson will have to go before the appropriations committee and defend all these bills. I would sooner see some of the priorities of this committee as addressed be more of the bullet that you have to shield and block than some others that could have had alternative ways of receiving their funding.

**Rep. Mike Schatz**: I am going to support this primarily because it is Williston. It is an area that is a little different. With the oil boom that is going on there, there is a definite need. We have built buildings around the state with monies when somebody donates a bunch of money.

There are many different ways of getting a building built on a campus. This is just another way of doing it. I think it is a definite need.

Rep. Skarphol: There should be a handout. (Area Career and Technology Centers Members Schools). I introduced this bill to resolve an issue we have in northwestern ND for the lack of access to the CT and E for our students. Williston State College and the Great Northwest REA have been working hard to put together this proposal. They did not get within the deadline required by the State Board of Higher Education. This bill was introduced with a \$6 million appropriation requested for the cost of building a facility in Williston to provide the type of C.T. and Education we should have available for our students in northwestern ND and the facility would be designed in such a way that as times and needs change the walls on the inner side of the facility would be moveable to increase or decrease the size of the area that's dedicated to a certain area for the aspect with regard to C.T. and E. **Rep. Skarphol:** I didn't spend time thinking about where it would be. They were late in getting the work put together and said let's try and get something accomplished rather than wait two years. It is an area of the state in need of these types of jobs. Our young people are going elsewhere for education and then usually stay away after their education.

**Rep. Dosch:** I'd like to know what higher education is doing with all of their money. If they are not responding to the needs of what is going on in ND, why are we repeatedly giving higher education these unlimited amounts of money? Then we turn around and there are other programs like this. Why isn't this part of the higher education budget?

**Rep. Skarphol:** I share your frustration. It took 56 years for our university system to put into place a petroleum engineering degree, 56 years after the discovery of oil. I would submit to you they are not very responsive to the needs of our state.

**Rep. Hawkins:** This is not a higher education initiation. (Mike not working and mostly inaudible.)

**Rep. Onstad:** In discussion with the current technical training, it got started in Minot. It was originally designed to extend out past the Parshall and Stanley areas. The need was totally absorbed and they have no more space at this point. Like to move this part forward and to increase technical training and provide access that is needed.

**Rep. Klein:** I believe two sessions ago Rep. Timm was trying to bring this bill to this committee to provide service for Stanley and all those areas and didn't get anywhere, so Minot did build their own with getting support from the surrounding communities.

He visited with the folks at Williston State College and the Great Northwest REA about the possibility of having a CT and E center. From the map, it is obvious their region in the ability of their students to access a career and technology facility. The original bill as introduced was for \$6 million from the permanent oil trust fund to fund the center in its entirety. Williston as a community has very few empty buildings. The college last session received budget authority to build a diesel building to the extent of \$1.4 million but it would require all local funds. As the thought for a CT and E center progressed, it became clear it would be more worthwhile to incorporate both into one facility. He distributed a proposed amendment (attached) because the way the bill stands now, it would require a \$3 million local match. If the federal stimulus money indicated in the bill can be used for the project, he is not sure the project is "shovel ready" enough. The \$3 million may not be able to be raised quickly enough to make the match. The amendment would appropriate the entire \$6 million out of stimulus dollars if appropriate and if not, there is a contingency appropriation for \$4.8 million with a 20% local match. The 20% would be doable. That has been the practice in

the past with CT and E centers with the exception of the one in Minot. There is a great deal of interest in the dual credit course capabilities in a CT and E center. Minot built a center and hoped to provide services to a large area however the size of the facility has made that difficult. Williston State College has been limited to only night time use of the facility. With the amount of travel required, it has been under utilized by their region. Stanley is much closer to Minot but they do not feel they can get the services they need from the Minot center. There are about 14 – 15 schools that anticipate utilizing the proposed center.

Senator Lee asked in terms of the reengrossed bill, are we looking at \$3 million from stimulus funds and \$3 million from special funds, what are the special funds?

Representative Skarphol said the special funds means the local match. In today's environment, the time frame might make it unfeasible.

Senator Lee asked if \$6 million would build the project.

Representative Skarphol said yes, some work is done with site preparation for the diesel facility. This center would be larger and would have more capabilities. It would have movable walls to grow or shrink with program needs.

Senator Flakoll asked about the time line for completion date and bid letting.

Representative Skarphol said others will know the answer. They want to move ahead as soon as possible.

Senator Flakoll asked if there is a necessity for the emergency clause.

Representative Skarphol said it is probably not needed.

Senator Flakoll said if the center is operational in the upcoming biennium, are there provisions for staffing the center?

Representative Skarphol said there is no ancillary bill. It would be provided within their own budgets, the REAs will fund the largest portion with student fees.

Representative David Rust said he is recently retired from the education business, he was the superintendent at Tioga for 28 years. Students from Powers Lake are in the Missouri River Room today and they are interested in the bill. They are in the area that would be served by this facility. The map that has been distributed shows an obvious hole in career centers. This would be timely. There is a need for dual credit and career classes in this part of the state. Senator Bakke asked how services are provided to the students now.

Representative Rust said many of the schools have programs with the Career and Technical Center at their own schools. For example at Tioga, they had a vo ag program. Because of the regulations, they were not adding any single school districts, they did not have office education

or family and consumer science thru Career and Technical Education, they did it on their own.

These schools are doing some minimal programs on their own. This would give them expanded capabilities for offering more classes.

Senator Lyson testified in favor of the bill. The great northwest has been left out of the state's programs. This is one that with help, they could get back into. It is for young people and is a necessity for the great northwest.

Representative Sukut testified in favor of the bill. It is an important project to Williston State College and to northwest North Dakota. It will fill a hole. The REA will be an integral part of this. Their REA is one of the best in the state so groundwork has already been laid.

Senator Flakoll asked if the school districts are currently technologically prepared to receive this type of educational program.

Representative Sukut said a lot of the groundwork has been laid but experts will testify on it today.

Representative Hatlestad testified in favor of the bill. He is a former high school principal.

There is a definite need for the facility. It would provide an enhanced opportunity for students.

It is critical for economic viability of northwest North Dakota. There are skills that would be taught at this facility that are not available to many of the students. The facility shows great cooperation between the college and the local school districts in the entire northwest region which is giving us the maximum bang for the buck.

Joe McCann, Williston State College President, testified in favor of the bill. See written testimony. In addition to the programs included in the written testimony, diesel technology would also be included. Bismarck State College is going to partner with Williston State College to bring 4 of these programs to WSC and to the great northwest school districts. In return, WSC will provide their diesel program for one or two cycles in the Bismarck Mandan area. They anticipate continued federal funding through Senator Dorgan's office and the federal delegation for the workforce consortium of higher education institutions in the western end of the state. The feeling of the great northwest partners and upon the advice of contractors in the region and with their recent building experience on campus, they think they can do it for considerably less than the estimated \$8 million. Eventually funding would flow through the Board of Higher Education's long term funding plan. Additional costs would be covered by fees from the school districts of the Great Northwest Education Cooperative that are partners in the project.

Senator Flakoll asked if this is a single phase project.

Joe McCann said yes. If there were additional needs, an addition could be made to the building. The needs are not static, the building is flexible.

Senator Flakoll asked how many students would be necessary to make it cash flow.

Joe McCann said about 175 students are expected. It would cash flow at 100 students.

Senator Flakoll asked if there is a need for the emergency clause. The North Dakota portion could be phase 1, the federal money portion could be phase 2 to try to increase the opportunity to harvest the federal stimulus dollars.

Joe McCann said he had not thought of it as a phased project because of the critical need to prepare workforce out in the industry. However, they would accept it if necessary. The emergency would be justified, they could select an architect earlier.

Senator Flakoll asked if part of the money could come from naming rights. Does current law allow it?

Joe McCann said the term Bakken comes from a family on whose land oil was discovered back in the fifties. Their descendents are reclusive and they do not anticipate any funding from them.

Senator Flakoll said he was speaking in general terms.

Joe McCann said there are some possibilities. He left the door open with the wording of "nonstate funding". Construction costs are volatile. They might have to go to their foundation for help in raising dollars. The WSC board believes there might not be the support for this project as much as other projects given the belief in the employer base that the state is receiving significant dollars that would justify investment in the project. He doesn't think they could raise \$5 million. If the overruns were more in the area of \$1 million - \$1.4 million, they could probably raise that.

David Richter, Coordinator of the Great Northwest Education Cooperative, testified in favor of the bill. See written testimony. The area is a lot of square miles. To require kids to come in to each location every day was not realistic. The superintendents have agreed to block scheduling, they will use interactive TV. There is a new server system so a school would not need to have a whole ITV lab for a single student to participate. The new software from

Polycom allows them to hook up to a single computer in any location. All coursework would be at the dual credit level. There is a big need for welders now. If demand wanes, they can change that section of the building to a lab in a needed area. They have a plan to run the center, they have the personnel in place, they have the ability to get the equipment, they have a history in the REA of working cooperatively, they just need a facility.

Murray Kline, superintendent from Alexander and lead administrator for the Great Northwest REA and the ITV coordinator, testified in favor of the bill. See written testimony. He also distributed written testimony from Everette Enno, executive director of the Tri-County Regional Development Council (attached). This is an efficient REA. In 2007 – 2008, they received \$31,000 from the state to operate the REA. They expended \$1,317,795 that year, mostly from grants written by their REA members that went directly to curriculum and aids for their students.

Senator Taylor said the member schools have not done block scheduling in the past, will they receive exception from the Department of Public Instruction to do so?

Murray Kline said he doesn't think they need permission to do it. In Alexander, they have gone to an 8 period day. Afternoons are left open for dual credit coursework. Most of those classes meet 3 days per week. His kids would be in their ITV labs 3 days per week and could go to college all afternoon 2 days per week. That is feasible in a number of high schools. Chris Kittleson, Principal, Williston High School, testified in favor of the bill. See written testimony. He reviewed the packet he distributed. In the dual credit relationship with WSC and the REA, Williston High School has been able to work with WSC to reduce the funding per credit hour for dual credit opportunities. The cost per credit hour was \$130.44 and they were able to reduce it to \$60.00. This career and tech center will be bursting at the seams as

soon as it is up and running. They have serviced their white collar professional students, they



would like the opportunity for their blue collar professional student to be hired locally to help service the local need for these professions.

Senator Flakoll asked Joe McCann if we have virtual delivery, why are there underserved spots. Will we get to the point where Williston courses go to Wahpeton?

Joe McCann said some programs necessitate hands on learning, they need a building. A good example is the Dakota Nursing Program which provides an associate of applied science degree that leads to RN licensure that serves students from the Montana border to Grafton and from Minot to Bismarck. They use a mixture of clinical faculty to provide the hands on training as well as ITV instruction that comes from four different college campuses and now includes Fort Berthold Community College. In the Career and Technical Education arena, we need a mixture. The community colleges need to look at the state as a municipality where we use all the facilities we can muster in order to provide a mosaic of instructional modes, even within a course, to get the job done.

Chairman Freborg closed the hearing on HB 1230.

After the floor session, Chairman Freborg opened the discussion on HB 1230.

Senator Freborg asked if Senator Flakoll brought Senator Andrist's proposal. He recommended we amend the bill, take \$3 million out of the oil and gas trust fund, and authorize \$3 million in stimulus money.

Senator Taylor said the .0301 amendment from Representative Skarphol doesn't do that. Is there an amendment from Senator Andrist?

Senator Freborg said that is right.

Senator Taylor said the Williston State president referenced that same ratio.

Senator Bakke asked if we can allocate stimulus money.

Senator Freborg said we can authorize it, it doesn't mean those in charge will pay it.

Senator Bakke said if we authorize it and those in charge don't agree, then these people are left without enough money to make their building.

Senator Freborg said they would have \$3 million more than they do now.

Senator Bakke asked if the other \$3 million would be coming from special funds, according to the bill. Senator Andrist recommends it comes from the oil trust fund.

Senator Freborg asked if anyone elaborated on where the \$3 million in special funds was coming from.

Senator Lee said the special funds in the bill was intended to be a local match.

There was discussion about the building project and various funding options.

Senator Bakke asked the balance of the oil trust fund.

Senator Freborg said he doesn't know, it is a lot and going up fast.

Senator Taylor recommended the emergency clause to get the project shovel ready.

Senator Lee said David Richter's testimony said the 60<sup>th</sup> Legislative Assembly authorized a diesel tech facility, there could be some money there.

Senator Bakke said it started with \$6 million, it was cut to \$3 million in appropriations.

Senator Freborg said the money should be available.

Senator Bakke said Joe McCann recommended the same thing.

Senator Flakoll said he is ok with the permanent oil trust fund and ok with the stimulus language. Will we still be able to secure local dollars, from naming rights or other donations which is part of our intent. It is smart to give that safety valve in there is a shortage, to provide some "spackle".

Senator Freborg said they are still going to have to raise \$2 million.

Senator Flakoll said the committee could apply the emergency clause from a bid package standpoint and move up the bids by a couple of months. It could save money on the project. It

would also insure the building would be enclosed by winter. The original House bill had \$6 million from the permanent oil trust fund. He has a message from Jim Smith that the balance of the fund is projected to be \$475 million on July 1, 2009 and \$339 million on June 30, 2011.

There was discussion of the \$3 million in special funds which is a local match.

Senator Flakoll said part of the problem is significant donations take a long time to secure.

Senator Taylor said we could request an amendment with \$3 million from the oil and gas trust fund, \$3 million in federal stimulus funds with an emergency clause and authority for other dollars, the local match.

Senator Freborg said if we agree we can get an amendment drafted and take up the bill tomorrow.

Senator Flakoll said there is a strong need for this type of facility, he is concerned about a conference committee.

Senator Taylor asked if they need authorization to raise local funds.

Senator Freborg said they need authority to spend it, not to raise it.

Senator Flakoll said over \$500,000 would need our blessing.

Senator Lee said if we passed it like it is and send it straight to appropriations, is that better than going to the floor with an amendment.

Senator Flakoll said it will go to appropriations even if they don't like the amendment. What we are talking about improves the bill and is more like our committee wishes. If appropriations overrides, we can fight it out on the floor. If it goes to a conference committee, it is better if the policy committee is involved.

Senator Flakoll said he will have an amendment drafted by tomorrow. It would leave \$3 million in stimulus money, \$3 million from the oil trust fund, the emergency clause and the authority to accept grants to fill the gap up to \$3 million.

Senator Bakke said that is in excess of \$8 million.

Senator Freborg said maybe we should not authorize more than \$6 million since that is what they asked for. We should not leave it open ended..

Senator Flakoll said the legislative intent is not to exceed \$6 million in the bill package.

Senator Freborg asked Senator Flakoll to get the amendment drafted.

Chairman Freborg closed the discussion on HB 1230.

Chairman Holmberg Help me understand the timeline. A question was asked earlier about why didn't this project go through the board of higher ed. and it was because this came up so suddenly yet your testimony says it started over a year ago. There seems to be a time warp that I do not understand.

**Richter** Great Northwest is a consortium of 16 school districts. Great Northwest started working together about a year ago to create a career and tech center. It was last fall that we started thinking about working with Williston State College. The concept of the one building as a collaboration was towards the end of October the beginning of November.

**Senator Wardner** How does this fit with the high tech co-ops? Are you involved with high tech co-ops?

**Richter** The high tech co-op is made up of modules that go out in six week sections and are incorporated into several districts. Spoke about the modules.

V. Chair Grindberg Last session we authorized the construction of the diesel technology facility, did that not get built?

**Richter** The diesel technology facility was authorized but the funding was to be raised totally locally and my understanding is that they're not having much success.

V. Chair Grindberg What pot of money does Commerce have that you are applying for? Is it federal?

Kline I am not writing the grant, it is state department of commerce. I do not know where the pot is coming from, it is new.

**Senator Warner** Asked some questions about what is required of students. Some of these classes carry high fees, do students have to supply some tools for high school classes? Are high school students required to buy them?

**Kline** Our dual credit classes at Williston are sponsored through scholarships. Spoke about the program.

**Dr. Joe McCann** President, Williston State College. Testified in favor of HB 1230. See attachment # 5.

Chairman Holmberg In your testimony on Jan. 13 you talked about a new separate diesel tech lab and classroom. The funding source was general fund. You are absolutely right that it was not included in the governor's budget but are you ditching the testimony you gave us in January about the need for this building? There is no testimony today about any communication regarding this bill and the January bill.

**McCann** In January the board of higher ed had not yet been approached about supporting HB 1230. There was discussion to supporting additional career and technical opportunities; I informed the chancellor that I was in support of that idea. I wasn't in a position when I stood before you before to reference this bill. What I did was to bring up the need for this type of building.

**Chairman Holmberg** Was that communicated to the house higher ed subcommittee that the diesel building that we heard about in January was not high on your agenda this month.

**McCann** Regarding SB 2003, when I spoke to the house appropriations committee, I referenced the need for this building but did not talk to them at that time about a separate diesel building.

V. Chair Grindberg Could you argue, or is the evolution of this, that the funding wasn't raised for the building last session so you're combining the two projects?

McCann It's more yes than no but I will say this, we realized that we needed a larger facility.

V. Chair Grindberg My concern or tone is not so much opposed to the idea other than that I have questions. It's more so that I found myself with a lack of data and market based approach to these requests. Has your committee verified that the model would work, do you have a plan?

**McCann** I do not have that in written form. We did do some needs analysis relative to student interest. Unfortunately in the last several sessions, we did not get money that we wanted to be able to do a comprehensive study. With the volatile labor market, it is hard to give numbers.

V. Chair Grindberg That's my point, you can't have a moving target without a reasonable approach to the market. If the plan has a verified vision to it, the numbers will always change, that is my frustration. As a university system we're not taking a comprehensive view on approving projects. That is more of a statement than a challenge—it is hard to do with changing needs in the state.

**McCann** It is a real issue. Spoke about the operating costs and challenges with the building. We want to be able to operate the building once it is built.

V. Chair Grindberg Anything your finance person can provide is appreciated.

### Testimony of David Richter, Coordinator Great Northwest Education Cooperative House Bill 1230

January 19, 2009

Chairperson Kelsch and members of the Committee, I am David Richter the Coordinator of the Great Northwest Education Cooperative, the REA in Northwest ND. I am here today in support of HB 1230 virtual CTE center at Williston State College.

We began planning for a Virtual CTE center over a year ago. We conducted a needs assessment that included data from Economic Modeling Specialists, the North Dakota Energy and Construction WIRED study, ND Job Service top jobs, discussions with Economic developers in Divide, Williams, McKenzie, and Mountrail counties,

Superintendents from all 16 districts in the GNWEC, school boards, and then conducted a Student survey.

We had no facility or central location to create a CTE center so we designed how our center would work using distance education technologies, ITV, online, computer simulation, traveling modules, etc. Regardless of how we looked at it we needed a central location to make it work.

Planning changed last fall after discussion between WSC and BSC to share programs. There is no location to house the programs that BSC would offer at WSC. So we began the idea of a collaborating on the programs and for the construction of a center that we dubbed the Bakken Career Development Center. (A1-1)


The facility that is proposed is 60,000, square feet, steel construction with adjustable interior walls so the building can be changed as demand for programs change. There will

be four lecture ITV classrooms with ability to expand to eight. Ten offices for faculty and CTE staff including up to two Career Advisors, lab space for Diesel, Welding, HVAC, Electrical, Plumbing, and Building Trades which can be changed as demand changes. Four of the programs proposed for the Bakken Career Development Center are not currently High School programs, so we will make all of them dual credit. We have had several discussions with personnel at ND Career and Tech Education and they are willing to create MISO3 numbers for the courses.

We have the plan, we have the personnel, we have access to the equipment, we have the history of cooperation, we need a facility to make it all work.

- 1. The increase oil activity in Northwest ND has resulted in a shortage of labor in the region not only in the oil patch but also in all skilled labor in regional communities.
- 2. According to the North Dakota Career Resource Network, skilled labor constitutes 62 percent of the North Dakota labor force.
- 3. School districts in Northwest ND lack the CTE programs to satisfy the needs of students, business and the communities in the region.
- 4. The 16 high school districts of the GNWEC have been working to fill the void for CTE programs in Northwest ND but the region lacks a facility that will service all the school districts in the REA.
- 5. The GNWEC is collaborating with WSC, the anchor for the project to create seamless school to work programs and to be the home of the regional CTE center.
- 6. High School CTE programs, using block-scheduling, will include virtual delivery methods and Dual Credit opportunities, high school and college students will have access to internship programs and coops with local business partners.
- 7. This REA initiated project with WSC as facilitator will broaden the educational and career opportunities for high school and college students and facilitate the placement of highly-skilled professionals to satisfy the skilled labor needs of the region.

My name is Murray Kline. I am the superintendent in Alexander, North Dakota. I am also the Lead Administrator and ITV Coordinator for the Great Northwest REA. As Lead Administrator of the 16 school districts of the Great Northwest REA, it is my purpose this morning to express support for the creation of a virtual CTE center at Williston State College and to share supporting details as to why this project will be successful and why it will benefit student in Northwest North Dakota.

 Williston State College cooperates fully with our REA schools to provide dual credit, ITV and on campus curriculum.

When Governor Hoeven and the Legislature made the ITV network available to North Dakota school districts, Williston State College partnered with Alexander Public School and Wildrose Public school to offer Dual Credit Spanish. Today, Williston State College offers 51 different ITV dual credit courses to our 16 member REA high school students including art; biology; business; business administration; business, office and technical education; chemistry; communications; computer information systems; computer science; economics; English; geology; history; political science; psychology; sociology; and Spanish. What is missing is a Career and Technical curriculum; a void which House Bill 1230 would fill.

To further enhance the partnership between Williston State College and our REA schools, Williston State College President, Dr. Joe McCann allowed our REA to employ his Director of Instructional Programming, David Richter, as our REA coordinator. Since Mr. Richter's employment, our REA high schools' junior and senior participation has increased in dual credit courses from 35 students to well over 200.

2. The students in Northwest North Dakota deserve an equitable opportunity to experience a quality career and technical curriculum.

The establishment of a career and technical center at Williston State College would ensure this happens. Our students would utilize the center in two ways: 1. By block scheduling, our students within a reasonable traveling distance, would be able to attend CTE classes on campus. 2. Through the current ITV system, many of the CTE courses would be delivered directly to the REA school districts.

3. In summary, there is a need in our NW North Dakota high schools for a consistent and equitable Career and Technical curriculum. Williston State College has proven to be a willing and dedicated partner in delivering coursework to our high school students. On behalf of the 16 school districts in the Great Northwest REA, I ask that you support House Bill 1230.


Points of Interest from Williston High School

With the current lack of skilled labor in our area, we feel that Williston State College would be a strategic location for area students to learn skills that will make them marketable in our economy.

Williston State College and Williston High School have developed a strong relationship for our students. Currently our college-bound students have a much broader chance to benefit from dual credit through Williston High School instructors teaching college level curriculum. Furthermore, the cost per credit hour has been reduced through several different scholarship opportunities. This past year our dual credit enrollment at Williston High School has increased 500% and we truly believe this number will continue to rise.

Currently we have no course offerings in the trades that will lead up to professional certification. According to The North Dakota Career Resource Network, the percentage of companies that will need skilled labor has increased from 20% in 1950 to 62% in 2005. The percentage for white collar professionals has stayed static at around 20%. Therefore, we are teaching 100% of our students toward a profession that requires 20% of the workforce. We would like the option for course offerings to satisfy the additional 62% of the labor force.

In conclusion, with the huge increase in enrollment of our white collar professionals in dual credit, we believe that if there were a center for our students who are blue collar professionals, there would be an equal if not greater increase in that form of training. With that, we would be able to assist our area companies with training a skilled labor force that they can employ.

# Western North Dakota's workforce: Today and tomorrow

(Today the Tribune publishes its Progress 2009 edition. The edition looks at Bismarck-Mandan's progress from a frontier community until today. The edition contains stories and essays. The essay below provides an introduction to this edition.)

Many may find it surprising that 84 percent of job opportunities in our state require less than a four-year degree. Yet, 80 percent of our postsecondary students are enrolled in our state's four-year colleges, creating a significant imbalance when it comes to connecting graduates with careers in our state.

Herein lies our biggest current and future challenge - and greatest opportunity - regarding North Dakota's work force.

The majority of the high-wage, high-demand opportunities of the future are in the skilled trades and technical areas, where the greatest shortages exist because not enough young people are pursuing those career paths.

Job Service North Dakota has compiled a list of the 40 hottest jobs of the future in North Dakota. These are the fastest-growing, best-paying jobs in the state. A majority of these hot jobs are in health care, information technology, energy and engineering.

These include positions such as electricians, derrick operators, rotary drill operators and service unit operators for oil, gas and mining - all of which require a trade degree, not a four-year diploma. People with these skills will have great career opportunities in western North Dakota.

The challenge of matching young people to careers is magnified by our demographics: In many industries, 50 percent of our state's current workforce will be eligible to retire by 2016, and we need to grow and retain the pool of young people to fill these positions being vacated by retiring baby boomers.

These factors are very concerning to business and industry leaders as they look at their business investments in the state. So how do we address these problems?

First, we need to change the mindset within our school systems and parents. Currently, they are geared to encourage young people to enter four-year programs. Many young people who enter a postsecondary program leave after their freshman, year and many more fail to graduate. Instead, they move from job to job until they





connect with a career. Many who do graduate come out with degrees that do not provide a career connection in North Dakota.

Graduates of two-year programs in skilled trades and information technology will find tremendous opportunities in western North Dakota. By making young people, parents and educators aware of these career opportunities, we hope to convince more young people to enter the trade professions.

The Workforce Development Division of the North Dakota Department of Commerce is helping to educate people about these opportunities through the Career Conversations program.

The goal of this program is to provide current information about careers that have a strong future in North Dakota to high school students and adults who are advising them.

Commerce coordinates interactive "career conversations" using a Webcam that links students in a classroom to workers in high-wage/high-demand occupations.

Launched in November, Career Conversations has reached 990 participants in eight schools: Bowman, Bismarck, Mandan, Linton, Fordville, Glenburn, Williston and West Fargo. Another 2,200 students, teachers and parents participated through the Health, Career and Technology expo in Fargo.

The conversations are posted online for viewing at any time. These online videos have been viewed more than 1,175 times, which speaks favorably about the interest our young people have in North Dakota careers.

Operation Intern is another way Commerce is helping to secure young talent for businesses in North Dakota. Operation Intern provides matching grants of up to \$3,000 to businesses that create internships. Since last spring, 90 businesses have participated, offering 205 internships.

Work force enhancement grants are a tool for two-year colleges to apply for funds to create or enhance demand-driven training programs for North Dakota business and industry. These grants have been awarded to Bismarck State College, North Dakota State College of Science, Williston State College and Lake Region State College.

Providing a local perspective, Bismarck State College President Larry Skogen said that from BSC's view, the work force needs in western North Dakota will continue to be driven by the growth of agriculture, energy, tourism and rural entrepreneurial enterprises, such as Killdeer Mountain Manufacturing and Steffes Corp. of Dickinson.

BSC supports education and training for all these industries. For example, BSC recently opened the National Energy Center of Excellence to address the estimated 3,350 construction and 728 permanent positions in the energy industry projected through 2015. Most of the construction positions and all of the permanent positions are directly related to the training and education that will flow through Bismarck State College.

BSC has programs to educate students about educational and career choices. BSC's goal, according to Skogen, is to demonstrate to families that good,





high-paying jobs are available in western North Dakota for students completing a diploma, certificate or degree program.

Williston State College has another industry-specific work force training program. The Petroleum Safety and Technology Center trains workers for the oil and gas industry. The center works closely with its industry partners to develop and maintain the hands-on training programs.

More than 100 oilfield-related businesses have requested training from the center. More than 4,200 participants have taken part in more than 375 safety training classes offered by Williston State's Petroleum Safety and Technology Center.

The solution to our work force challenges can't be found in a single source. Rather, we will meet our challenges through communities taking a leadership role such as the Bismarck-Mandan Development Corporation Workforce Committee.

Ultimately, partnerships like those that Williston State College and Bismarck State College have created and Commerce has launched will attract students into training programs that offer promising career opportunities and will meet the real workforce demands of businesses in our state.


# Computer Aided Drafting and Design (CADD) and Engineering

# Testimony Offered to the North Dakota Senate Education Committee

# HB1230 – VIRTUAL CAREER and TECHNICAL CENTER BUILDING

A "Bakken Career Development Center" building has been proposed by the Great North West Education Cooperative (GNWEC). This building would be constructed on a southeast corner site of the WSC campus. Among the high school coursework and associate of applied science degree programs to be offered using this facility, would be carpentry; ventilation, heating, and air conditioning; electrical wiring; welding; and agriculture. Bismarck State College is planning to partner with WSC to bring four of these programs to WSC and the GNWEC school districts as dual credit courses.

Total cost of the building was estimated to be in excess of \$8,000,000 by Hulsing and Associates. The center would be operated with funding from tuition and fees, NDUS funding based on increased enrollment via the SBHE long term funding plan, and fees to be charged school district members of the GNWEC. WSC did not present this building concept to the State Board of Higher Education during the spring of 2008 nor was it in the March 2008 WSC Facilities Master Plan. The GNWEC had not yet come to the realization that a building would be a crucial part of its plan to bring more CTE programs to its 17 member school districts. I urge this committee to amend HB 1230 to appropriate \$3,000,000 for the construction of this building from the permanent oil and gas trust fund with that appropriation being matched by \$3,000,000 in Federal stimulus funding or other non-state funding.

GNWEC Director, David Richter and GNWEC Chair, Murray Kline requested WSC's support in November 2008. WSC's position is to support this legislation is to support HB1230, as long as that support does not erode support for the SBHE's capital construction priorities, including the renovation of WSC's science laboratories and bonding authority to build a new dormitory. WSC plans to continue as an active partner in the GNWEC and to manage this Bakken Career Development Center building.

When I became WSC president in 2000, there was a sense of urgency to harness the university system in order to improve North Dakota's economy and to "stem the out migration" of youth and 24 - 45 year old adults. Offering these CTE high school education opportunities in the MonDak region and AAS programs in the northwestern portion of North Dakota's growing energy corridor will serve the state, region, and citizens of western North Dakota well.

# Testimony of Everette Enno Executive Director Tri-County Regional Development Council House Bill 1230 March 3rd, 2009

Chairman Freborg and Committee Members;

My name is Everette Enno and I am the Executive Director of the Tri-County Regional

Development Council in Williston, ND. I am submitting this written testimony in support of HB

1230, the funding of a virtual CTE center at Williston State College.

The Tri-County Regional Development Council is a regional planning council that was created by the counties of Williams, Divide, and McKenzie and the City of Williston in 1992.

The petroleum production industry boom has been underway in the Williston Basin geological region of western North Dakota, eastern Montana, northwest South Dakota, and southeastern

Saskatchewan, Canada for the last two years. According to the North Dakota Petroleum Council, a recent study indicates the industry needs to hire more than 3,000 new employees each year for the next three to four years.

At the moment, the local Job Service office in Williston has 147 job orders in Divide, Williams, and McKenzie counties to fill. This number does not take into account that at least half of the job orders have multiple positions to fill. Also, many of the employers that are not oilfield related do not list their job openings in Job Service. As a result, there are probably between 400 to 500 job openings in the three county area that are non-oilfield.

All of the above factors, combined with the severe housing shortage, have created the need to provide training in the areas of truck driving, diesel mechanics, welding, construction trades, and other areas according to the demand of the local industries. The petroleum industry boom, the demand for new workers, the severe housing shortage, and the need for additional training

programs has impacted the past and current planning efforts. It has also impacted the educational emphasis in western North Dakota. There has been more of an effort to provide dual credit classes and expose the high school students to the training opportunities that currently exist within the region. Funding a CTE center at Williston State College would not only enhance the current efforts but it would also provide northwest North Dakota with a facility that could meet the identified training needs.

HB 1230 Written Testimony

Good Morning. I am Steven Holen; Superintendent of Schools for McKenzie County Public School District #1 – Watford City. On behalf of my school board, I would like to express our support for the construction of a career and technical center on the campus of Williston State College. Our school district is able to offer a diverse curriculum in the area of vocational and career and technical education; however, we do not have the student base or facilities to offer more advanced curriculum in important career trades areas, such as diesel mechanics, electrical, or HVAC. Our community and businesses have asked the school district to increase its capacities in meeting the needs of our community and Main Street as we struggle to find workers to meet employment needs. Our district sends a high volume of students to BSC and Wahpeton; with the increased challenge of bringing these students back to our area after graduation. It would be beneficial for our area to keep students in the Northwest and offer dual credit/ITV options to high school students. I believe it is important WSC evolves to meet the needs of this portion of the state; especially amidst a time of increase oil development, through the development of this CTE center. It is important this opportunity is available in western North Dakota as it is currently available in the eastern and central portions of the state. The center would assist the area school districts in maintaining high-quality, relevant curriculum that could not be done individually. The center would also assist communities in meeting the employment infrastructure needs desperately needed at this time.

# Testimony of David Richter, Coordinator Great Northwest Education Cooperative House Bill 1230

Chairman Freborg and members of the Committee, I am David Richter the Coordinator of the Great Northwest Education Cooperative, the REA in Northwest ND. I am here today in support of HB 1230 virtual CTE center at Williston State College.

We began planning for a Virtual CTE center over a year ago. We conducted a needs assessment that included data from Economic Modeling Specialists, the North Dakota Energy and Construction WIRED study, ND Job Service top jobs, discussions with Economic developers in Divide, Williams, McKenzie, and Mountrail counties, Superintendents from all 16 districts in the GNWEC, school boards, and then conducted a Student survey.

We had no facility or central location to create a CTE center so we designed how our center would work using distance education technologies, ITV, online, computer simulation, traveling modules, etc. Regardless of how we looked at it we needed a central location to make it work.

Planning changed last fall, there had been discussions between WSC and BSC to share CTE programs. The GNWEC and WSC have been collaborating on Dual-credit courses for several years, so we began the idea of a collaborating on CTE programs. The 60 Legislative Assembly authorized the construction of a Diesel Technology facility on the WSC campus, since the entire NW is in need of a CTE facility we choose to pursue

construction of one facility that could meet the needs of both k-12 and WSC. This resulted in the center that we dubbed the Bakken Career Development Center. (A1-1) The facility that is proposed is 60,000, square feet, steel construction with adjustable interior walls so the building can be changed as demand for programs change. There will be four lecture ITV classrooms with ability to expand to eight. Ten offices for faculty and CTE staff including up to two Career Advisors, lab space for Diesel, Welding, HVAC, Electrical, Plumbing, and Building Trades which can be changed as demand changes. Four of the programs proposed for the Bakken Career Development Center are not currently High School programs, so we will make all of them dual credit. We have had several discussions with personnel at ND Career and Tech Education and they are willing to create MISO3 numbers for the courses.

We have the plan, we have the personnel, we have access to the equipment, we have the history of cooperation, we need a facility to make it all work.
