Louise Potter~Representative from District 17. Give a brief explanation of Crohn's auto immune disease. Concerned about bathroom use at a retail store and goes over the HB 1258 to the committee.

Representative Ruby: How would someone in an establishment know if people have this disease?

Potter: That's a good question and I don't know how that will exactly work.

Representative Ruby: On page two, subsection four, talks about not having to make physical changes. I'm concerned about some of the potential in a wheelchair, would be open to any thought about this.

Potter: I wondered the same thing. There is not anything under two and also on page four this section does not require retail establishment to make any physical changes.

Vice Chairman Kasper: Are you aware of any circumstances in North Dakota where an employer has refused access to anyone for a condition like this or any other condition.

Potter: I'm not aware of any.

Potter: Number B would somewhat pertain to that they have to have three or more employees.

Representative Nottestad: Testifies to support Representative Potter and explain the situation about a girl in his school who endured Crohn's Disease.

David Boeck~Protection & Advocacy Project. In paragraph two A, on line 21, it says a "customer suffering from", I don't think suffer is the word you want to use. You need to say "who has a eligible medical condition". The other point I want to make, most filling stations have toilets. I think paragraph C on line one on the second page should not be included because of paragraph E. They say the same thing. I could call someone in Illinois and find out how this interacts with the ADA.

Representative Ruby: If you are going to make major renovations, I guess I would want clarification under ADA, would need wheelchair accessible anyway because you are now allowing some access to the public?

Boeck: I don't clearly understand, are you saying that the remodeling would be to the store or just remodeling the restroom?

Representative Ruby: Either or.

Boeck: If you are remodeling the store, regular ADA rules would apply. Remodeling the restroom, you wouldn't spend enough money to trigger the ADA requirement.

Chairman Keiser: If hired somebody and are wheelchair bound, am I obligated to provide bathroom facilities for them?

Boeck: If it's burdensome, yes you would.

Vice Chairman Kasper: I would like the ADA language because I'm carrying this on the floor and I want to answer the question right.

Boeck: I will take a look and get back to you.

Minutes:

Senator J. Lee opened the hearing on HB 1258 to provide individuals having medical conditions reasonable restroom access in retail establishments.

Representative Louise Potter (District 17) introduced HB 1258. She explained that HB 1258 has to do with Crohn's disease and is modeled directly from an Illinois statute known as Ally's Law. Crohn's disease is an auto immune disease. It is an inflammatory bowel disease. She explained that two of the predominant symptoms are diarrhea and intestinal cramping. She walked the committee through all parts of the bill. She was asked by a family in Grand Forks to present this bill.

Senator Heckaman referred to page 1, lines 23-24, and said in her rural areas it would be an issue. There are places that don't have public restrooms and don't have three or more people working at the same time. She asked if there was thought on this bill to maybe allow the physician to write some kind of a note to the family to take with them rather than change the law.

Rep. Potter thought the people do have something they carry with them. A business with only one person working would have the option to say "no".

She reported that she had asked the family if their daughter had been denied access to a restroom and they said she had been.

Senator J. Lee was thinking the three or more employees was a safety factor.

Senator Erbele asked if this is a law without a penalty.

Rep. Potter replied that it started out with a penalty but it was taken out.

Senator J. Lee thought there might be some worth in talking about having something from the doctor.

(Meter 11:58) Topics of discussion: notifying all businesses, regulating common decency, safety risks, and exempting certain structures.

Senator J. Lee asked what other states besides Illinois have passed this.

Rep. Potter said she would provide the committee with a map tracking the progress of Ally's Law. This was later provided. Attachment #2

Veronica Zietz (Executive Director, The Arc of Bismarck) testified in support of HB 1258.

Attachment #1

Senator J. Lee asked if there are digestive conditions and diseases that are actually considered disabilities.

Ms. Zietz answered that, looking at the ADA Act, things that limit major life activities are usually considered disabilities.

Senator J. Lee – the word disability has a different connotation than disease or condition.

She pointed out that ADA compliance is a different deal than just being polite to people that have a problem.

Ms. Zietz said the "any other medical conditions" in section 1 would be interpreted as certain disabilities.

Senator J. Lee said there are legal protections for people with recognized disabilities that are different from what might be done in a more informal fashion to accommodate people who have a problem.

Senator Dever asked Ms. Zietz if she knew if newly constructed retail establishments are required to have a public restroom.

Ms. Zietz thought it might depend on the size of the establishment.

David Boeck (Lawyer for the Protection and Advocacy Project) did not have written testimony but had answers to some of the questions asked by the committee.

The reason for three or more employees is because of a concern about security.

MN's bill is different in that a person has to present documentation that they have the disorder.

He didn't have the answer for why it does not include an establishment of 800 square feet.

He didn't know if newly establishments were required to have public restrooms. The ADA requires that, in terms of bathrooms being accessible, a facility built after January 26, 1993 must be completely accessible which would include both a public and an employee restroom.

This also applies to significant remodeling projects.

Senator J. Lee pointed out that she didn't see anything about documentation. The only thing she saw was that they amended out the penalty.

Mr. Boeck thought they had changed something on the first page.

There was discussion on the House changes. Mr. Boeck said the House committee was troubled by the penalty clause.

Senator J. Lee asked Mr. Boeck what he thought of the idea that someone might find they have an excuse to not provide service because they only have two people working where otherwise they might have accommodated them.

Mr. Boeck thought that would be unlikely to happen. He didn't think this bill would change a person's attitude toward someone who is desperate to use a restroom.

Senator J. Lee said a good thing about the bill is there isn't any civil liability for the establishment.

Mike Rud (ND Retail Association) spoke in response to the question posed by Senator Dever.

After 1993 a facility is required to have public restrooms if they are a certain size. He didn't know anything about the 800 square foot exemption and didn't think it was helpful to anyone.

He didn't think this type of language was needed in North Dakota.

Senator Dever suggested that if businesses feel imposed on by regulation then there might be some push back.

Senator J. Lee suggested that if retail businesses recognize this kind of situation and try to be helpful it might be less onerous than legislation.

Mr. Rud agreed and said that anyone who runs an establishment probably already has this in place.

Bonnie Staiger (National Federation of Independent Business) reported that NFIB members who serve in the House of Representatives had lingering concerns when this went through that chamber. She felt that the old adage, "You can't legislate common courtesy and common sense", might apply here. A model bill that is suitable for a state like Minnesota or Illinois might not necessarily be the best fit for North Dakota. The organizations that represent small business could make a concerted effort to educate their members on the importance of being courteous to customers that have a need. Other issues remain on the bill such as security and safety. She felt it was a solution looking for a problem and requested a Do Not Pass.

There was no neutral testimony.

The hearing on HB 1258 was closed.

There was committee feeling that they were getting into an area that they don't need to legislate.

Senator Dever felt that if they did something with the bill they should remove the requirement that they provide access and leave immunity from liability as encouragement for them to do it. He was okay with a do not pass, also.

Points of discussion (1) educating businesses to be responsive to those with needs, (2) liability issues, (3) enforcement.

Senator Heckaman moved a Do Not Pass.

Second by Senator Dever.

Roll call vote 6-0-0. Motion carried.







