Chairman Dever called the committee to order. Representative William Kretschmar was there to introduce the bill.

Representative Kretschmar: William Kretschmar, Representative from district 28. This bill was passed by legislative assembly; it was to allow local political subdivisions to work with each other in a better way. Each 5 years the political subdivisions were to look at their structure of government and do something about it and it was a mandate. At least in the smaller subdivisions that mandate was more out of its reach. The Association of Counties would like to get that part of the statute removed, that is basically what 1346 does, there are still provisions in law that they can look in the structure of their process. Allow them to do that as a need basis rather than have North Dakota require a mandate. I would urge you to give it a do pass.

Senator Cook: Would we be sending a message to local government that they have reached the top of the mountain when it comes to finding efficiencies?

William Kretschmar: We are sending a message that says that the political subdivisions have the right to see how the best way to make your agency better as is needed in your local area.

Senator Nelson: How many political subdivisions have this creature, the advisory committee?

William Kretschmar: I don't think the association of counties keeps track of it. I would guess

that a large number of our smaller political subdivisions ignore it.

Senator Dever: If they followed the mandate they would establish it order to avoid the cost of

an election.

Terry Traynor: Assistant Director, North Dakota Association of Counties. See attached

testimony #1.

Senator Horne Is this is based on the creation of the tool chest bill in 1973. How has that been

accepted and has it brought good results?

Terry Traynor: I would say yes. Every county has used the tool chest or the joint powers

authority to combine officers, re-designate offices.

Senator Horne: My mother was a county superintendant of schools and towards the end of

her career, as things were winding down, they were working with other counties on a half time

basis, is that an example of use of the tool chest?

Terry Traynor: The legislature prior to the tool chest did some re-organization in relation to the

tool chest. That resulted in a number of consolidations as well but since that time the tool chest

has been used to do cross county consolidations of that function.

Senator Cook: Has this been introduced in past session and failed?

Terry Traynor: No, there was a bill that was supposed to re peal the tool chest. This provision

is what was left out of political subdivisions.

Senator Cook: We talk a lot about property tax, I happen to believe that there is opportunity to

accomplish this if you had willing government officials to work together. I think that the right

direction is to form a committee with cities and counties on how to find efficiencies.

Terry Traynor: I acknowledge the value of having those committees and if they were to more

regularly meet and have a specific charge I think that you would see more ideas brought

forward. That is why we don't want to lose the ability to create that committee either by a

citizen petition or commission resolution. But our members feel that the way it is structured

now, it doesn't bring that result.

Senator Cook: What is it that we could do to encourage the discussion?

Terry Traynor: This is not the answer that you are looking for, but one of the things that we

have seen is whenever there is an obvious financial benefit for counties to come together with

another county or city and share we see it happening. Sometimes it is hard to see the short

and long term financial benefits. Sometimes the initial investment to get the long term benefits

is not available. Rather than a requirement to do a study, show the county that there is a

financial benefit to this.

Senator Dever: We are eliminating the requirement for an election but we are still allowing in

existing law that somebody could circulate a petition and 10% of the voters that voted in the

governor's election and what would they have to do?

Terry Traynor: Then they would have to create the committee.

Senator Horne: Is there anything in this that would encourage more cooperation between city

and county government?

Terry Traynor: They have the ability in the requirement for the vote but they do have the ability

to form a joint city county advisory committee that would fulfill the cities and the counties

obligation under current law.

Senator Horne: That makes me think of the cities. Does this bill also require cities to form

study committees?

Terry Traynor: Under current law they are also required to put it on the ballot every 5 years.

This bill takes that requirement away from the cities as well.

Al Jager: Al Jager Secretary of State. The one thing that comes to mind from an election standpoint 5 years makes no sense; the bill has merit because a 5 year cycle doesn't work with anything be it city or county.
