Representative Lisa Meier, District 32, introduced HB 1414. See attachment #1.

Representative Meier provided examples of plates that are used in other states. See attachment #2.

Representative Delmore: Do you have any idea what the design will look like?

Representative Lisa Meier: The DOT hasn't come up with a design as of yet, since the bill hasn't passed.

Representative Potter: When you say surviving members of fallen members of the US Military, would that be the parents, grandparents, brothers and sisters?

Representative Lisa Meier: Those would all be included. They are stated on the bill.

Chairman Ruby: Is there an initial fee of \$15 and after that a surcharge of \$10?

Representative Lisa Meier: Yes, that is correct. The DOT will be able to explain the mechanism.

Representative Mike Nathe, District 30, encouraged the committee's support of HB 1414.

Representative Griffin: Was there ever any discussion about waiving the fees?

Representative Lisa Meier: We did discuss waving the fees with the DOT. We thought that it would be better to propose a fee because we were afraid that if you open it wide up, it does allow some opportunities for families that aren't families of veterans to pass some fraud.

Francis Ziegler, Director of North Dakota Department of Transportation, spoke in support of HB 1414. See attachment #3.

Representative Potter: How does the department certify someone?

Francis Ziegler: We have a model in place for the Veteran's plates at this time. The language that we have in the bill is the same language that we use to certify whoever can get buried in the veteran's cemetery. So, if they have a member in the veteran's cemetery, we will do follow up through the Adjutant General to make sure that the person is truly the family member. The same process will be used if they are buried somewhere else.

Representative Weisz: In Subsection 5, says can't you remove the eligibility? What is the purpose of that section?

Linda Butts, DOT: The reason was that when we were designing the program, we wanted to maintain the integrity of who was really eligible for the plates. Once that person who was deemed eligible passes away, we will not give that number to anyone else. The number is retired when the person passes on. The plan is to work directly with the Veteran's Administration who already does screening. Once they have told us a person is eligible, we would never go back and say that person is ineligible. The system will work as well at the screening process that the VA currently has.

Representative Vigesaa: Subsection 3 talks about the actual configuration of the plate and noted that the numbers GS would be in front of the number. I know that we have some other special plates. Will these plates still be able to be personalized? And if so, I think the extra letters will limit what they can put on the plate.

Francis Ziegler: There will be a special design. We will be woking with that, to include the G S as part of the design. Vanity plates are allowed on other plates with special logos.

Representative Schmidt: Don't you think the participation for this will be close to 100%? Wouldn't the income be more?

Francis Ziegler: We are not sure what kind of participation we might get. Assuming we have 100% participation, I believe we have about 12,000 that will be eligible for this.

Gene Kouba, current president of North Dakota Veteran's Coordinating Council, supported HB 1414 by a unanimous vote of his organization. He related that Bernadette Monroe came into his office after trying to get a Purple Heart plate for her son who died October 11, 2004. The DOT wouldn't sell her one. He made some contacts and found out that what she should really have is a Gold Star Mother plate to honor the fallen veteran. For the record, there have been twenty veterans in North Dakota that have died in the Global War on Terrorism. There will be no problem screening applicants. There is already a system in place. Mr. Kouba provided a list of other states that have Gold Star plates. See attachment # 4.

Major Davina French, North Dakota National Guard passed out a picture of twelve members of the National Guard that have been lost. See attachment #5. She recognized some of the parents who were in the room. Mrs. Reese, the mother of Kenny Hendrickson; Joyce Meher, the mother of Chris Meher; Sheila Vector Richter, the mother of Travis VanZoest were introduced. The importance of this bill is not only to honor the families, but we would like to say that families serve forever. These plates will give us the opportunity to thank these families for their sacrifice.

Hearing Date: 02/05/09

Doug Johnson, a North Dakota Citizen, spoke in support of HB 1414. He would like us to use this opportunity to honor those who have fallen in wars and conflicts. He feels that it is important for us to recognize these veterans.

Linda Butts addressed Representative Potter question about offering the plates free.

Linda Butts: When we first started working on this concept it was to honor fallen veterans of the Iraqi war. As we worked on this, we decided that we would need to open it up to all who had lost loved ones, in any war. At that point, we didn't know the scope and size of the project, so, it went from being offered free to a small population, to something that we at least needed to recover our costs. We decided that if we can recover our costs, anything thereafter we would give to the veterans. Those funds then can be used for appropriate purposes.

That is the history of the fees.

The hearing was closed on HB 1414.

Representative R. Kelsch moved a Do Pass on HB 1414.

Representative Weisz seconded the motion.

A roll call vote was taken on HB 1414. Aye 14 Nay 0 Absent 0

The motion passed.

Representative R. Kelsch will carry HB 1414.

This bill will provide for a new vehicle license plate for surviving family members of a military member who died on active duty during a time of conflict. Development of the plate will be the biggest cost for this process.

Plate development cost: \$1,500.00. Plate material and mailing cost \$8.83 per plate set. Estimating 50% of authorized would purchase the plate this biennium and another 30% for following biennium – the cost of this material/mailing is off-set by the fee collected.

Revenues gained from these plates will yield full coverage of costs for the DOT. After DOT recovers initial issue fees, the annual renewal will net \$10.00 per renewal for the Veterans Cemetery maintenance fund, which should result in between \$7,000 - \$15,000 per biennium.

The only cost for this plate is the initial development cost for the plate. This cost is estimated to be \$1,500.00.

Chairman Gary Lee opened the hearing on SB 1414 relating to the issuance of special plates for surviving family members of fallen members of the United States military. Senate Marcellais was absent.

Rep. Lisa Meier introduced HB 1414 and urged a do pass. Written testimony # 1

Senator Lee asked for clarification on legislative intent on line 13 of section 1. Where it said. "the arm forces of the United States who died while serving on active duty during the time of military conflict". Does that mean killed in action or someone serving during a time of war and not in the conflict?

Rep. Meier said they discussed it and decided that if they were serving overseas in the conflict directly.

Rep. Nathe testified in support of HB 1414.

Gene Kouba, DAV and current president of the ND coordinating council of all the service organizations in ND testified in support of HB 1414. He told of one of the mom's who came into his office and told him she tried to buy a purple heart license plate in honor of her son who had died in October 11, 2004 and she couldn't get one. Out of this came HB 1414. He passed out a listing of all the states that have a Gold Star license plate, list of states with no Gold Star



plates, and list of states introducing legislation this year. He recognized the families of fallen soldiers in the room.

Senator Nodland asked for clarification on lines 13 & 14.

Gene Kouba answered it was killed in action.

Doug Johnson a citizen of ND testified in support of HB 1414. He said his wife's grandmother lost 2 sons in WWI and had two of those flags that her and her family treasured it even now. He said that he had relationships with some of the families that were here and even had one of the boys as an employee at his school and also one of the boys was a student at his school at Simile when he was principal and his mother was a student of his. I encourage a do pass for these parents here today and all families who have lost sons or daughter in military conflicts.

Linda Butts, Deputy Director for Driver and Vehicle Services at the ND Department of Transportation testified in support of HB 1414. Written testimony #3

Senator Potter asked a question on page 2, lines 7-8.

Linda answered that this was already in place.

Paul Goodiron, father of Nathan Goodiron who was killed in action on Thanksgiving Day 2008. He said that he had served 4 tours in Vietnam and he asked to go, so did his son. North Dakota has suffered the highest percentage of those killed in Iraq and Iran. He asked the committee to look favorably on this bill for those not coming home.

Harriet Goodiron mother of Nathan Goodiron thanked the state of ND for helping us not to forget what our sons and daughters have done for their state and nation.

No Opposition

Senator Lee closed the hearing on SB 1414.

Senator Nodiand moved a do pass.

Senator Fiebiger seconded.

Gold Star Family License Plate Status

I've attempted to collect information on which states have some kind of Gold Star Family license plate. Several states have legislation in progress and I have noted that where I can. Be sure to read the details link as some plates have additional documentation requirements in addition to the application, like form DD 1300, Report of Casualty or an additional affirmation form attesting to your relationship to the fallen soldier.

Those qualifying for the Gold Star plate vary by state from mothers only to extended family members. Check the qualifications carefully.

My research is not exhaustive so if you have additional details of pending legislation please **contact me**.

If you are interested in introducing legislation for a Gold Star Family license plate in your own state see my **GSF license plate kit**. I recommend you try to make the qualification requirements as wide as possible to get the greatest number of plates on the road. Using the **DOD qualifications for wearing the Gold Star Pin** will give your legislator a predefined group and ease his work.



Good morning, Mr. Chairman and members of the committee. I'm Linda Butts, Deputy Director for Driver and Vehicle Services at the North Dakota Department of Transportation. Thank you for giving me the opportunity to present information to you today.

The North Dakota Department of Transportation supports House Bill 1414. This bill provides for a new vehicle license plate for surviving family members of military personnel who gave the ultimate sacrifice for our country during a time of conflict.

The provisions of this bill follow the process, funding and distribution of collected funds laid out in the Veteran Plate section of statute. This process is doable, affordable, and reflects positively on our best values, by providing a means to preserve the memories of those we have lost in war, and provides a visible symbol of pride and loss for the loved ones of our fallen military members who remain with us today.
