Mr. Chairman and members of the committee, my name is Jerry Hjelmstad, and I am here to on behalf of the North Dakota League of Cities to testify in support of House Bill No. 1420.

Under current law, a city auditor is required to send two certified copies of the levy as adopted and two certified copies of the final budget to the county auditor by October 10th. This is a carry-over from an old requirement that the county auditor forward one copy of the levy and final budget on to the State Auditor's office. When that requirement was repealed several years ago, this section of the law was not updated.

The changes we are supporting on line 11 would eliminate the unnecessary copies. We emailed all 53 county auditors to see if any had a reason why this section of the law should not be changed. All of the 15 that responded thought the change would be a good idea. Here is a sample of their comments:

"Only one copy is necessary. You have my support."

"At one time we were required in our section of law to send a copy on to the State Auditor's office. When they took that out, they neglected to make the change in section 40-40-10. Get it done."

"We do not need two copies. More paper lying around."

We ask for your support for House Bill No. 1420.
