Minutes:

Chairman Gary Lee opened the hearing on HB 1457 relating to the hearing for a traffic violation.

Representative Metcalf introduced the bill at the request of legal services that are provided in his area. He said that they have a judge in the Valley City area that approached him and said that he and others like him didn't have enough time allowed to meet certain circumstance. He was talking about only traffic violations. The problem is and has been in the past that the judge is assigned the responsibility to hear a particular case however as the time goes along maybe the judge gets sick or something else happens and he is unable to keep the hearing schedule. Another judge is appointed and they run into the problem of time running out. He said by allowing the appointment of an alternate judge the time can be extended. That is the purpose of the bill to extend the time of the appointment and an alternate hearing official.

**Senator Fiebiger** asked if there was a hearing date set up and on the 60<sup>th</sup> day they have to reschedule with another judge, he asked if they got another 90 days.

Representative Metcalf said his understanding is that it has to be in the time frame that is acceptable to the newly appointed judge but underneath the old concept of 60 or 90 days.

**Senator Fiebiger** continued his questions on if they get an extra amount of days after the appointment of new judge. He was trying to get some clarity on this.

**Senator Nething** said this is so vague. He understands what the bill wants to do but he is wondering what the House discussion was on how this would work.

**Rep. Metcalf** said they looked at this for just traffic violations and second, for an alternate hearing official. In most cases the implication is dealing with a city judge.

Senator Potter asked if the 90 days applied after an alternate hearing official is appointed.

**Rep. Metcalf** said that was his understanding.

Senator Nething thinks this also applies to both municipal and state authority.

**Rep. Metcalf** said he wasn't aware of this but hoped language could be used to make it work for the problem he presented. The judge wants that 90 days extended.

Senator Lee asked what the judge did now when he runs out of his 90 days.

**Rep. Metcalf** he has to notify them and give them a new date. He said if the committee needs to do any work on this bill he would support their decision.

#### No Opposition

Senator Lee closed the hearing on HB 1457.

**Senator Nething** asked for more time to get more information and possibility try to get more structure in this bill.

The committee asked the intern to do some work on this. The committee agrees the language is confusing.

Discussion followed on what would happen if they missed the 90 days and the fact that there were no prosecutors that gave testimony or judges or anyone else. Problem lays with municipal judges and where they don't have fulltime judges.

Senator Nodland thought if we do anything we could extend the 90 days to 120 days.
