HOUSE BILL No. 1504 90598.0200 Sixty-first Legislative Assembly of North Dakota Introduced by Representatives Heller, Kreidt Senator Christmann

A BILL for an Act to amend and reenact subsection 3 of section 20.1-03-11 of the North Dakota Century Code, relating to taking of big game for disabled individuals.

Written testimony of Weston Berg

Blind hunters can have a designated shooter shoot and kill their deer. North Dakota Game and Fish has a form to request that permit.

House Bill 1504 will extend a similar provision to disabled landowners allowing a designated shooter to shoot their deer. A doctor's statement is required.

Hunters use snowmobiles, four wheelers, or walk to access hunting areas. These are not options for one who is disabled. A disability permit to shoot from a vehicle is not an option when you can not get a vehicle to the hunting area. Nor is there an option for a disabled hunter who would likely suffer injury from hunting.

There is an abundance of deer. Every day there are more deer lying along the roads that have been hit by vehicles. Landowners provide feed and shelter for deer year round.

North Dakota has a gratis deer hunting tag for landowners. There is a deer out there for that gratis tag. HB 1504 will allow for that gratis tag to be filled, which could not otherwise be used when a landowner is disabled.

Testimony Against HB 1504

Mister Chairman, members of the committee, the North Dakota Wildlife Federation opposes HB 1504. The law that this bill proposes to enact, is too vague to be good law. Lines 13, 14 and 15 on page 2, state that the "individual ... must be on or as near as reasonably practical to the eligible land described on the license application." What exactly does "reasonably practical" mean?

An elderly land owner in a care facility miles from the land described on the license application is as near as reasonably practical to the land described on the license application.

Page 2, line 16, describes the disabilities this bill addresses as, ... "a condition likely to result in injury or physical harm..."

An elderly man or woman, thin and frail, risks hypothermia when exposed to cold. That apparently meets the definition of disability in the proposed legislation.

An elderly woman suffering from osteoporosis cannot fire a high power rifle without breaking her shoulder. That qualifies her as disabled under this proposed law.

Mister Chairman, members of this committee, if you pass this bill you will create an impossible situation for Game Wardens charged with enforcing this new law. The new law would be too vague and ambiguous to be of any use in enforcing and prosecuting violators.

On a routine license check, does the Game Warden use his or her time to find the license holder who is as near as reasonably practical and question him or her to confirm who he or she designated to do the shooting?

This bill will put Game Wardens and prosecuting attorneys into an impossible situation. If there is a violation, does the prosecutor subpoena the license holder to testify that he or she actually designated the shooter the Warden contacted in the field? How will enforcing violations of this law come across to the public?

Hunting is an intensely personal experience that pits the hunter against a game animal in a battle of wits. The North Dakota Wildlife Federation supports laws and policy that accommodate disabled people who want to engage in and enjoy hunting. The Federation cannot support this bill because it takes hunting out of the equation. This bill doesn't accommodate disabled hunters; this bill eliminates disabled hunters from the hunting equation and in doing so, issues an open invitation to the less than ethical to obtain a second buck tag using a disabled person as a reason to obtain that second tag.
