Chairman Skarphol: Called the committee back to order to take up HB 1520.

Rep. Kilichowski, District 16: Stood in favor of HB 1520 which allows county parks, roughly 40 of them in the state. It is a \$1.00 matching grant with \$2.00 coming from the state. It would allow purchase of land, infrastructure, and structures. Some of the parks have an ideal location but don't have availability of water and want to expand to make their camp sites bigger. He purposes this to managed by the park district.

Rep. Klein: How many counties have parks that would qualify?

Rep. Kilichowski: Roughly 40 county parks, some have 2 or 3, how many counties, I'm not sure.

Rep. Onstad: I see it's only for existing county parks and not for start up.

Rep. Kilichowski: Yes, not for creation of new parks.

Rep. Williams: Where did you get the idea for this?

Rep. Kilichowski: About 10 years ago the Corps came to our county park in Walsh county, they were redoing the dam and we worked with them and have a swimming area, 13 camp sites, built a shower and bathroom building. There is a possibility of some land that could be purchased. There is a big need for it, good for the economy.

Rep. Wald: You said you added some 15 additional camper spots in your county.

Rep. Kilichowski: Yes, we did. They are limited to a week at a time.

Rep. Wald: Are you competing against the private camp ground, where the government is competing against the private campground, such as KOA?

Rep. Kilichowski: No.

Chairman Skarphol: Do you collect a fee, daily or weekly?

Rep. Kilichowski: Yes there is something like \$20 or \$25 for the season and maybe \$2 or \$3 for the daily pass.

Rep. Klein: You referred to dam repair. What was that dam and who did the work?

Rep. Kilichowski: That was done by the Corps. It needed to be repaired because the life expectancy was well overdue.

Chairman Skarphol: Anyone else wishing to testify in favor of HB 1520? Anyone wanting to testify in opposition to?

Doug Prchal, Director of North Dakota Parks and Recreation: I testified in favor of HB 1019 and I am here to testify in opposition to HB 1520 and in support of HB 1019 which includes the grants program because the two bills are parallel.

Rep. Klein: You say you have a similar thing in your bill that would do this, expand on this.

Prchal: The local Community Grants bill would accept county grants across the state, municipal grants, all political subdivisions.

Chairman Skarphol: Anyone else wanting to testify in opposition the HB 1520? Any thoughts on HB 1520?

Chairman Skarphol: Seconded by Rep. Klein. Do we have any discussion? I realize Rep.

Rep. Ekstrom: It seems to me we have a great excess of third maintenance and projects that need attention. I'm going to resist this motion.
