Representative Mike Brandenburg: Introduced HB 1528. He explained that he wanted to bring HB 1528 and HB 1529 together to try to find an answer to Cindy and Carmen Essig's problem. (Refers to testimony provided in HB 1529.) This bill allows regular approved state highway signs to be used. Coming from the north and south on Highway 30 there would be signs that say, "Photos by Cindy". They could take their sign and move it off the road 600 feet. The only problem is that it will cost about \$800 to buy state approved signs. Carmen and Cindy have said, "We don't like that!"

Chairman Ruby: Will these signs be put up by the state?

Representative Mike Brandenburg: Yes, the signs will be made and put up by the state. The only issue is the \$800 cost.

Harold Newman, President of Newman Outdoor Advertising, spoke in opposition to HB 1528. He stated that this statute came about four years ago in response to the same issue. How do we get people directed off of the main road? This was what they (federal) call a TOPS program, however it has some restrictions. This allows the signs to go in the right-of-way, very close to the main road. There are some liability issues. If a sign goes up on the road and causes an accident, the sign belongs to the person that hired it put up. How will that be

solved, other than with a bunch of legal fees? If you let the state go in and put the signs up, I don't think that they should be able to compete with private enterprise business that knows the signing business. I don't know where the \$800 figure came from, because it is hard to imagine someone charging \$800 for a sign that is THAT big and THAT high (made the sign size with his hands of approximately one foot by two to three feet). My position is that if you spread this out and allow it all over the place, there will be problems with the federal government or the liability issue. I would not recommend it. This problem can be solved by zoning which I referred to in HB 1529.

Darcy Rosendahl, Office of Operations Director from DOT, spoke to provide information for HB 1528. See Attachment #1.

Chairman Ruby: Is this dealing with tourist oriented directions? Do you consider the business that we have been talking about this morning as "tourist oriented"?

Darcy Rosendahl: Yes, they would qualify.

Chairman Ruby: Could they (Essigs) request this already without this bill?

Darcy Rosendahl: That is correct. They would just have to get the services of a contractor, have it installed, and pay.

Representative Heller: What is the liability issue if someone were to hit the sign?

Darcy Rosendahl: All the signs that we have must have breakaway bases. So, if an errant vehicle would get all the way to the back slope and hit one of these signs, it should break away and be safe.

Representative Vigesaa: What color is the background on these signs?

Darcy Rosendahl: The background is blue.

The hearing was closed on HB 1528.

2A. Bill and fiscal impact summary: Provide a brief summary of the measure, including description of the provisions having fiscal impact (limited to 300 characters).

This bill would allow the Department to install Tourist Oriented Directional (TOD) signs within the DOT right of way. The Department would charge the applicant for all costs associated with the installation. The remitted fee would be placed in the State Highway Fund.

B. **Fiscal impact sections:** Identify and provide a brief description of the sections of the measure which have fiscal impact. Include any assumptions and comments relevant to the analysis.

The average cost for sign sheeting is approximately \$24.20 per square foot. Fifteen square feet of sign sheeting is required by state law for all installations. This results in a total material cost per sign of approximately \$363.00. The estimated installation costs are approximately equal to the sheeting costs of \$363.00. Therefore the estimated costs for one sign would be approximately \$726.

The Department requires one sign for each direction of travel: $$726.00 \times 2 = $1,452.00$ 10 installations per yr / $$1,452.00 \times 10 = $14,520.00$ 20 installations per biennium/ $$1,452.00 \times 20 = $29,040.00$

The bill provides that the DOT may charge the applicant for the costs incurred to erect, install, and maintains TOD signs. The revenues that would be recovered per biennium under this provision are estimated to be approximately \$29,040, as calculated in part 2B of this fiscal note.

The estimated expenditures would be approximately \$29,040 per biennium as calculated in part 2B of this fiscal note.

The DOT would need an increase to its appropriation to cover the additional material costs that would be realized. The additional costs of the materials would be approximately \$14,520 per biennium as computed in part 2B of this fiscal note.

Good morning Mr. Chairman and members of the committee. My name is Darcy Rosendahl. I'm the Office of Operations Director for the North Dakota Department of Transportation (NDDOT). I'm here today to provide information on HB 1528.

Tourist-oriented directional signs (TODS) are signs that provide identification and directional information for tourist-related businesses, services, or activities. TODS are allowed under federal regulations. National highway standards for the signs are found in the Federal Highway Administration's Manual on Uniform Traffic Control Devices (MUTCD). Additional standards and guidance are found in state statute and administrative rules.

TODS can be placed on any state highway with the exception of the interstate. TODS is an option for businesses to consider, since it has more flexible placement criteria than commercial signing, which has different requirements. The signs are 6-feet wide and 30-inches high, and are located adjacent to the right-of-way line on the ditch backslope. One sign is allowed for each direction of travel.

If HB 1528 passes it would allow the department to place the sign and develop a payment plan. For example: The current cost for two signs and their installation is approximately \$1,500. Rather than paying the \$1,500 for the signs in one year, the Department could develop a plan that allows payment to occur over a three year period.

Over the last fifteen years there have been thirty-seven TODS erected across the state.
