Attachment 1. This is testimony on behalf of all member colleges of the North Dakota Association of Tribal Colleges.) In the formative years, there were some formalized agreements between their communities and the neighboring college or university. When they became accredited years later, they still struggled, but they had a different relationship with the colleges and universities throughout North Dakota. What they see in HB 1566 is something that is being formalized. He doesn't think this bill is intended to be a one-way street for the tribal colleges solely, but how can the universities benefit as well. There needs to be a better understanding and better working relationship between their colleges and the ND university

Dr. David Gipp, President, United Tribes Technical College, appeared in support of HB

1566. United Tribes Technical College is a member of North Dakota Association of Tribal

Colleges. They believe it would be a good beneficial thing for all of their tribal colleges and for the respective 11 public institutions and for their tribal government in seeking ways in which

they can better work together, how they can coordinate, and how they can look at ways in which they can improve upon their research asking and participate in growth capacity in terms

of the future of North Dakota particularly as it relates to the growing and young population they

have to serve throughout the state.

There was no opposition to HB 1566.

**Chairman Kelsch**: I have a technical question for the chancellor's office on HB 1566. Is the chancellor listed as the commissioner of higher education in statue?

**Michel Hillman, ND University System,** appeared to answer Chairman Kelsch's question. Actually in the constitution he is listed as commissioner so he serves as both commissioner and chancellor, but for the formal constitutional and label references, we use the title

commissioner.

**Rep. Jerry Kelsh**: I see there is no fiscal note or appropriation on here. Can this be done without some money being spent or do you have some in your budget that you can spend in this area?

Michel Hillman: I think there is quite a bit of flexibility here the way the bill is worded right now. We could continue on with joint meetings and talk about where things go and basically there would be travel expenses involved. Obviously, the chancellor's cabinet meets anyway so we try to double up as much as we can. If they are actually hiring a consultant for statistical work or those kinds of things, certainly there could be expenses involved. Again, I think we are waiting to see the legislative discussion, what the expectations are. As you heard from the testimony this morning I think we have an excellent and, improving still, relationships with the tribal colleges, but we are all about continuous improvement too. If there are things that we can and should be doing better, we would like to know about that. We will work on those.

Vice Chair Lisa Meier: Have there been any studies in the past with tribal colleges and the university system of North Dakota?

Michel Hillman: We do have, depending on how you label the word study. There are a lot of relationships and a lot of things when we come together. We do an official fall enrollment, for example, where we require degree credit enrollments at university system campuses. We also invite the tribal and private colleges to participate. It is not always 100%, but we do see in our enrollment report we have enrollment information when it is provided by tribal colleges included. Actually our office serves as ICA(?) as integrated by secondary education data system. US Dept. of Education official statistics are for data collection, and so we work with the tribal and private colleges on all of those things. We had a meeting last week on the tenth floor where we talked about the university system economic impact study. The tribal colleges also want to do that but will probably use the same consultant and a lot of the background in that study. I can't think of a special study that we worked on together just regarding the cooperation itself. I think there is a free and open communication chain. There aren't any barriers.

The hearing was held open for a few minutes because it was technically scheduled for 11:30.

#### Minutes:

Chairman Freborg opened the hearing on HB 1566. All members were present.

Representative Kasper introduced the bill. Collaboration has already started with the North Dakota college presidents and the tribal college presidents. He asked Chancellor Goetz if this bill would be appropriate and helpful to have a study and he said by all means. The bill would require Higher Education to study through the Chancellor's office the opportunity for increased collaboration and cooperation between the North Dakota University System and the tribal colleges. Over 90% of the graduates of the tribal colleges stay in North Dakota. The highest birthrate in the state of North Dakota is among the Native American citizens. We are looking for work force development and a more educated work force. This is a good chance to continue to look at how we can expand this opportunity. Many tribal college graduates go on to education with the North Dakota University System. It is a required study and the Chancellor supports it.

Senator Flakoll said in line 12, is it the legislative intent to look at all graduates from the tribal colleges including the non beneficiary students or just the Native American students.

Representative Kasper said it is his intent to look at all options to increase educational opportunities for all North Dakota students.

Russell Mason, President of Fort Berthold Community College, testified in favor of the bill. See written testimony.

Jim Davis, President, Turtle Mountain Community College, testified in favor of the bill. See written testimony. The tribal colleges are good feeder programs to the North Dakota University System 4 year schools.

Russell Swagger, Vice President, United Tribes Technical College, distributed testimony from David Gipp who was out of town. See written testimony. Now more than ever, United Tribe Technical College students go on for further degrees. This collaboration will help make sure there is no impediment to their transfer to the other institutions of higher education. We need to consider the economic impact of the ease of transfer, the return on investment is 20:1 at UTTC.

Chairman Freborg closed the hearing on HB 1566.

Senator Flakoll moved a Do Pass on HB 1566, seconded by Senator Bakke. The motion passed 5 – 0. Senator Flakoll will carry the bill.

Good morning! Thank you Chairman Freborg and members of the Committee for allowing me time to testify on behalf of the Turtle Mountain Community College and in support of HB-1566. My name is Jim Davis and I am the President of the Turtle Mountain Community College located in Belcourt, ND.

The commission study under this bill is yet another step in North Dakota to strengthen higher education amongst all institutions of higher learning. Although we have had collaboration and articulation agreements with most of the higher education institutions in ND, this bill provides the means to strengthen even more the higher education opportunities that we can and should offered to all of our citizens.

I wish to thank Dr. Goetz and his staff within the North Dakota University System for the work they have done to informally discuss common issues and concerns as they apply to NDUS and the tribal colleges in this state. To formalize this process and find ways to strengthen higher education in ND is something that was not thought of years ago when tribal colleges first came onto the scene some thirty-five years ago.

I am greatly encouraged by the people in the ND legislature who are willing to understand and appreciate the importance tribal colleges play toward providing higher education opportunities available to all citizens. Tribal Nations and their people have been the most underserved population when it comes to higher education in the past. Today, TMCC has a student enrollment of 790 students. Many of these students will be transferring to the mainstream institutions in the state upon completion of their two years at TMCC.

There are many other ways we can improve the transfer of our students to the ND mainstream institutions and later today and tomorrow I and members of my staff will be meeting with NDSU President Chapman and his staff to improve and find ways so there is a seamless transition of tribal college students to NDSU.

I believe this bill, if passed, will have a positive impact on the mainstream institutions once we collectively determine how to do this. I also believe the results of this study will help achieve this through a written report, a report we can use to strengthen higher education in North Dakota.

I recommend a "do pass" by this Committee. Thank you and I will entertain any questions you may have at this time.


A bill requiring the North Dakota board of higher education to conduct a study on the "interplay" between the North Dakota university system and the Tribally controlled colleges

Mr. Chairman and members of the Committee:



At the outset, I want to make clear to the Committee that the Tribal colleges have been meeting with the North Dakota university system for some time regarding a number of issues. For example, the tribal colleges have agreed to a common course numbering system consistent with that of the North Dakota university system, allowing easier recognition by the North Dakota state colleges of general education credits earned by students attending tribal colleges.

Essentially, HB 1566, asks the state commissioner for higher education in North Dakota to do three things:

- 1) study the relationship generally between the tribal colleges and the North Dakota university system and determine how they can work together more effectively;
- 2) study how Native American students can be assisted to pursue options in higher education;
- 3) study how Native American students can be assisted so that retention rates and graduation rates from college are increased;

While I believe that we are making progress with the North Dakota university system independent of the study contemplated by HB 1566, the study contemplated by HB 1566 is a good step forward and will aid in development of the relationship between the tribal colleges and the North Dakota university system. Therefore, we urge the House Education Committee to give HB 1566 a "DO PASS" recommendation.
