Representative George Keiser: In support of the bill. This is a short study resolution it comes in large part at the request of WSI as well as the WSI interim committee. There are four or five issues that continue to arise in the discussion and presentation of cases. Clearly this is one of them and as you can see although the 2008 performance evaluation when they focused on the degeneration condition found zero claims that were being denied. But there are still questions relative to North Dakota law. We do have in statute a relatively more conservative position than other states. We thought it would be appropriate to have a study or request legislative counsel to consider a study that would address the pre-existing degenerative condition.

Rob Forward, Staff Counsel for Workforce Safety and Insurance: WSI and the board of directors support 3008.

Jeb Oehlke, North Dakota Chamber of Commerce: Written testimony in support of 3008.

Senator Andrist: Asked about a friends' case.

Senator Behm: How do you determine how a case is reopened?

Rob: If a case is dormant for four years and in order for it to be reopened he has to show his injury was from a prior cause. We went from sole cause to primary cause.

Testimony of Bill Shalhoob North Dakota Chamber of Commerce HCR 3008 January 26, 2009

Mr. Chairman and members of the committee, my name is Bill Shalhoob and am here today representing the ND Chamber of Commerce, the principle business advocacy group in North Dakota. Our organization is an economic and geographical cross section of North Dakota's private sector and also includes state associations, local chambers of commerce development organizations, convention and visitors bureaus and public sector organizations. For purposes of this hearing we are also representing seven local chambers with total membership over 7,000 members and ten employer associations. A list of those associations is attached. As a group we stand in support of HCR 3008 and urge a do pass from the committee on this bill.

During the past interim we had a decision moving WSI back to the Governor's control. That issue has been decided. During the process there were many statements made about the benefit levels in North Dakota. As employers we believe our benefits, including those for those outlined in HCR 3008, are somewhere in the middle of those provided nationally. We would like to know definitively if that is not the case and this resolution gives a means to find an answer that may end the debate.

Remarks from Sylvan Loegering, regarding HCR 3008 January 26, 2008 Volunteer coordinator, ND Injured Workers Support Group

This measure cites the 2008 Performance Evaluation as its reason for existence, but it does not follow the recommendation. The evaluation recommends creation of a study group consisting of all the stakeholder groups. This measure asks legislative council to study and report findings and recommendations and legislation.

I'm afraid the public would see this measure as a way of delaying other changes in treatment of prior injuries, preexisting conditions and degenerative conditions. They know we have suffering injured workers right now who would be receiving benefits if they lived in almost any other state. The public might feel that this is a continuation of an organization run by insiders. That is what upset the voters so much in 2008.

I'm not pushing hard to stop the study or encourage it. I will ask that you do two things if you pass this resolution. First, I'd like to see it amended so that it truly follows the recommendation of creating a true study group with all stakeholders involved. Second, I'd like you to approve other bills that deal with the aforementioned type of injuries without waiting two or more years just to get ready to make changes.



Testimony of Jeb Oehlke North Dakota Chamber of Commerce HCR 3008 March 24, 2009

Mr. Chairman and committee members my name is Jeb Oehlke. I represent the North Dakota Chamber of Commerce, the voice of North Dakota business. Our organization is an economic and geographical cross section of North Dakota's private sector and also includes statewide associations, local chambers of commerce, development organizations, convention and visitors bureaus and public sector organizations. For the purposes of this hearing we also represent sixteen local chambers with total membership over 7,200 members and ten employer associations. As a group we stand in support of HCR 3008 and urge a do pass from the committee on this bill.

The businesses of this state depend on a healthy workforce to be successful. We believe Workforce Safety and Insurance does a wonderful job of making sure injured workers receive the proper care needed to get them healthy and back to work and that the benefits provided for by our statutes compare quite well with those offered by the rest of the country. However, we also believe that we need to study the system regularly to ensure it continues to provide adequate coverage for workplace injuries. The study proposed in this resolution will allow us to evaluate our coverage of certain injuries against that offered in other states and make adjustments if the study determines they are needed.
