Rep. Delmore: I'm looking at some of the things that may be missed by companies not totally regulated by FDA and then the fact that some of these products are passed on. And passed on sometimes without the knowledge passed out to consumers because they are outdated. There could be all kinds of ramifications from it.

Minutes:

Senator J. Lee opened the hearing on HCR 3024 directing the Legislative Council to study the safety of cosmetics.

Representative Lois Delmore (District 43) introduced HCR 3024 and explained that it actually started as a bill. The fiscal note and some other problems with the bill caused her to turn it into a study resolution. This breaks down cosmetics into several areas (1) relationship to cancer, (2) affect on unborn children and, (3) outdated cosmetics. This industry is regulated but not regulated by the FDA to the degree we think they are.

Senator J. Lee viewed this as more of a scientific research and didn't know if legislators are necessarily qualified and prepared to do it. She asked Rep. Delmore how she saw this study being held logistically.

Rep. Delmore replied that she expected looking at some of the facts, the missing things that we can look for legislation to cover. It is a very broad area. It's not an industry that really affects the state but we know of stores and retailers that are selling some of these products and we can attempt to do something with it.

Senator Marcellais asked if she knew how many other states have adopted safe cosmetic laws.

Rep. Delmore was aware of three starting with California and is gaining momentum.

There was no opposing or neutral testimony.

Senator Heckaman agreed with comments from Senator J. Lee that an interim committee wouldn't have the expertise in this area. On the other hand she thought there might be something they could look into on the secondhand cosmetics. She could see a lot of transfer of infections or diseases if cosmetics are being donated to a facility.

Senator J. Lee pointed out that some discount stores acquire cosmetics and other items that are on the verge of expiring. That is part of the concern.

She saw this as a federal issue.
