Representative Monson, Sponsor: You've seen this resolution before in previous sessions.

With the new President and some new players in Congress we wanted to revisit this issue.

Me

Line 9, it was never the intent of Congress to interfere with or prohibit the farming/production of

industrial hemp. When it enacted the original Marijuana Tax Act of 1937, it was quite specific

that it should not include industrial hemp. But in the 1970's it got changed. DEA has by their

own authority decided that they could require licenses and put on restrictions. On the second

page, line 4, North Dakota State University finally did get a license for one year. We want to

make sure they get a multiyear license. It took them eight years to get the first one.

Line 6 & 7, cost of \$100,000 is pretty much minimum. I put an amendment on the Senate side

to NDSU research station for \$200,000 special funds. It will be money donated or possibly

through APUC. The \$100,000 is pretty much the bare bones security requirements. We want

Congress to realize just how much this is costing. For them to have a one-year license, if they

can't get a multiyear license, that's a lot of money down the tubes for nothing.

Representative Kingsbury: How much does a license cost?

Representative Monson: It's about \$2,300. Import fee from Canada is about \$1,300.

Representative Uglem: 3/10% THC. What does the drug marijuana contain?

Representative Monson: The high potency is probably 20-25%. Point 3% is pretty low. That will do nothing.

Chairman Johnson: Do you have varieties that are for oil or fiber?

Representative Monson: Yes, and it depends on how tightly you seed it. The more crowded, it doesn't get as tall. The fiber on a small spindly plant is much finer. The finer the fiber, the better it is for clothing. If you're going to make it into fiberglass replacement car parts, courser is better. It could be thick like sunflower stalks.

Sen. Flakoll opened the hearing on HCR 3026, a resolution urging the US Drug Enforcement Administration to allow ND to regulate industrial hemp farming without requiring federal applications, licenses or fees. All members (7) were present.

Rep. Monson, district 10, testified in favor of the bill.

Rep. Monson- we put this in virtually every year, we are actually in a court case on this very issue saying that this is the states right and that it should not have to require the federal license or a DEA license to raise industrial hemp, that is what the whole issue here is. We have all the laws in place for industrial hemp. So I would urge you to support this.

Sen. Klein- the constant urging, are we really moving anything forward here?

Rep. Monson- it doesn't hurt to keep urging it, and our lawsuit here is probably the most complying thing moving it forward at this time.

Sen. Heckaman- do you know of any other states that are doing similar resolutions right now? **Rep. Monson**- there are a lot of states that are doing it now, there are a lot of states that have taken ND's lead. I am not sure of all of them I know in Vermont, Oregon, Kentucky and

Minnesota for sure have something similar in place.
