Chair Grindberg, Senator Warner, and Senator Krauter who were excused as they were in Washington D.C. for the inauguration.

Ken Bertsch, State Seed Commissioner testified in favor of SB 2022 and provided written testimony # 1. He went over his budget that is presented in the hand out. Salaries, Operating, Capital Expenditures, Grants, and Contingency . (06.13) consider an amendment if you would. On page 3 of testimony. (11.41)

V. Chair Bowman: Basically it is just spending authority that you would like to have in this Bill and then the language that you suggested to us on page 3 of your testimony? One question I have do you coordinate the type of research with NDSU and will you be able to utilize the huge greenhouse we are going to be building down there and work together to see if there is some kind of coalition to get the maximum amount of use of that.

Ken Bertsch: Those are two separate issues. This warehouse project that I am talking about up in the Grafton facility really is a federal issue. It doesn't have anything to do with NDSU. The greenhouse issue, on the other hand, we are in support of, that is extremely important for

the seed industry. It is two separate issues. But we do work very closely (13.20)

Senator Krebsbach: How many people are employed in your division, FTE and part-time.

Ken Bertsch: we've got 35 FTEs and right now we have 30 of them filled.

Senator Krebsbach: Potatoes are raised in many locals in North Dakota. Is this testing good all over?

Ken Bertsch: Yes it does apply to all potatoes grown in ND. Secondly, USDA CFIA Bilateral (14.34) agreement right now calls for a certain percentage of, it's pretty complicated and I won't go into it for time but seed acres are separated from commercial production, The concern being obviously the soil is transferred in seed potatoes and their shipped around state to state. However the commercial be sampled. These surveys are trying to make a determination that so that ND and Idaho basically had state borders, not only Canada but other states as well, closed until they narrowed down where that pest is occurring.(15.32)

Senator Krebsbach Had questions regarding the affect of the pest called Potato Cyst Nematode have on the potatoes.

KenBertch: It attaches to the root and may not kill the plant but will affect it adversely. I've seen pictures you wouldn't buy that bag of potatoes. If they look bad, you won't buy them. Mostly the skin is bad, they have black spots when you cut them open.

Senator Kilzer: I'm from western North Dakota where we don't grow commercial potatoes. The seed of potatoes that you sell is it potatoes you cut up or does the potato produce seed like a carrot.

Ken Bertsch: Seed potatoes are tubers, usually a smaller size, they are cut and potatoes in ND and most states have 6 generations of production. It might be a seed in breeders stock, it might be a seed like a carrot called a true seed off a potato plant and replant it for the purpose of using a tuber in the next generation. Beyond that they are all potato tubers. At the lowest generation are produced in Fargo in greenhouse, we cut little plant and plant those pieces and

produce those nuclear seeds which go out to northwestern North Dakota and are produced there and sometimes in generation two they are transported around the state or all over the United States. (19.15) Only1 generation you find the seed, the rest is all tubers, they are always cut mechanically with an eye in one of these pieces

Senator Kilzer: This potato needs human help to produce. I also have a question regarding contingency. Have you used it all?

Ken Bertch: Seldom. You could say this is contingency issue and I would be fine with that. It is always nice to have the authority in case we go over that amount. (20.53)

V. Chair Bowman: I'll have council draft an amendment that addresses those concerns.

Ken Bertch: I do have a model I'll share with Legislative Council. This provides the extra spending authority. (21.38)

V. Chair Bowman: That will work as long as we do it right.

Ken Bertsch: I had contemplated earlier in the year coming to the Emergency Commission for the authority to construct because we thought we would be starting last summer but we didn't have to do that because the federal funding issues didn't come about.(22.18) we'd like to begin construction as quickly as possible in the spring so we'd like to include some language regarding an emergency clause just for that construction project.

Bertsch: It is grower funds, actually from our revolving fund and cash from the reserve fund.

Continuing with testimony. In total the bill represents an increase of \$676,000 made up of the

initial budget request that was about a 1.4% increase. Secondly the Executive branch in terms of salaries and that \$200,000 amendment that we asked for in the Senate. He briefly explains the amendment that would allow construction of a warehouse facility in Grafton. USDA Aphus and the North Dakota Ag Department have asked for a use agreement where they would prepay rent. New need permission to construct the facility.

Rep.Williams: There is no problem with the \$220,000 because is basically self funded, why wasn't it in here?

Bertsch: We were and still are unsure

Rep.Williams: You would not construct the building until you have an agreement?

Chairman Skarphol: Are there any vacant positions

Bertsch: Currently 5, the longest is a ½ time position that has been vacant for 112 months.

Chairman Skarphol: Any you could do without?

Bertsch: We would not want to lose any. We assign positions on a regional basis.

Chairman Skarphol: On the Green Sheet, are there a couple of bills. Are there appropriations related to you? 2125 and 2122?

Bertsch: I don't have a Green Sheet. 2125 sounds familiar, is that the one that deals with compensation for

Tammy Dolan, OMB Analyst: Neither of these bills have an appropriation.

Rep. Klein: In the last biennium you had \$100,000 for extraordinary repairs that you did not need. Did you take that out?

Bertsch: We used part of that money. OMB has a formula that gives us the figure to construct the extraordinary repairs budget line. We seldom expend the entire thing.

Rep. Klein: Addressing Dolan, Why those changes on the Green Sheet?

Chm. Svedjan: This is the State Seed Dept. and comes out of the Education and

Mas

Environment Committee.

There are no amendments for this bill.

Rep. Williams referred the Committee to the green sheets for this bill.

Rep. Williams: The number of employees has been constant over the last two bienniums. In the Executive Budget if you look at 1, 2, and 3 under the highlight section you will see that the one-time expenditure from the previous biennium has been removed. The main point here is if you look at # 8 and #9 – the Exec. Budget has the 5 and 5, the Cost to Continue at 4%. In the bottom portion you will see there is \$200,000 for a custom software program to meet industry standards and \$55,000 for lab equipment. All of this money is not General Fund money. None of the money is General Fund money. It is from field inspections and certification fees. I have a list of the fees if anyone is interested. The Senate did grant one amendment. Page 2 shows that. They included \$200,000 for a new warehouse facility. The Seed Department has been cooperating with USDA, APHIS (Animal and Plant Health Inspection Service), and the ND Dept. of Agriculture to carry out soil surveys for potato cyst nematode. Because of the testing protocol and the materials needed, they requested this warehouse. They are trying to do it in Grafton in a garage that is not conducive to the testing. This only authorizes them to spend

some of their own funds to construct this new warehouse next to NDSU. There are no other changes in the budget from what the Executive proposed.

Rep. Williams: Moved to adopt SB 2022

Rep. Klein: Seconded.

Rep. Delzer: (4:20) What kind of reserve do they have in their fund?

Rep. Williams: I don't believe that came up in our hearing. I don't think they would request the authorization unless they had the funds.

Rep. Skarphol: That never did come up so I can't answer the question.

Rep. Delzer: Sandy?

Sandy Deis: I don't know. I could check.

Rep. Delzer: It looks like there is equity money in here.

Rep. Skarphol: There was no discussion about equity dollars. It is on the green sheet, but we did not catch it.

Chm. Svedjan: What is the amount of equity?

Rep. Skarphol: It shows \$1491.

Rep. Skarphol: We could make a motion to remove the equity dollars in this budget.

Rep. Wald: Seconded.

Chm. Svedjan: This is like the question that exists with Job Service ND and SB 2017.

We can proceed to pull the equity money even though it is not General Fund money and square this up in conference committee.

Rep. Skarphol: By changing it we are changing the bill.

Rep. Onstad: (7:10) If you're taking equity money which is General Fund money and you are putting it into pool, now you are taking other source money and putting that into pool, and then requests come back to take dollars from that pool doesn't that mean you could be taking other

fund money and subsidizing these other equity pools. Are each of these going to be kept separate? Or is it all going to come back in a lump sum. I don't know how you can combine special funds into a General Fund category.

Chm. Svedjan: I hear your question. We've posed that question with Legislative Council. The understanding I have is that even in instances where we pull General Fund equity money, there is Special and Federal that is tied to that. Is it kept separate? My understanding is that it is separate.

Sheila Sandness, Legislative Council: That is my understanding too. I will confirm that with Allen (Knudson). I'll get back to you in a couple of minutes.

Chm. Svedjan: If we pull this, and the Seed Dept. was authorized for an equity adjustment, we wouldn't use General Fund money to do it. You would have to use their funds.

Rep. Skarphol: (8:55) If there is a decision made to give them half as much equity money as what is in the bill, then the balance should be returned to the entity that had those Special Funds. The actual dollars taken out this budget, for example, would be returned to the Seed Department. I think that's the purpose.

A Roll Call vote was taken on the amendment. (Vote 2) Yes: 11, No: 9, Absent: 5, (Representative Kempenich, Thoreson, Berg, Kaldor, Ekstrom).

Motion carried.

Rep. Skarphol: Moved Do Pass as amended.

Rep. Wald: Seconded.

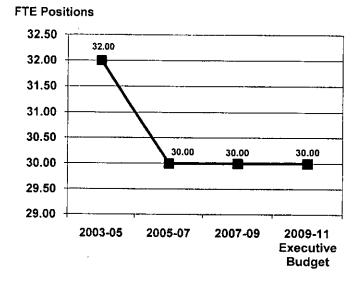

SB 2022 Seed Department Budget Senate Appropriations Committee

January 21, 2009

Good morning Mr. Chairman and members of the Senate Appropriations Committee. For the record, my name is Ken Bertsch and I serve as State Seed Commissioner and administrator of the State Seed Department. I appreciate the opportunity to speak to you today on behalf of the State Seed Commission and to provide and overview of HB 1022, the Seed Department budget.

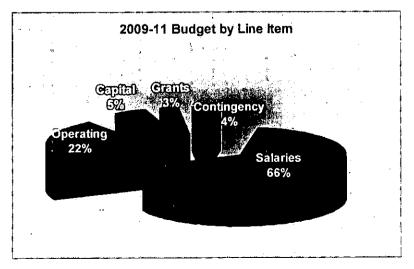
With the consent of the Committee, I will provide brief background of the budget request focusing on changes to the 09-11 as compared to the 07-09 appropriation.

The agency budget development process is guided by a long-range plan completed in late 2003 and updated annually, and is approved by the Seed Commission. The Commission is a nine-member board of directors appointed by associations throughout the state, which approves budgets, provides for policy changes and sets fees for the agency as per statutory authority.

As you know, the Seed Department is a self-funded agency whose budget consists (in total) of special funds, and whose revenues are derived from service fees.

Budget Described as Line Items

The Seed Department budget was converted to a single line budget in the 2005 Legislative Session. Six line items were previously used to describe the major operating functions of the budget. We will continue to outline these areas (salaries, operating, capital improvements, grants, contingencies) for purpose of comparison.

Discussion and Explanation

Section 1 of SB 2022 provides the base level, enhancements and final Executive budget appropriation of the previously mentioned single line budget.

First, committee members will notice that our testimony notes our total budget for 2007-2009 as \$6,179,126 rather than \$6,166,218 base level as described in SB 2022. The \$6,166,218 total is the final budget passed by the 2007 Legislature, and signed by Governor Hoeven. However, this figure does not take into account the impact of <u>SB 2189</u>, which added an additional \$12,908 in equity pool funding to our budget.

Following is a brief explanation of the budget increase in line item format:

1) Salaries

The net change is a result of the adjustments for cost to continue fiscal year 2009 4% salary increase (shown in the 2009-2011 Request column) and the Governor's salary increase recommendation (5%-5%, shown in the Executive column) impacting base salary and benefits package.

2) Operating

The Department is not requesting an increase for operating funds.

3) Capital Expenditures

The capital expenditures line increases by \$203,500. Included in the request is: \$200,000 for conversion of our custom software programs to current industry standards utilizing updated programming tools; \$55,000 increase to provide for updating laboratory equipment, and \$98,500 for facility repairs according to the extraordinary repairs buildings formula calculation provided by OMB.

4) Grants

NDSSD utilizes a grants line item to fund seed industry promotion efforts with grower final certification fees. Additional funds were shifted to the Grants line in 2008 to allow for Seed Commission action to contribute \$250,000 to the NDSU Greenhouse Facility project. The line item is reduced to normal levels in the 2009-2011 budget for a reduction of \$169,000.

5) Contingency

The Seed Department has commonly carried a contingency line in our budget to account for urgent situations such as Karnal Bunt or other phytosanitary emergencies. This line remains unchanged for the 2009-2001 budget.



In total, **SB 2022 represents an increase of \$457,676** over the 07-09 budget. The increase includes 1.4% requested by the Department and the balance from the Executive recommendation for compensation package adjustments.

A depiction of our budget by **major program area** is provided as an appendix in page 4 of this testimony.

Amendment

Over the past two years, the Seed Department has been cooperating with USDA-APHIS and the ND Department of Agriculture to carry out soil surveys intended to determine the presence or absence of a quarantine pest called the Potato Cyst Nematode. This USDA-APHIS testing protocol has been instituted in a bilateral trade agreement with Canada to allow for trade between the two countries after nematode finds in Idaho and Alberta.

This PCN testing requires warehouse space designed to dry and store soil samples that are currently sent to Idaho for testing and disposal. This warehousing and drying process has been carried out at our regional facility in Grafton, where the Seed Department has provided space in our storage/garage area for use by the federal and state personnel.

The space required to carry out the soil survey project is far more than we can provide in a garage type space attached to our Grafton office.



USDA-APHIS has expressed interest in creating a long-term arrangement in Grafton, due to the central location of the city in relation to the soil survey project. We are negotiating with USDA to create a **use agreement**, whereby USDA agrees to pay space rental in advance of use, in exchange for sole use of facilities constructed by another party.

This use agreement would allow the Seed Department to build a warehouse structure adjoining our facility that would provide adequate space to dry and store samples and equipment used in the soil survey (samplers, trailers etc.). Under the use agreement, we would continue to provide USDA/NDDA personnel with office space during peak sampling times. Upon completion of the use agreement, estimated at ten (10) years, the Seed Department would assume ownership/title of the warehouse addition. Essentially, the contract provides for pre-payment of rents over the agreement term.

We currently estimate the construction cost of a warehouse addition at approximately \$120,000. However, the USDA-APHIS state director and I are working to expand the current project blueprint from 2500 sq. ft. to 4000 sq. ft. to account for the possibility that the soil nematode testing should need to be performed on-site in a laboratory type enclosure inside the warehouse. I estimate that the additional size may increase the cost to \$150,000-\$200,000.

I am asking the committee to consider and approve an amendment that would allow the Seed Department to construct an addition to our Grafton facility, and receive and expend funds for the project. Also, an emergency clause on the amendment would be appropriate and necessary, as we would need to break ground on the project in spring in order to be operational by August when the soil survey commences.

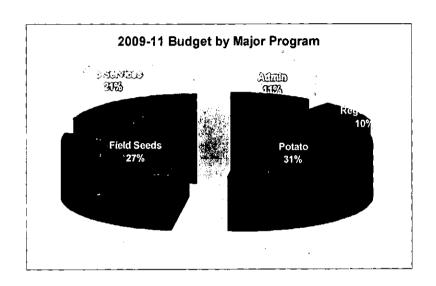

For the record, my name is Ken Bertsch and I serve as State Seed Commissioner and administrator of the State Seed Department. I appreciate the opportunity to speak to you today on behalf of the State Seed Commission and to provide and overview of SB 2022, the Seed Department budget.

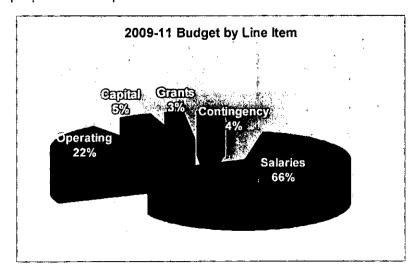
With the consent of the Committee, I will provide brief background of the budget request focusing on changes to the 09-11 as compared to the 07-09 appropriation.

The agency budget development process is guided by a long-range plan completed in late 2003 and updated annually, and is approved by the Seed Commission. The Commission is a nine-member board appointed by agriculture associations throughout the state, which approves budgets, provides for policy changes and sets fees for the agency as per statutory authority.

As you know, the Seed Department is a self-funded agency whose budget consists of special funds, and whose revenues are derived from service fees.

Budget Described as Line Items

The Seed Department budget was converted to a **single line budget** in the 2005 Legislative Session. Six line items were previously used to describe the major operating functions of the budget. I will briefly outline these areas (salaries, operating, capital improvements, grants, contingencies) for purpose of comparison.

Discussion and Explanation

Section 1 of SB 2022 provides the base level, enhancements and final Executive budget appropriation of the previously mentioned single line budget.

First, committee members will notice that our testimony notes our total budget for 2007-2009 as \$6,179,126 rather than \$6,166,218 base level as described in SB 2022.

The \$6,166,218 total is the final budget passed by the 2007 Legislature, and signed by Governor Hoeven. However, this figure does not take into account the impact of <u>SB 2189</u> (2007 session), which added an additional \$12,908 in equity pool funding to our budget.

Following is a brief explanation of the budget increase in line item format: (Seed Department request shown in blue, Executive budget in black, Senate/engrossed version in red)

1) Salaries

The net change as requested in the **09-11 Executive** column is a result of two adjustments:

- a) Cost to continue fiscal year 2009 4% salary increase as shown in the Department's 2009-2011 Request column
- b) Governor's salary increase recommendation of 5% and 5% as shown in the **2009-2011 Executive column**

The engrossed version of the SB 2022 salary line remained unchanged.

2) Operating

The Department is not requesting an increase for operating funds.

3) Capital Expenditures

In the Executive budget recommendation, the capital expenditures line increases by \$203,500. Included in the Department's request is:

- a) \$200,000 for conversion of our custom software programs to current industry standards utilizing updated programming tools
- b) \$55,000 increase to provide for updating laboratory equipment
- \$98,500 for facility repairs according to the extraordinary repairs buildings formula calculation provided by OMB

Additionally: The engrossed version of SB 2022 (represented in the **09-11 Senate column**) contains an additional \$200,000 in capital expenditure authority requested by the Seed Department in an amendment to the Senate Appropriations committee. I will explain the reason for the amendment and appropriation at the end of this presentation.

4) Grants

NDSSD utilizes a grants line item to fund seed industry promotion efforts with grower final certification fees.

Contingency funds were shifted to the Grants line in 2008 to allow for Seed Commission action to contribute \$250,000 to the NDSU Greenhouse Facility project. The line item is reduced to normal levels in the 2009-2011 budget request, for a reduction in the grants line of \$169,000.

5) Contingency

The Seed Department has commonly carried a contingency line in our budget to account for phytosanitary emergencies during the biennial budget cycle. This line remains unchanged for 2009-2011.

In total, **SB 2022 represents an increase of \$657,676** over the 07-09 budget. The increase includes;

- a) 1.4% base increase in the original Department budget request (capital related)
- b) Executive branch recommendation for compensation package adjustments
- c) \$200,000 in capital construction funds requested by the Department in Senate amendment

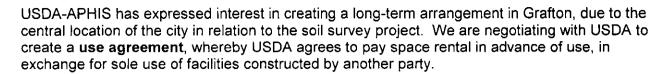

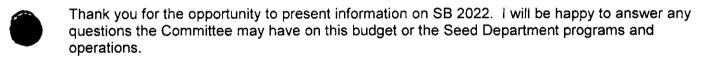

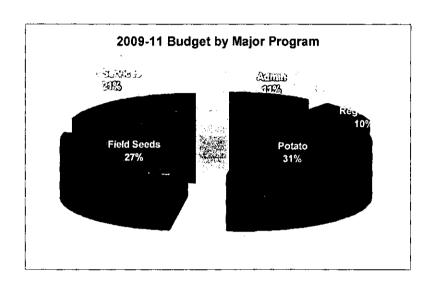
We requested, and the Senate approved, an amendment allowing the Seed Department to receive and expend funds for the project. As discussed, the amendment provided an additional \$200,000 in spending authority to our budget, which will be internally allocated to our capital line. Also, the Senate approved an emergency clause, as we would need to break ground on the project in spring in order to be operational by fall of 2009 when the soil survey commences.
