**Senator Klein** opened the hearing on SB 2056 relating to workers' compensation mileage reimbursement for injured employees' medical travel. This would bring them in line on how the state pays other state employees.

**Tim Wahlin,** Chief of Injury Services with WSI testified in support of SB 2056. Written testimony #1. The change will allow for greater accuracy in mileage calculations.

**Senator Potter** asked how they would pay for a trip to Grand Forks. If you go by Interstate, it is 270 miles, not all interstate, it is 245 miles. He asked which mileage they paid.

**Wahlin** said he was unsure. He said the way that they would calculate is off the ND state map. We would go zip code to zip code.

**Senator Klein** said that we could be giving some people additional revenue if they are living on right side of town.

**Wahlin** said that is correct and that is one of the reasons there will be no fiscal impact because some people will live on one side of the zip and another person will live on the other side of the zip. It will allow for greater accuracy.

**Senator Potter** asked if they were using the state highway map, Google, MapQuest or how they would determine the distance.

Chairman Keiser: Opened the hearing on SB 2056 relating to workers' compensation mileage reimbursement for injured employees' medical travel and to provide for application.

Jennifer Clark~Legislative Council. This bill changes how WSI reimburse the injured worker for their travel expensed when they are going and receiving medical treatment. Under existing law, an injured worker submits their expensed based upon travel from the outside of city limits. If I'm going to travel from Bismarck to Fargo, I start on the outside of city limits to the east and my miles stop when I hit the city limits of Fargo. We are changing that to cover actual miles covered keyed into Map Quest and come up with the actual miles traveled. That's the number they are going to use. On page two you can see the application to travel that takes place on or after the effective date of this act.

Representative Amerman: What are they going to key into?

JClark: Map Quest.

Tim Wahlin~Chief of Injury Services, WSI. See testimony attachment.

**Chairman Keiser:** Just point out to the committee, the agency, the impact will be minimal, but so some of the claimants, the impact will be pretty significant.

Wahlin: That correct, especially in the rural areas.

# 2009 Senate Bill No. 2056 Testimony before the Senate Industry, Business, and Labor Committee pame ofice. Presented by: Tim Wahlin, Chief of Injury Services Workforce Safety & Insurance January 19, 2009

Mr. Chairman, Members of the Committee:

My name is Tim Wahlin, Chief of Injury Services with Workforce Safety and Insurance (WSI). On behalf of WSI, I am here to testify in support of SB 2056, a proposal submitted at the request of the Interim Legislative Workers' Compensation Review Committee. WSI's Board of Directors unanimously supports this bill.

SB 2056 changes the basis for calculation of mileage reimbursement for injured workers traveling by motor vehicle to and from medical appointments to miles actually and necessarily traveled.

Current law requires mileage reimbursement be based on actual map or atlas mileage from city limit to city limit and excludes intracity mileage. In the age of Google®, MapQuest® and the like, calculation of actual mileage within city limits is easily calculated, consistent and verifiable. This change will allow for greater accuracy in mileage calculations. No significant fiscal impact is anticipated.

WSI requests your favorable consideration of SB 2056. I would be happy to answer any questions you may have at this time.
