Relating to licensing student teachers

Janet Placek Welk, Executive Director of the Education Standards and Practices Board – See written testimony.

Senator Nething - Asks if backgrounds have been a problem and how they are dealing with this now.

Welk – She said they have gotten many calls from institutions, from schools, and from applicants asking for the board to make the decision, which they have not done. Her recommendation has been to have the candidate share their background information with the institution and local district.

Senator Nelson – Questions the licensing term for student teachers, and would this bill eliminate the finger printing rule.

Welk - Said yes it would. On their application it asks for them to disclose anything in their past. She discusses what information usually comes out in the background checks.

Josh Askvig - ND Education Association - He is in opposition - They are not opposed to criminal background checks. There concern is for a license for student teaching. He said it seems to be another barrier for getting teachers to teach. He is for letting the schools decide who gets to teach and who doesn't.

There is discussion on students getting background checks, is there some doubling up on checks. Also should institutions be left to make their own decisions?

Senator Olafson – Asks why licensing is a problem.

Askvig – Said it is another fee that students are burdened with.

Senator Olafson – Asks if there is a complex application to fill out.

Askvig – Said he doesn't know if there is an application for the student teaching license yet but for the teacher license it is a 2 or 3 page application.

Tom Trenbeth, Chief Deputy for Attorney General – See written testimony. He provides a proposed amendment.

Discussion continues on background checks and committee goes over the amendments provided by Mr. Trenbeth.

Good morning, Mister Chair and Members of the Judiciary

Committee. For the record, I am Janet Welk, Executive Director of
the Education Standards and Practices Board and wish to provide
testimony in support of SB 2084.

Last session, legislation was passed requiring all student teachers to have a criminal background check completed prior to any student teaching experience. This criminal background check included an investigation of the records at BCI and FBI. We learned, early in the process, that if a student had a record, there was a lot of confusion as to what that student could do. Who was to make the decision as to whether the student should be allowed to work with children. Many people thought ESPB could act on the information prior to letting the candidate teacher student teacher. ESPB had no authority to act prior to application for initial licensure. The institutions of higher education, with approved teacher education programs, has asked ESPB to provide a student teaching license prior to the student

teaching experience. They wanted one body making the decision.

This license would provide documentation to the institution and the local district, ESPB had reviewed the background information and made a decision regarding the student teaching license.

On behalf of the members of the North Dakota Association of Colleges of Teacher Education, I wish to support SB 2084 which would provide a student teaching license which would document clearance of background investigations <u>before</u> candidates enter the schools.

Support of this bill is based on the fact that ESPB currently receives the results of the background checks from the ND BCI and the FBI and sends notices to candidates regarding their record. Candidates with records should be required to submit documentation prior to student teaching so that ESPB can determine if the record would potentially deny them from seeking a teaching license.

SB 2084 TESTIMONY OF THOMAS L. TRENBEATH CHIEF DEPUTY ATTORNEY GENERAL

Chairman Nething, members of the Senate Judiciary Committee, I appear this morning to offer a friendly amendment to SB 2084. In order for full criminal background information to be obtained on an individual, access must be had to the records of the FBI. The FBI has a "single contact" rule, which dictates that only one entity per state may access their information. That agency, in North Dakota, is the Bureau of Criminal Investigation, a division of the Office of Attorney General. In order for the BCI to make a request to the FBI, it must have direction by the legislature for the groups required or allowed to obtain the information. One such group, covered by this bill, is the student teacher population. The bill before you is, therefore, enabling legislation allowing the Education Standards and Practices Board to ask the BCI to request the information from the FBI. What is then needed is the statutory authority for the BCI to make such a request.

N.D.C.C. 12-60-24 is the statute commanding the BCI to request criminal history background checks on individuals belonging to groups name din that statute. 12-60-24(2)(c) is the subparagraph

directing BCI with respect to those individuals whose background checks are requested by the Education Standards and Practices Board. The subparagraph contains no reference to student teaches and, therefore, if SB 2084 were to pass, the request could be made but could not be honored.

The proposed amendment merely adds that group into the subparagraph to complete the intent of the proposed legislation.
