Shane Goettle, Commissioner, and ND Department of Commerce: (Testimony Attached).

Senator Potter: You're getting rid of the ten million dollar cap on investing alternative and adventure capital investments, from the Bank of North Dakota, but you're still managing alternative adventure capital investments are there any limits to that? How is that determined? Shane Goettle: We negotiate with the banks but the limit would be what the bank would impose on that agreement. We're doing it well under market.

Senator Potter: The cost of your service to the bank, but what about the loans themselves? You were not allowed to borrow funds to exceed ten million dollars, not to exceed ten million dollars. Is there any limitation now?

Justin Diver, North Dakota Department of Commerce: The limit and statues are actually under the Bank of North Dakota division, and so the ten million dollar limit will remain.

All this does is removing the borrowing authority from the development.

Senator Horne: Do interns come only from the University level and you want to extend it to the eleventh and twelfth grade levels? What is involved in your program, if I was to become an intern in your business, how would that work? Do you benefit somehow financially?

Bob Pope: In the current program, we bring on an intern from the college they are paid about twelve to fourteen dollars an hour. This program supplements that so it doesn't cost us as an employer so much, it encourages us. I think the cap is three thousand dollars. We train and mentor them; they are productive in helping us provide better services to our customers.

"SECTION 10. AMENDMENT. Section 54-60-03 of the North Dakota Century Code is amended and reenacted as follows:

54-60-03. Commissioner of commerce - Duties. With the advice and counsel of the North Dakota development foundation, the governor shall appoint a commissioner to supervise, control, and administer the department. The commissioner serves at the pleasure of the governor and receives a salary set by the governor within the limits of legislative appropriations. The commissioner:

- 1. Shall file an oath of office in the usual form before commencing to perform the duties of the commissioner;
- Shall serve as chairman of the cabinet;
- 3. Shall propare the cabinet's list identifying-economic development moneys included in budget requests of cabinet-agencies;
- 4. Shall appoint personnel as may be determined necessary to carry out the duties of the department;
- 5. 4. Shall manage the operations of the department and oversee each of the divisions;
- 6. <u>5.</u> Shall assume central responsibilities to develop, implement, and coordinate a working network of commerce service providers;
- 7. 6. Shall coordinate the department's services with commerce-related services of other state agencies;
- 8. 7. Shall advise and cooperate with departments and agencies of the federal government and of other states; private businesses, agricultural organizations, and associations; research institutions; and with any individual or other private or public entity;
- 9. 8. May enter contracts upon terms and conditions as determined by the commissioner to be reasonable and to effectuate the purposes of this chapter;
- 10. 9. Shall report between the first and tenth legislative days of each regular legislative session to a standing committee of each house of the legislative assembly as determined by the legislative council and shall report annually to the foundation:
 - a. On the department's goals and objectives since the last report;

Representative N Johnson: On page five, when you talked about the local economic developer certification education program, if you think about language where you put both in every two years instead of this next biennium it's going to be certification and the next one

Goettle: Honestly, that's a function how much turnover there's been in the ranks of economic

developers and whether there's enough demand to do that because they can be in North

Dakota and get certified and so we thought we would work with EDND and leave some

flexibility in there and gage that. We know there isn't enough demand going for the next

biennium because we just hit a crash. We needed some flexibility but it's possible that we would do education two biennium's in a row and come back as an officer.

Representative N Johnson: That was what I was just saying and/or education...

Goettle: I think that would be just fine with me.

Chairman Keiser: Just following up on Representative N Johnson, if you look at page five, it certainly could be "local economic developer certification and education program" and then you would have the flexibility to do with it. If a new person were hired, it would be nice to certify them.

Representative Nottestad: I comfortable so far, I had one question about getting an amendment.

Representative Ruby: On section five, where you are removing "economic development strategic plan", how involved is that? Isn't that useful information to have if you're going to be requiring for allowing use of this fund?

Goettle: Right now, an economic development strategic plan as we interpret this, is something that they have actually put together rather comprehensively and done in their community. This is supposed to be for rural cities and a lot of them are pretty small. So we put the resources into what we term "economic development strategic plan" and this is \$20,000 to \$25,000. That a big burden to put on the program which can only access \$75,000, it's not that we don't want plans from, but the way it's termed right now, we thought it would be problematic. I think, obviously, if they are still applying for this fund, to want to know the background and what they did in terms of planning, we just don't want them to go through all the hoops of economic development strategic plan to access those dollars.

Representative Vigesaa: In that same section, it doesn't address it in this bill, but what are the size parameters for being designated a rural growth incentive city?

Goettle: Off hand, we think 8,000.

Representative Vigesaa: Also, below that.

Goettle: We will get that information to you right away.

Chairman Keiser: Commissioner, going back to Representative Ruby's & Representative Vigesaa question, on section five. I realize these are small cities and they don't have staffs

typically, but shouldn't an economic development strategic plan have some statement or

concept to what they are look at rather than just applying for the money?

Goettle: First of all, we may have been the victims of ourselves on this in some respect. This

is trying to incent cities to go through this comprehensive plan, but it just didn't work. What we

want to do is to review our operations and programs that are being deployed and aren't. If we

ask ourselves why they aren't being deployed, what's the barrier? We asked communities why

they were not applying; they said that they didn't want to go through that process. Now we

probably could internally revise that to say, we don't expect full blown economic development

strategic plan.

Chairman Keiser: Is there a way to state it that they have to have some kind of document?

Goettle: We have them have some kind of proposal and that would be like any kind of

enterprise.

Chairman Keiser: Perhaps, this is adequate.

Goettle: The population is 2,500 or below.

Representative Vigesaa: Would you anticipate if we removed that obligation, you would get

more applications?

Goettle: I asked that same question to my staff. We thought about eliminating the whole

program and knowing that this is barrier that some communities have communicated to us.

We thought we would just test this then and see if they access the program once we remove

the barrier. We think for communities might access this and it depends on us getting the word out about the availability of the funds. If the program continues, that's what we would do. On the other hand if we should do away with it, we would do that.

Vice Chairman Kasper: On page four, line 27, referring back to the economic development strategic plan, "meets any additional program requirements provided by rule", have you developed rules in that area which might be what the committee is asking about as far as substituting for an economic development strategic plan?

Goettle: I'm going to defer to Paul Lucy.

Lucy: As far as I know, there are not any specific rules that necessarily laid out. It's on a case by case basis.

Representative Ruby: I was wonder, how much is available in the fund?

Lucy: I don't know exactly what the balance that would be; I would have to check with the CEO.

Chairman Keiser: Should we raise that number of \$25, 000? This is our chance.

Lucy: I would have to spend some time with the CEO of the development fund. These funds have to be paid back and the larger community you get to, the more their capacity and capabilities are to pay back to the revenues that are coming in.

Chairman Keiser: As I think about it, \$25,000 to \$75,000 doesn't sound like too much, but in terms of cash match, that is really significant for a small community. This is an opportunity to look at this but it seem to me that we should have considerately expanding that number, but also create a two to one match for these smaller communities. If we are looking for barriers and trying to get the smaller communities engaged in this, for them to raise \$10,000 and be able to access \$20,000 makes a whole lot more sense. For cities like Bismarck or Fargo, it's not too hard to get a one to one match.

Goettle: There is something else that I would like to point out here, the small cities often times they are struggling to keep open a grocery store. You will see that this gives them a set of funds that they can manage on their own but also geared to help a grocery store or a gas station. You wouldn't have that challenge with a larger community.

Chairman Keiser: Where is the fiscal note on this bill?

Goettle: There is not a fiscal note on this one. There is no additional cost associated with what we are attempting to do.

Chairman Keiser: So, any extension program like, the apprenticeship program, you are going to absorb that internally?

Goettle: In the Department of Commerce budget bill, for this biennium, operation interim is funded at \$600,000. The governor's recommendation is proposed to double that program to \$1.2 million. The change we want to make, we will work with no matter what the size the program.

Bill Shaloob~North Dakota Economic Development. The most exciting part of this bill is the change on the certification to an education program. The EDNDN congress envisions that actually going down to the board. As old board members come off and as old board members are there, we can actually get to these folks and let them know what's available. As they know what's available, they can take that back to their communities and take advantage of the programs of the congress, if they can go through this educational process, get it down to the folks who are trying to drive the project and make it work. If we can get these folks in and tell them what's there, maybe we can spark an idea on how to make it work. I hopeful that's what will happen.

Lucy: That's a moving target. I believe the last look it was somewhere around six to eight

million but there are a number of commitments out. That is just the balance that's in there.

Chairman Keiser: If we were to expand the size of the cities that could apply and if we were

to change the cash match for cities under 25,000, would that create a fiscal note that would

impact the fund or would it just come out that fund?

Lucy: I believe I would need to have a conversation with the CEO of the development fund to

give you a good answer to that question. I could see that it would definitely have impact on an

increased demand on the fund.

Chairman Keiser: But the fund wouldn't be increased?

Lucy: No, it would not.

Goettle: In looking at how that fund would be in the financial situation in the upcoming

biennium, if you recall two years ago, we did request three million dollars into the fund because

of the size of the projects that we had financed. The returns that we projected from equity

investments as well as the loans, we thought that would be sufficient to take care of the

demand that we saw against fund going forward and that included some assessment of what it

means in terms of the cities that might access this. If you increase that population pressure, it

would change our projections on that fund. We would have to rerun those based on our

estimated (?).

Chairman Keiser: At this point in the game, that might not be a good idea.

Vice Chairman Kasper: Is the six to eight million dollars available or is it loan out? What I'm

wondering is how much is left for new loans right now if someone wanted to apply for a loan?

Goettle: That the balance we have on hand right now. There are contingents upon that and

that's what we don't have an exact figure for you. We can get that because we keep a running

list of those commitments but they are always changing. Cash on hand is just over six million.

Vice Chairman Kasper: It would be helpful, at least for me, if you could give us a list over the

last two years of the projects that have requested funding and the projects that were funded

with maybe some dates so we can see the activity because if we are talking about expanding

and the activity is modest, expansion for the next biennium might not be a big problem. How

can we make a decision, if we can't see something, numbers?

Goettle: We could easily provide that for you.

Paul: Dean Reece is running those exact numbers; Shane & I will be meeting when we get

back to the office to discuss those. I can tell you that the projections that were presented to

me in the last few months represent what that fund typically does over the last three years. It

has averaged approximately 6.5 million dollars in revenue in funds. About 3.9 million dollars

investments coming back in to cover all operation costs...

Representative Ruby: You are talking about the broad development funds, but for the

provision of the rural growth incentive fund, it can tap into those that are available. If I

remember the testimony correctly, you haven't awarded any of those types of incentives yet

because no one has wanted them. Is that right?

Goettle: There has been one.

Representative Ruby: What Vice Chairman Kasper is asking for is a much more

comprehensive list of information as far as activity from the whole fund?

Chairman Keiser: Correct, but what I am understanding from the commissioners is that the

budget for commerce was prepared and taken to the governor and appropriations. They had

considered all of their anticipated, current & past activities and they are comfortable with the

budget that was submitted. If we change, either the threshold of the number of people in the

community or the cash match, that would require an adjustment to the budget that was

submitted. That would be a new fiscal note.

Chairman Keiser: Sara, on the certification education program, it seems to me that there is a potential significant difference economic development and tourism. Should we have a

certification education program for tourism?

Sara Otte Coleman~Department of Commerce. We do offer scholarships in conjunction with our destination marketing association. There isn't one certification program for tourism, which is a difficulty because there is so many specialties area that tourism professionals work in, but there might be some merit in investigating how we could go further. One thing that we

have done this year is we developed a hospitality training program. This is a DVD based

program that we have gotten out through the whole state.

Chairman Keiser: On the side of the insurance, tourism has a very different problem than does regular commercial economic development. I wonder if we don't need to pump up our educational program on the tourism side for those people in the industry so they can find their own solutions, like the equine insurance. Montana and Wyoming have done it but apparently North Dakota has not.

Coleman: That's true. The difference you have between tourism professionals is many of them focus their efforts on marketing as opposed to development.

Representative Nottestad: The training has great value. If I had training, it would have been great for me with my contact of school parents moving, to have some training. Sometimes I average 10 to 15 new parents a week and any training for people who have access like that would pay off in the long run.

Coleman: That's so true. Tourism professionals are really every day, ordinary people that live throughout North Dakota and we try to get the message out to them & provide them information. The website has done a tremendous amount to enhance that because of the

information on the website that people can access easily.

Good morning, Mr. Chairman, and members of the committee. I am Shane Goettle, Commissioner of the North Dakota Department of Commerce and I am here before you today in support of SB 2110.

SB 2110 was introduced by the Department of Commerce to clean up our statute, modify a few Commerce related programs, and add a Rural Development Office and Council.

Section 1 makes permanent the North Dakota Development Fund's role in the New Venture Capital Program that is currently set to expire on July 31, 2009. The Development Fund currently manages the New Venture Capital Program for the Bank of North Dakota. The Bank of North Dakota introduced SB 2103, a bill you will hear tomorrow, which makes permanent the New Venture Capital Program. Section 1 also removes the Development Fund's authority to borrow the \$10 million from the Bank of North Dakota, as it has been decided that providing management services was a more appropriate way to run the New Venture Capital Program.

Section 2 generalizes the ED&F Division's mission to focus on "identified target industries" instead of listing specific industries. The North Dakota Economic Development Foundation is undergoing a process to revisit its strategic plan and will be reviewing the target industries. Section 2 also removes a reference to the Myron G. Nelson Fund, which is no longer in existence.

Section 3 amends the ED&F Division structure to reflect current practice. The ED&F Division does not have a specific Finance Office and the International Business and Trade Office was changed to report directly to the Commerce Commissioner last session.

Section 4 adds the responsibilities of the Finance Office to the duties of the ED&F Division Director.

Section 5 removes the requirement for a Rural Growth Incentive City to prepare an economic development strategic plan. The strategic plan requirement has served as a barrier to cities accessing the program as the cost of developing a strategic plan many times outweighs the benefit of the Rural Growth Incentive.

Section 6 transitions the Local Economic Developer Certification Program to an education program. 32 developers were certified as Economic Development Finance Professionals by the National Development Council as a part of the program and we would like to continue an education program that could include more than just a certification.

Section 7 generalizes who the Tourism Division works with to "tourism partners." Tourism partners include more than just political subdivisions.

Section 8 updates the Tourism Division Director's duties to include current activities and strategies. Section 9 updates the state's tourism policy to reflect the role Tourism marketing plays in improving the image of North Dakota and assisting with attracting new residents.

Section 10 is a change recommended by the North Dakota Economic Development Foundation. It clarifies that the Foundation can spend its funds on Commerce activities in or out-of-state.

Section 11 removes the responsibility of the Commerce Cabinet in regards to preparing a list of economic development moneys included in the budget requests of cabinet agencies. This information is gathered elsewhere and provided to legislators, a copy of which is attached as an appendix. We are proposing an amendment to SB 2110, which is attached, to also remove this responsibility from the Commissioner of Commerce.

Section 12 expands Operation Intern to include apprenticeships and high school students in grades 11 and 12. These changes were recommended by the Workforce Development Council and reflect the importance of skilled trades and technology occupations in our workforce.

Section 13 creates a Rural Development Office within the Department of Commerce. The Department of Commerce currently contracts with the Center for Technology & Business to provide rural development services. Section 14 places the Rural Development Council into statute.

Section 14 repeals the ED&F Division's Finance Office, the Tourism Division's Motion Picture Development Office, and the Target Industries reporting requirement. The Finance Office responsibilities were transferred to the Division Director in Section 4. The Tourism Division does not currently have an active Motion Picture Development Office. We will continue our work in regards to target industries, but do not feel it's necessary to do so in the manner outlined in NDCC § 54-60-11.

- 8. Shall advise and cooperate with departments and agencies of the federal government and of other states; private businesses, agricultural organizations, and associations; research institutions; and with any individual or other private or public entity;
- 8 9. May enter contracts upon terms and conditions as determined by the commissioner to be reasonable and to effectuate the purposes of this chapter;
- 9 40. Shall report between the first and tenth legislative days of each regular legislative session to a standing committee of each house of the legislative assembly as determined by the legislative council and shall report annually to the foundation:

- a. On the department's goals and objectives since the last report;
- b. On the department's goals and objectives for the period until the next report;
- c. On the department's long-term goals and objectives;
- d. On the department's activities and measurable results occurring since the last report; and
- e. On commerce benchmarks, including the average annual wage in the state, the gross state product exclusive of agriculture, and the number of primary sector jobs in the state;
- 10 11. Shall adopt rules necessary to implement this chapter; and
- 11 42. May take any actions necessary and proper to implement this chapter."
