Patrick Bohn- Deputy Director for Transitional Planning Services – Explains the bill, see written testimony.

Senator Nething mentions under the current structure you don't have a director of the division of parole and probation. The current law 155.105 says the director of the division of parole and probation shall serve as the pardon clerk. He asks how that can be done.

Bohn replies, said they would still have the figurative position and still can execute the duties and responsibilities as prescribed by the law. The change is to bring their current practices and bring the law into a duty.

Leann Bertsch, Director of the Department of Corrections and Rehabilitation – She tells of a performance audit done in 2004 in the Dept. of Correction and some of the recommendations from that audit have not yet been implemented. She explains how the department went through reorganization. Due to an audit they have made changes and made more efficient use of different units, and departments. One of the recommendations was that the director of the division of prisons should not also serve as the warden because of conflict. The audit also looked at how they managed inmates between the division of field services and the division of prisons. This meshed how they managed the adult offenders.

She said bill #2122 cleans up some of the language, only when it refers to the pardon and parole board do you actually see the division of parole and probation anywhere in law. The authorizing language in the Dept. Corrections really refers to two major divisions, the division of juvenile services and the division of adult services. All the major assets that need to function across the dept. are under the director of administration.

Senator Fiebiger - asks how she envisions the practical piece of this being implemented, how will it differ from what is being done now.

Bertsch – States that day to day operations will not change at all. Pat Bohn is the deputy clerk of the parole board at this time and he handles the bulk of the work.



My name is Pat Bohn and I am the Deputy Director for Transitional Planning Services for the North Dakota Department of Corrections and Rehabilitation (DOCR). I serve as the deputy clerk for the North Dakota Parole Board, provide administrative support to the Pardon Advisory Board and I am here to testify in support of Senate Bill 2122.

Senate Bill 2122 proposes to place the responsibility for the clerking duties for the parole board and pardon advisory board with the director of the department of corrections and rehabilitation. During the Fall of 2007, the DOCR was reorganized, the Prisons and Field Services Divisions were disbanded and nine work units were created under the umbrella of the DOCR-Division of Adult Services. In our current organizational structure, we no longer have a director of the division of parole and probation. Parole and Probation Services are now managed by a deputy director and the clerk duties for either board do not fall under that person's duties. Our intention is bring these responsibilities under the authority of the director of the DOCR. This will allow the director to assign the execution of these responsibilities to the work unit within the DOCR that is best suited to meet the needs of either board and execute the boards' orders, regardless of the organizational structure.

The last section of the bill, Section 8, merely updates the language to be in line with current practices. Any legal transcript created under this section pertaining to an offender sentenced to the legal or physical custody of the DOCR will go to the DOCR for distribution and not just parole and probation. The legal information contained in the transcript may have some implications for inmates as well as parolees or probationers. This change will direct the information to the correct source and encompass all offenders under the authority of the DOCR.

In closing, we have spoke to the chairpersons of both the parole board and pardon advisory board and they both support the proposed changes presented in this bill as does the DOCR.

Senate Bill 2122 proposes to place the responsibility for the clerking duties for the parole board and pardon advisory board with the director of the department of corrections and rehabilitation. During the Fall of 2007, the DOCR was reorganized, the Prisons and Field Services Divisions were disbanded and nine work units were created under the umbrella of the DOCR-Division of Adult Services. In our current organizational structure, we no longer have a director of the division of parole and probation, although we have retained a person in that capacity (Warren Emmer) in order to continue to comply with the law. He then designated me as the deputy clerk. Parole and Probation Services was established in the reorganization to manage core community parole and probation functions but the clerking duties for either board do not fall under the duties of Parole and Probation Services. Our intention with the proposed changes in the law is to bring these responsibilities under the authority of the director of the DOCR. This will allow the director to assign the execution of these responsibilities to the work unit within the DOCR that is best suited to meet the needs of either board and execute the boards' orders, regardless of the organizational structure.

The last section of the bill, Section 8, merely updates the language to be in line with current practices. Any legal transcript created under this section pertaining to an offender sentenced to the legal or physical custody of the DOCR will go to the DOCR for distribution and not just parole and probation. The legal information contained in the transcript may have some implications for inmates as well as parolees or probationers. This change will direct the information to the correct source and encompass all offenders under the authority of the DOCR.
