Attendance was taken and all members are present.

Kelly Schmidt: North Dakota State Treasurer (see attached testimony #1)

Senator Nelson: Concerned about audit problems. What does the auditor think about putting

off to the next payment that you make to that entity?

Kelly Schmidt: When the bill submitted in 2005 session we should have had it say may. We

are trying to bring cost effective measures with the best of our ability.

Senator Nelson: On the other side, is it fair to the consumers to wait for the money?

Kelly Schmidt: These are not consumers rather political subdivisions and to them it makes no

difference.

Senator Horne: The correction would be made soon, but not precisely at the time that it is

discovered.

Kelly Schmidt: That is correct. Anything under \$50

Senator Horne: What is the break off point?

Kelly Schmidt: It depends on the distribution. For the most part \$50-\$100 being the threshold.

Senator Nelson: Who or what is the Bond Market Foundation?

**Kelly Schmidt**: Nonprofit 501c3 organization developed after September 11, 2001. Developed in co-op with financial firms to help folks deal with the crisis and have a safe place to learn jargon and details before they go to a broker.

**Senator Nelson**: Were there other options or BMF the only one and have they been endorsed by any state agency?

**Kelly Schmidt**: The National Association of State Treasurers Foundation is particular on what we pair with. So we have looked and declined several partnerships through our clearinghouse that doesn't meet our criteria.

**Senator Neison**: I noticed that the state seal was on the left hand side of the website, and that implies state approval.

**Kelly Schmidt**: We sought approval from the Secretary of State. We have a letter stating that we are in compliance with state law.

**Senator Horne**: Doesn't the state securities office do financial education promotions? Is this in competition with that?

**Kelly Schmidt**: The security commission gives education to the educators. The information that we provide is for the people of the state. I also work with ND jumpstart collation & we have started a clearinghouse here and if we can bring tools to the state without cost, this website that is on our link, we have spent no dollars, on the development. If we can bring tools to our constituents I feel it is in our best interest.

**Senator Dever**: The security commissioner education involves personal finance or is that more stock market investments?

**Kelly Schmidt**: To my knowledge that is correct. And we work in co-op with the ND jumpstart collation which is an organization of non profit, government, non government and educational entities that come together for the betterment of financial literacy statewide.

**Senator Dever**: Are you prevented from doing this now? Is the purpose of this being here to make a policy statement?

Kelly Schmidt: I am not prevented from doing it because the National Association of State

Treasurers on a national level provides this information and works through financial literacy so
as a state treasurer and a member of the National Association of State Treasurers I can
continue to work with the programs. However I thought it was important to bring transparency
and to make sure that we include the information if we are working with it.

**Senator Dever**: Am I correct that the tax commissioner's office that there is a liability less than \$5 they don't worry about it?

Kelly Schmidt: I don't know

Senator Nelson: We have a contract with vanguard

Kelly Schmidt: The Bank of ND has a contract with vanguard to facilitate our 529 plan.

**Senator Cook**: Am I to understand the auditor giged you because you did not correct it with a special check?

**Kelly Schmidt**: Mr. Chairman I would like my deputy to address that. He worked with the audit and he has worked with some of the issues.

Lawrence Hopkins: for the record I am Lawrence Hopkins, Deputy State Treasurer. What we want is the flexibility and freedom to be cost efficient and effective. The tax department does have a \$5 threshold and this would allow us to do that.

**Senator Dever**: Other questions.

Senator Horne: This would not require additional staff?

Kelly Schmidt: Yes that is correct; we are requesting no staff and no additional dollars.

Gordy Smith: Senator Honre stopped by and asked us to take a look at this bill. The only concern we have is on the last page. Using the work "may" typically that means that the agency has a choice or whether they are going to refund these. Most of them have a computer formula the problem is that if the law changes so a distribution changes when they went in and make a computer change there has been mistake there? Some information they get from other department and sometimes there have been mistakes there. I guess in saying "may correct" the concern I have is as lawmakers you deserve the right to have some assurance that in fact it has been distributed in that manner according to that political subdivisions especially some of the smaller school districts and cities. Our concern is that they "may" makes these adjustments if the issue is materiality there certainly is language that can be put in the tax department. If that is a concern it is legitimate. What criteria would they use in deciding correcting one verses the other?

Senator Cook: Has there ever been an error that has not eventually been corrected.

Gordy Smith: To my knowledge no.

Senator Cook: Is there a time frame for how quick it has to be corrected?

Gordy Smith: To my knowledge no. And I think that is a valid concern; right now there is nothing in the quota. I have no problem if they want to wait to the next distribution to make it better than try and generate checks if they found something. I don't think that is a bad idea either.

**Senator Cook**: I think one of things that they want to accomplish with the word 'May' was to set that minimum threshold like \$5 or something like that. I would think in that position that there is no motive not to correct it if you are going to be a state treasurer to get the money out and do it in the right and efficient manner. Maybe the best thing is for the auditor's office and treasurer to sit down and have a conversation.

**Senator Dever**: The impression that I got yesterday in the testimony is the treasurer is that their only interest is having the flexibility in dealing with the smaller amounts and they would set the amounts so for us to adjust it would be for us to set the amounts.

**Senator Cook**: The motive here is if the treasurer did not correct something the agency that got shorted is going to have a lot of people listen to their concern. I would be happy if there was another way accomplish what the intent of bill and find some language that we could look at.

Gordy Smith: We would certainly are very happy to work with them to try and come up with something. The only thing is that a person has to take a look at how would a city find out that there was something that was not distributed correctly. Because presently the way it has been done is that the auditor's office did the audit then we found problems and worked with the treasurer's office to change what is necessary to make sure. There are a lot of these distributions and we don't check everyone every year we try and rotate them.

But we want to be able to establish a policy that

SB 2135 amends section 54-11-01 of the ND Century Code relating to the duties of the Office of State Treasurer.

The majority of the changes relating to this bill are a direct result of the changes we have experienced in technology and also the implementation of our central accounting system...namely PeopleSoft.

There have been some additions added which bring this section into the uniform wording of Century Code.

The exception of this would be Page 3, Line 17. In order to provide cost efficiency to the correction process, we have included "may". We have found there are many times when a correction must be made which costs the state more in processing than the cost of the refund. We would like to have the flexibility to implement a policy relating to the threshold of repayment based on the each tax distribution we process.

The remaining change is the inclusion which would allow the Office of State Treasurer to promote and access tools relating to financial literacy.

The exception of this would be Page 3, Line 17. We have found there are many times when a correction must be made which costs the state more in processing than the cost of the refund. The original bill included "may"; however, the Senate amendments found in the engrossed bill gave us the discretion to address insignificant amounts and the opportunity to address the issue with an agency policy.
