Chairman DeKrey: We will open the hearing on SB 2156.

Rep. Larry Klemin: Co-Sponsor, support, explained the bill. This deals with probate of an estate. If a person is appointed as Personal Representative in the primary state, that person also needs to be the personal representative in any other state in order to handle that state's property, etc. for that decedent. The procedure is basically a formality. If you are appointed in SD, you probably don't have a problem appointing that same person in ND, but we have to be sure in ND, that he really was appointed in SD. Right now we go through what we call an authentication process. There is federal law on how you do authentication. Basically we're trying to have somebody in SD tell us affirmatively that the person who was appointed as PR in SD really was appointed. So authentication is kind of a convoluted procedure where the clerk of court would sign off on something and the district court judge would sign off on something, and the clerk of court would authenticate that that was the signature of the judge and the judge would authenticate that that was the signature of the clerk, and then bring that to ND and we accept that as proof that he was the PR in that other state, so we'll appoint him in this state.

This bill tries to simplify that process to allow also a certified copies of the person's appointment, so we don't have to go through this convoluted authentification procedure to get

the authenticated copies of the person's appointment in another state. All we have to do is

provide a certified copy and a certified copy is something that you go to the Clerk of Court,

they put their stamp on it, certify that this is the exact copy of the original that was filed in the

other state. We file it here, and then you don't have to track down people that have to say that

this is so-and-so's signature. That will give us another option.

Rep. Koppelman: I don't understand the veracity of the authenticated copy, is there any

reason why a certified copy wouldn't suffice. Why would we ask for an authenticated copy in

the beginning?

Rep. Klemin: I'm not sure, this is now part of the Uniform Law and they must have had some

reason in the past for it. This probably goes back to 1969 when the Uniform Probate Code

was first adopted and readopted into here in ND in 1973.

Chairman DeKrey: Thank you. Further testimony in support.

Sen. Stan Lyson: Sponsor, support. Certified copies are easier to obtain and less hassle. In

MN they need two notaries for each statement. We don't need a notary for certified copies.

Ch. DeKrey: Thank you. Further testimony in support. Testimony in opposition. We will

close the hearing. What are the committee's wishes in regard to SB 2156?

Rep. Koppelman: I move a Do Pass.

Rep. Delmore: Second.
