Chairman called the committee to order, the clerk called the roll,

Senator Ryan Taylor: Senator Ryan Taylor, district 7, if it would be helpful I will have Anita Thomas from legislative council do a quick walk through on the bill and some of it's technical aspects.

Anita Thomas: This bill has one purpose and that is to raise per diem for agricultural boards from \$75 to \$135 a day. The reason Senator Taylor and I are here is explain some of how this bill connects with the agricultural title rewrite. You are going see some things that look very familiar. Sec 1 for instance, normal heading, as you go through the bill you will see references to 1025, the title rewrite does not pass and then you are going to see amendments of sections that have not been enacted yet. When we did the title rewrite we went into 13 different chapters of the code. When we amend sections of the code that 1025 has already touched we have to figure out how to intersect them. If you start with section 1 this is a normal section that is in no way impacted by the title rewrite and it pertains to the state fair board. Section 2, is normal and pertains to the state board of agriculture research. Section 3 pertains to the seed commission. Section 4 seed arbitration board, and then we get to section 5 where sections intersect in rewrite and what we do at this point is pretend that the title rewrite that bill 1025



does not exist. These are the amendments under any circumstances. Section 5 has to do with the potato council. Sec 6 refers to the oil feed council, section 7, dry beans, section 8 barley, section 9 soy beans, section 10 corn council, section11 dry pea and lentil council, section 12 is a normal one that refers to APUK. Section 13 milk marketing board, section 14 soil conservation committee, section 15 dairy promo commission, section 16 wheat, section 17 beef commission. Section 18, we are going to assume that the title rewrite does pass, we are saying that if the title re write passes, we are amending what is already in 1025. That is why you are seeing that this is chapter 4.1 it is done as an amendment to 1025 for 2 reasons. 1) So that we don't have a conflict and 2) so that you can actually see what the proposed changes are. I know that there has been a lot of confusion in a lot of the other committees about 1025 and if we have an issue with a later passed bill and I can assure you that we do not; that is why we do the amendment section, that's why that heading from section 18, 19, and on from several others looks a little bit differently than you would normally see.

Section 18 has to do with the barley council, section 19 is beef.

When did title rewrite told not to change policy. Many of the groups came up during the course of the interim and said that they would like their per diem fees raised from \$75 to \$135 a day. Senator Flakoll who sponsored the title rewrites last session and interim Chairman Representative Muller said no that was not intent throw a separate bill in. That is why this bill is in front of you today. But if you chose to pass this bill the law would be at \$135. Section 20 is corn; section 21 is the dairy, section 22 deals with dry bean, sec 23 oil seeds, section 24 pea and lentil. Section 25 potato council, section 26 soybeans, section 27 wheat, section 28 pertaining to the agriculture mediation service, that was not part of the title rewrite.

Section 29 Board of Animal Health and Section 30 Board of Appraisers; when we did title rewrite, did not change legislative policy and we changed the dollar amount, some of the



Senator Ohelke: Board of Appraisers, are they appraising animals or land?

Anita Thomas: If an animal is diseased and it is condemned by the Board of Animal Health there is an element of remuneration and that is what this board is charged with doing.

Senator Dever: Fiscal note says it is from other funds. Can we assume with all of these that it is from membership fees?

Anita Thomas: I know it is on the commodity groups I have not looked at fiscal note in regards to Board of Appraisals.

Senator Dever: Do you know if it was the intention, at setting this at \$135, to be consistent with legislative pay?

Anita Thomas: Yes, tie the amount to increasing skill get a large fiscal note.

Ryan Taylor: Once again, Ryan Taylor for District 7. I introduced 2252; I was Vice Chairman of the interim agriculture committee that was responsible for doing the Ag Century Code rewrite over the last year and a half. We were not going to make big changes in re write and changing the compensation would have been a substantial change. This has gone on for a number of years as you can see, the language in bill previously was \$75 so it has been some time since this was adjusted. It is my understanding is change was made when my predecessor Ken Solberg I think brought it up a number of years ago and at that time legislative pay was \$75 so the Ag boards were brought up at that time to match legislative pay.

Not a huge outcry for pay raise generally these are humble folks and they are not of the nature

to complain. But I know from experience, maybe with the folks that lead these groups that pay

is an issue. I employ a few folks on our ranch back home and even when I am down here at the legislature, I think that the key to personally be able to have help is to give a raise before they ask for it. I think that fair compensation is a key to keeping good help around. Just like the legislature I think we want the best folks possible on these boards, not just the ones that can afford it, but they want to. Just like us being way from our own businesses we know we have better things to do and compensation will help take up the slack. Similar to what we do, can be tedious at times. Just as tired at the end of the day of meetings. I think it's fair to say if our time is worth \$135 a day then their time is worth \$135 a day. One thing that was given to me by a lobbyist; see attached handout #1.

Senator Horne: I haven't served on any boards, one question, do these folks have legal authority to set policy?

Senator Taylor: They do have legal authority to make legal policy. As they direct dollars towards promotion, research, and other things they have a fair amount of authority. They also have their own election process.

Senator Dever: Authority is spelled out in Century Code that is what the rewrite does **Senator Horne**: They have a certain amount of responsibility that comes with their responsibility.

Senator Dever: Fiscal notes, 2nd page, 3 of them have 0 paid members and 0 times met during biennium and this would represent a 0 increase in their compensation.

Senator Taylor: 1st page of the fiscal note sub section B, it says no impact on potato council which is one of those that are paid less. It is also not impacted because the board meets as part of regional group. Pay comes from another entity. Need to do more thinking about potato council.

Senator Dever: Raises questions about existence of board.

Senator Taylor: I can talk to Jeff and get answer and bring back to committee.

Scott Rising: See attached testimony #2.

Senator Horne: The commissions listed in blue (attachment #1) are check off organizations?

Does the legislature cap these at \$60 or can this organization raise it on their own?

Scott Rising: The jest of legislation currently they are capped at \$75 rate. The legislation suggests that they be given the authority not exceed \$130 rate, but those council members are not forced into that if they chose to go lower than \$75 then they can.

Senator Horne: Even though they are check off they are governed by state law?

Scott Rising: Yes sir

Senator Dever: Is it safe to assume that this bill would not create a hardship with budget constraints.

Scott Rising: I think that is true simply by the fact that they are allowed to adjust their rates according to what their budget can support. They can't exceed \$135 but they can do less.

Senator Dever: Increasing from \$75 to \$135 is not a problem.

Scott Rising: No sir.

Doug Goehring: I am Doug Goehring, I serve on North Dakota Soybean Council. We are the check off organization, one of the ones listed on sheet, I have not written prepared testimony. There are a few issues for our producers that exist in the state of North Dakota and how we operate and function on boards; one is not only recruiting but retaining help. Over a lot of years we have a lot of producers that say it's tougher and tougher to volunteer time. When hired man cost \$120 to \$160 a day with payroll taxes. During the winter, there are shorter days, not as much time outside working. As of this morning I felt it was important to be here, I had to hire a truck to haul corn this morning and that cost me \$400 so it is kind of going backwards. But it is in service of industry in both the state and nation. There is statute on how we are governed in

the state, we would like to see that changed to allow our producers and members to work without hardship. Concerning earlier question, there is a liability when working with these boards.

Senator Nelson: I only see one soy bean on the list.

Doug Goehring: Growers are a nonprofit outside organization. The council is national check off organization but because there is statue there is language in the state of North Dakota and Century Code that refer to a check off. It is strange that operate under the guidelines, to some degree under the state, but we are a national check off.

Senator Nelson: But they can be part of your group.

Doug Goehring: Yes, work with them to carry out some work.

Louis Arnold: My name is Louis Arnold and I am presently Chairman of North Dakota Barley council, I am in favor of the increase. I guess one of the reasons that I would like to present to you is that if you look at me I am pretty gray haired. Spent 2 complete terms on council, in order to get younger people we need to compensate. Business is business and in order to attract young men we need to pay them. Barley council is in favor.

Senator Dever: Anyone else to speak for 2242?

Tom Lilja: Not to repeat a lot of things our council did have an incident member hit a deer last year and things add up. Key to get younger people involved. ND corn growers and ND corn council both stand in support of 2242.

Senator Dever: Any questions? Thank you Tom. \$135 a day does not detract from volunteer of boards

Minutes:

Senator Taylor, Sponsor: The per diem compensation with a number of agricultural organizations in the state is what we are talking about here. Half are check-off funded and the other half are state boards that relate to agriculture. The per diems are currently set at \$75 maximum per day for the people that serve on those boards. I don't serve on those boards so there is nothing in this for me. This is something that had not been changed for 15 years. I can't say there was a cry from these people for an increase. They are pretty humble and don't complain a lot. I try to pay my employees as fair as I can. I try to give a raise before they ask for it if you want to retain good employees. These jobs are not physical work but are demanding mentally and intellectually. It is similar to our work. Many would rather be home on the tractor. They could be losing money back home. If HB 1025 does pass, this language would plug right in. If it doesn't pass, it would go back to the original titles. The fiscal note funds are coming from the check-off organizations so it is not an appropriation from the general fund.

Representative Belter: Some places it says \$135 and some places it says "not to exceed \$135."

Senator Taylor: The "not to exceed" language is on the check-off funded organizations because those are their own funds. We give them the authority to set what they want up to

\$135. With the state boards they need a fixed number so now it is fixed at \$135.

Representative Kingsbury: Looking at the Dairy Promotion Commission, it is zero for the check-off. The Milk Marketing Board comes through the legislature. Why is that different?

Senator Taylor: The Dairy Commission also works with federal funds. The Milk Marketing

Board is a state board.

Representative Rust: All this bill does is change the compensation from \$75 to \$135? There is nothing else changed.

Senator Taylor: That is correct.

Scott Rising, ND Soybean Growers Assn.: The compensation periods are limited to the actual times at meetings and events. It does not include preparation time associated with many of the issues. (Written testimony attached #1a) (Attachment #1b)

Representative Rust: As a school superintendent, I served on a board that met during the week. I was not allowed to collect any money because my home school district was paying my salary that day. Is that true with any of these individuals? Are they collecting a salary that day from an organization? Would that be a double dip?

Scott Rising: From the commodity group standpoint, on the Soybean Council there was one person from the Dept. of Ag and was not compensated like the rest of the folks. There are some connected with the Federal Government which works the same way. To my knowledge, state employees or employees that work for other entities, other than farmers, on the Soybean council are compensated by their own organization. The farmer is compensated.

Representative Mueller: Do you think a change in pay will increase the pool of good participants in these organizations?

Scott Rising: I don't know. I think you are born with a "to serve" gene. There is a shrinking pool of people and their time has more of a demand. Agriculture has changed. The farmer needs to be scheduled. It may cost \$400 to hire someone else to drive the truck the day there is a meeting.

Deana Wiese, ND Ag. Coalition Administrator: The cost to be away from the operation often exceeds the pay for the meeting. (Written testimony attached #2)

Representative Froelich: Some of these organizations are on a very limited budget. If we increase the salary, are they going to come back the next legislative session and ask for an increase in the check-off?

Deana Wiese: There hasn't been any discussion on that.

Representative Vig: 1 look at the list and the Dry Bean Council meets 12 times, Oil Seed meets 4 times, Barley Council meets 72 times, Wheat Commission meets 96 times in a biennium. Why do some meet a lot and some are under 20 meetings?

Deana Wiese: I believe the organizations set their meetings.

Tom Lilja, ND Corn Growers: Expenses in attending meetings do add up.

The Corn Council meets 3-4 times a year but we have a lot of conference calls throughout the year. That might make the difference in the number of meetings. I think this increase in compensation would help in retention of board members. We do have a couple of industry representatives that serve on our board that are grain buyers. We do reimburse them mileage for those meetings but we do not give them a per diem because they are on a payroll.

Representative Schatz: This is an 80% raise. That seems like quite a bit. Are we going a little too big?

Tom Lilja: These members do make some good decisions. They work with million dollar budgets. For the time they are putting in, it is justified.

Vice Chairman Brandenburg: I'm looking at the number of paid members for Corn

Utilization Council. Can you explain why there are 30 members?

Tom Lilja: The Corn Growers Board and the Corn Utilization Council meet together. But that is only three times a year. We have five different committees with six people on them. The growers do have some input in the decisions.

Vice Chairman Brandenburg: So there aren't actually 30 board members. There are seven board members. You've asked these other people to come in and give reports.

Tom Lilja: Correct. It works well when you have a smaller committee that focuses on a project. We have a committee for research, for planning, for finance, etc.

Representative Rust: If you have an hour conference call, is that a meeting and \$135?

Tom Lilja: I have to write the minutes but it is not a meeting. They are not reimbursed for that.

Representative Vig: Yesterday we had an increase on the Barley check off. We asked what the money is spent on—is it research or staff? We are spending a lot of money on staff salary here. We were promised research.

Dan Wogsland, Executive Director, ND Grain Growers: This increase would help to recruit and retain board members. In answer to the question, are we going to see increases in the check off to pay these new board fees? When all of the commodity groups come before the legislature at the beginning of the session and explain what they are taking those funds for, that is when you can delve into what went for salaries or the places that you think are important. I don't think anyone is going to come in front of the legislature and say we paid this on the basis of giving ourselves a raise. I don't think anyone will buy it. That is the beauty of the oversight of the legislature. I think the money need to go to research. What I can explain on the 96 meetings of the Wheat Commission, individuals are going on trade missions, etc.

Representative Vig: Are the members paid when they go on the trade missions?

Dan Wogsland: I don't know.

Vice Chairman Brandenburg: I won't disagree that this wage is probably not adequate. But the members out there are just going to go wild if we increase it this high. Would a staircase type of increase be more appropriate?

Dan Wogsland: That is the beauty of this language which gives these boards and commissions the opportunity to go "up to \$135." You have to have the support of the producers.

Opposing: None

Chairman Johnson: Closed the hearing.

Representative Froelich: I concur with Representative Belter. Some of the wording could be changed to "may not exceed." It is not on all places. This would make it uniform.

Vice Chairman Brandenburg: I don't deny that this increase could be justified. But we have to think of some of the people that aren't here. Maybe we should deal with some of these wages in a staircase type of effect.

Representative Belter: I don't have a problem with the way the bill is written. We just need a clarification on some of the differences.

Chairman Johnson: I felt that way too, to give the commodity groups the opportunity to go "up to" that level.

Vice Chairman Brandenburg: Then they all say, "The legislature let us do this."

Representative Mueller: We let them, but they are the ones actually choosing to do it. Overall I think it is a pretty good piece of legislation.

Representative Schatz: I agree with Representative Brandenburg. I'd like to see a step-bystep method and then see how many go up to the maximum. It is too bad this wasn't done

over the last 10 years rather than all of a sudden. An 80% to 100% increase is hard to sell on the floor.

Representative Kingsbury: The down side of this is, you might have to pay for elections for runoffs to get on these boards.

Chairman Johnson: I still feel that by giving them the \$135 option, they are going to have to answer to their constituents and growers more than the legislature is going to have to answer. That is commodity dollars not state appropriation dollars.

Representative Froelich: Moved Do Pass.

Representative Kingsbury: Seconded.

Representative Uglem: A lot of these board members travel long distances and leave their normal business just like we do here. I feel it is justified. I don't think we'll hear a big squabble from our commodity groups.

Representative Kingsbury: About 15 years back when my husband was on the Bank of ND board sometimes we'd get up at 4:00 a.m. and drive out for the meeting.

Vice Chairman Brandenburg: Some of these boards you do it for a position of honor. You do it not for the money but because you want to be on the board. You want to have an impact on the industry that you are a part of.

Chm. Svedjan: SB 2242 comes from House Agriculture and deals with Ag. board member payment increases.

Rep. Dennis Johnson approached the podium to explain SB 2242. It is the commodity group increases. They want to go to \$135 cap from their present levels. There was no opposition to this bill. There is a fiscal note, but it is back to the commodity groups. We felt that it is up to the boards. If they want to increase to \$135, they will have to answer to their membership.

Chm. Svedjan: The increases are disparate. Some are at \$75 going up to \$135.

Rep. Johnson: It would be possible to go up to that level, but we just raised **the cap** to \$135. They can put it where they want to. It gives them the ability to go to \$135 if they choose. That way they wouldn't have to come back each time they wanted a change. They would need to answer to their membership.

Chm. Svedjan: The impacts are noted on the back of the Fiscal Note, the \$66,100 analysis.

That appears to be a loose figure in that there is no way of knowing who will go where.

Rep. Johnson: That's correct. There are twelve commodity groups, and it would be at the discretion of each group board and the membership.

Rep. Metcalf moved a Do Pass on SB 2242.

Rep. Meyer seconded the motion.

Rep. Meyer: Why is there no impact to the Beef Commission and the Potato Council?

Rep. Johnson: It explains on the fiscal note that the bill will have no impact on the Beef Commission and the Potato Council because they are both agencies are currently paying board members an amount per day less than the current maximum allowed.

Rep. Meyer: But isn't that what the bill is designed to do?

Rep. Johnson: It is. I can't answer that.

Rep. Berg: Each board can decide what they want to pay their members. It means that they have been below that amount, and they will remain at the amount that they have.

Rep. Johnson: Not all the groups came in asking for this. Some may not participate.

Rep. Delzer: Why is the State Fair Association in this? It's not a commodity group.

Chm. Svedjan: That's a good question. Everything else relates to commodities.

Rep. Johnson: We didn't have any discussion about that.

Rep. Wald: The Credit Review Board is not a commodity group or the State Soil Conservation committee.

Rep. Delzer: When you read these bills, we are setting at \$135. Some are set 'not to exceed \$135.' There's more than just allowing Boards to go up.

is up to each board. Is that correct? Or does this language say that it has to be \$135?

Roxanne Woeste: It depends on how the sections are worded. In some sections it says, 'that

the board members are entitled to receive \$135'. That would be their pay. In other sections it

says 'may not exceed'. Then that would be the upper limit. The sections are worded

differently. It depends on how the sections are currently worded.

Chm. Svedjan: There are several, "May not exceeds".

Rep. Berg: I would prefer just having that as a cap throughout here.

Rep. Johnson: It was our understanding that it would not exceed the \$135.

Chm. Svedjan: There is a perception issue. Where it says 'they are entitled to' is very

different than 'not to exceed'. Did the commodity groups all come in and ask for this?

Rep. Johnson: It was the commodity groups that came in. When you read through here it is

the commodity groups that has the language 'may not exceed \$135'.

Chm. Svedjan: They en masse asked for this change?

from the bill, would that solve Rep. Delzer's issue?

Rep. Delzer: I don't have a terrible issue. We've come through and raised them in the past. I

think most of these that say 'are entitled to receive' answer to state agencies. Whether we

want to give them the authority to set that, I don't know.

Rep. Berg: Some of these are appointees of the Governor. I don't think it's appropriate for

them to make the decision on what their compensation should be. It probably is a legislative

decision. I started to think about the commodity groups, they go out in their membership and

elect them. They are not appointed. The motion I made may be inappropriate. The cases

where it sets it are probably appointing the members.

Rep. Berg: I would like to withdraw my amendment.


