Chairman Klein opened the hearing on SB 2285, all members present.

Senator Mathern from District 11 in Fargo introduced SB 2285. He testified to the privilege of traveling through ND and visiting all 4 reservations. This bill directs the Department of Commerce to develop a memorandum to establish offices pertaining to community services, economic develop and finance, tourism, and workforce development, and at the same time, seeking tribal colleges' influences. Senator Mathern discussed figures. (See attachment #1) Senator Andrist: I represent a small part of Mountrail County, more directly the Three Affiliated Tribes, and throughout this oil boom, why has the unemployment rate on the reservations remained so high.

**Senator Mathern**: You hit the nail on the head. We have programs through the Commerce Dept. designed to find workers who FIT the job openings, we are simply seeing the need for this service on the reservation. The Tribal Colleges have done a great job of educating people, the resources of the Commerce Dept. need to come to the reservation and help put these people to work.

Senator Wanzek: Would these actually be affiliates of the Dept. of Commerce.

**Senator Mathern** Yes, we take the resources to accomplish this and it would be up to the Tribes and Dept. of Commerce.

**Senator Potter:** Will these satellite offices serve all the people of the region, all the businesses of the region, or strictly Native American's?

**Senator Mathern** This isn't a reservation boundary issue. In this state we have 2 issues, finding workers and keeping our youth. On these reservations, we have the answers to both. Let's stop looking at these places and people as problems, let's see those people and lands as the resources we need.

**Senator Nodland:** I was a County Commissioner and know well the problems you are talking about, however when we lost good employees to the oil fields, there were those jobs they vacated and we had hard time filling them. Is this more a social issue?

Senator Mathern Public policy for almost 200 years was to destroy these peoples' way of life. That policy changed to reflect respect of these Nations and these people. But it wasn't until recently, within your life, that these people were even granted the right to vote. Their development takes a long-time. The time it takes to solve a problem is about the time it took to create the problem. In front of these social problems is a need for a job and income to support their family.

Representative Boucher, district 9, testified in support of SB 2285. I want to address the very basic questions. First of all the bill would establish outreach to the reservations through the Dept. of Commerce. To better serve the people of the reservations and North Dakota, we have developed Regional Human Services, Corrections, Parole & Probation, and Juvenile Services. Half of the Native Americans live off the reservations. Turtle Mountain Reservation has 13K.

The labor and ability is there and the connection needs to be made to help. I must point out to you that many people believe Indian people are not trained or skilled workers. This is simply

not true. Many are skilled and trained. In our county, there are well over 100 Native American owned businesses in Rolette County. They have started a bank, the first in the country. The success comes from people being connected. When you look at this objectively, they contribute to the economy of North Dakota. The connections are there and need to be addressed.

**Senator Potter**: Why not just put the individual cities instead of the reservation. The implications might be that the office would only help "Indian's" and not "Non-Indian's". As there is Indians that live off the reservation, there are non-Indians that live on the reservation.

Senator Horne: What role does the Federal Government have in this?

**Representative Boucher**: The individual entities would be better informed to answer that question for you. Obviously they should be actively engaged

Senator Marcellais: District 9, and Turtle Mountain Band of Chippewa Tribal Chairman, testified in support of SB 2285. (See attachment #2)

**Senator Potter** What's the reason to create an MOU?

**Senator Marcellais**: There may be 4 different agreements because of each different reservation. As long as there is an office there, there is an outreach.

Chairman Klein: We do lots of things from Bismarck, for example, would it be necessary to establish an on-sight office. Are you aware of the existing relationships with the workforce?

Senator Marcellais: I just was elected so I don't know the history or the relationships from the past.

Senator Andrist: Is this a social or problem I don't understand? It seems we have the jobs there.

Senator Marcellais: There is training for careers.

**Senator Wanzek:** Was there discussion about initiatives to engage with our own people and the people on the reservations?

Senator Marcellais I don't recall any discussion, no.

Senator Potter: Isn't the aim of this bill to create jobs in these sovereign nations.

Chairman Klein: Our families move to where the jobs are. That's the difficult part, there is a culture to this.

Senator Nodland: We need to educate our people, we are all related.

Chairman Klein: Has there been a relationship amongst the tribes?

Shane Goettle: Commissioner of the North Dakota Dept. of Commerce testified neutral on SB 2285. (See attachment#3)

Senator Andrist: Are there any resources that you wish you had that you do not have now?

**Shane Goettle:** I think it is a matter of effective coordination with the tribes.

**Senator Andrist:** Do you have any ideas of how we can be more effective finding people to fill the jobs that are currently available?

Shane Goettle: The training is there, and maybe the work is there and transportation is not.

Chairman Klein: Across the state, we have developers. How does it relate to what's currently

on the reservation.

**Senator Potter:** How do you feel about these informational data with regards to the unemployment issues on the reservation?

Shane Goettle: I don't have any material prepared to dispute the figures handed out earlier. Whatever they are, they need to be addressed because whether it 20% or 60%, it's too high. We do understand that if you are not actively looking for a job, you are not classified as

"unemployed".

This bill would require the Department of Commerce to operate satellite offices on each of the Indian reservations. Each satellite office is required to have a staff member from each of the Department's four divisions.

This bill creates a requirement that the Department of Commerce establish satellite offices on each of the Indian Reservations. These satellite offices are required to include a staff member from each of the Department's four divisions. The cost includes the salary and benefits of each of the required staff members, as well as the operating costs.

This bill would require satellite offices staffed with four people on each of the Indian reservations. We estimate that each employee would cost \$8,009 per month including salary & benefits and operating costs such as rent, travel, phones, equipment, and supplies. This equates to \$32,036 in monthly expenses per office for a total of \$768,864 per office for the biennium. Assuming this bill only applies to the four primary Indian reservations in the state, the total biennial cost would be \$3,075,456. If this bill were to include the Lake Traverse Indian Reservation, which includes a small portion in North Dakota, the total biennial cost would be \$3,844,320.

Chairman Klein, members of the IBL Committee, for the record is my name is Richard Marcellais, Senator from District 9, Rolette County and Turtle Mountain Band of Chippewa Tribal Chairman.

Senate Bill 2285 would set-up satellite offices on the Indian reservations with a memorandum of understanding to assist with the economic development with the following divisions as part of the North Dakota Department of Commerce:

# **Division of Economic Development and Finance:**

As Governor John Hoeven said "We have been working hard to build a strong, responsive business climate in North Dakota to provide emerging and expanding businesses with the resources they need to grow and succeed in our state. We've simplified our tax system and created new tax incentives, streamlined regulatory processes, developed flexible financing programs, and readied our workforce for the high demand careers of the future"

# **Division of Community Services (DCS):**

Goal is to provide the Native Americans of North Dakota with effective, efficient and customer oriented administration of federal and state programs for community development, energy efficiency, housing and self sufficiency. All of the programs and services are geared to improving the quality of

life for the citizens of North Dakota and to making the State a great place in which to live, work and be in business.

# **Division of Tourism:**

The Lakota Sioux words. Aho Mitakuye Oyasin "We are all related" ring true in North Dakota You'll often see us celebrating all the things from our heritage that make us different, as well as all things that make us alike. At our American Indian powwows, we dance in a circle that honors this interweaving of cultures and the beautiful land connecting us. At Scandinavian festivals we say "Ja, sure," to that and start dancing in circles too. Whatever your heritage, come join in our circle and celebrate with us.

# **Division of Workforce Development:**

The Workforce Division is responsible for monitoring local, regional, national workforce initiatives and the development and implementation of the states talent and intelligence coordination strategies. It's a goal to ensure the North Dakota employers have access to a skilled talent pool to meet their workforce needs, young people remain in the state for jobs and civic engagement and volunteerism expands in the state.

## SHANE GOETTLE - COMMISSIONER, ND DEPARTMENT OF COMMERCE

Mr. Chairman, members of the committee. Thank you for the opportunity to address you this morning with information to help you evaluate this bill.

I'll start today by stepping back a bit to describe the overall mission of the North Dakota Department of Commerce and then I'll outline how we are specifically working with local partners and businesses to help them accomplish this mission on our Indian Reservations.

## North Dakota Department of Commerce Mission

Our mission is straightforward. We lead North Dakota's efforts to attract, retain and expand wealth. Our work is clearly collaborative in nature. Commerce is now and always has been an assistant to locally driven economic and community development efforts.

We provide a wide variety of services – funding, technical assistance, lead generation, advertising, promotional assistance, workforce development, recruitment and training support – all of which are available to local partners to help them address specific challenges, to build their infrastructure and to grow their economy.

The model for the Department of Commerce and previously the Economic Development and Finance agency is to work with the locals, not to become the locals. This supports the philosophy that locally driven economic efforts best fit the local culture and climate, have the strongest support from local people and are the most likely to succeed.

The North Dakota Department of Commerce operates under the guidance of a strategic plan that is developed and reviewed regularly by all Commerce employees. It is the primary tool to direct the activities of Commerce. I provided an extensive report on progress toward our goals to a joint meeting of the Industry, Business and Labor committees yesterday and I would be pleased to provide copies of that report to any of you should you so desire it.

Four strategic priorities drive our work. Most of our work with the state's Indian Reservations focuses on our first strategic priority: Business, Community and Industry Development.

Our goal here is to deliver initiatives, programs and services that support local business, community, and industry growth. Please let me describe some of the ways the Department of Commerce has worked in partnership with our state's Indian reservations toward achieving this goal.



## INDUSTRY AND BUSINESS DEVELOPMENT:

In 2006, Commerce created the North Dakota American Indian Business Development Office which is focused on helping North Dakota's American Indian businesses leverage government procurement opportunities, access state and federal resources and facilitate partnerships between Indian and non-Indian businesses.

During the past two and a half years, this office has worked with 101 Native American businesses, helping them secure federal contracts worth \$65.4 million.

This office provides intense counseling to Native American firms throughout the entire state and sees a bright future for Native American businesses. In addition to continuing to build Native American firms, the American Indian Business Development Office will increase its efforts on up-and-coming Native American entrepreneurs who are looking to start their businesses or Native American firms requiring training to attract larger government contracts.

These second-tier companies and start-up companies require one-on-one assistance. Opportunities remain abundant on reservations due to continued high unemployment rates and the federal government's willingness to set aside contracts for these companies.

Business Developers in the Economic Development and Finance Division held numerous community visits at Three Affiliated Tribes, Turtle Mountain and Standing Rock in the last two years. The goal of these visits is to meet with existing business such as Northrop Grumman, Turtle Mountain Manufacturing, and Mandaree Enterprises to identify challenges or future growth plans that the state can support. We also meet with local and tribal leaders and economic development personnel to discuss new opportunities, such as wind development at Standing Rock, and to identify ways in which the state might support their efforts.

- ED&F Business developers have distributed 33 different requests for proposals to local
  partners on reservations in the last year and a half. These proposals are from a business
  that is requesting information about a location for a future business project and seeking
  information from communities about how they might meet their business needs.
- Additionally, we recently coordinated two company site visits to Belcourt and one to New Town. In 2005, NovaCTI located a call center operation in the DynaBand facility in Belcourt. Unfortunately, that company has since ceased operations there.

The Agriculture Products Utilization Commission has provided technical assistance and funding to several projects on the reservations in recent years.

This includes extensive organizational assistance for a commercial corn seed production project at Standing Rock where the tribe would produce some of the original indigenous corn varieties and sell them for seed.

APUC provided funding for the Ft. Berthold Cattle Relending project in New Town, Myers Meats in Parshall and the Standing Rock Equine Center.



The North Dakota Development Fund has supported a number of projects on the reservations over the years. These include:

- Turtle Mountain Manufacturing Company in Belcourt, which is going strong
- FACT in Fort Yates, which was funded in 1993 and no longer in business.
- And Dakota Medical Lab in Fort Totten, which was funded in 1996 and no longer in business
- The Development Fund has recently held meetings with Mandaree Enterprises in Mandaree and Skydance Casino in Belcourt regarding potential funding.

The North Dakota Trade Office has a great success story with Rolla-based Arrow-Tech Inc., a company they have worked with for about four years. This Native American-owned firm produces a full line of dosimeters and other radiation detection equipment. Arrow-Tech, which employs 23 people, is registered with the North Dakota Minority Contractors Association and the U.S. Department of Commerce Minority Business Development Agency as a Small-Disadvantaged Business.

In an effort to increase the company's export business, Arrow-Tech has participated in a state trade mission and export training courses. With assistance from the Trade Office, Arrow-Tech also has developed a business export strategy, signed an agreement with an overseas distributor and has incorporated export tax benefits that have saved the company money.

Arrow-Tech exported goods valued at \$600,000 in 2007 – about 30 percent of the company's total revenue. Arrow-Tech exports its product to five countries.

Another Commerce partner, the **Manufacturing Extension Project**, is also helping several important Native American-owned firms remain competitive including Turtle Mountain Manufacturing in Belcourt and Sioux Manufacturing in Devils Lake.

Commerce provides funding support to our state's Small Business Development Centers, which operate two satellite offices on our reservations, one in Belcourt and another at Sitting Bull College in Fort Yates. A full report of the clients served to date in this biennium is included in my testimony. Let me provide some of the highlights:

Our state's Native American culture and heritage is also widely promoted by our tourism division. A full database of tourism-related activities is attached, but I'll highlight a few to give you a sense of how the tourism division is helping our state's Native American communities leverage their resources for tourism development:

- We have prominently featured and promoted signature events such as the United Tribes Pow Wow.
- Native American culture and heritage is prominently featured in our media pitches, marketing pieces, themed itineraries and travel materials.
- Tourism has also provided \$250,000 in grants to support Native American-related historical sites and events.

#### COMMUNITY DEVELOPMENT

As I mentioned, our mission involves not only supporting economic development projects but helping communities address key challenges for community development such as public infrastructure, housing, hunger and poverty. Addressing these issues helps position communities for future economic growth.

Through the Community Development Block Grant Program, New Town received \$88,000 to fund improvements to its waste water system and Rolette County received more than \$200,000 in the form of a grant and loan to Turtle Mountain Manufacturing for the purchase of equipment.

Also through the Division of Community Services, the weatherization program invested \$100,000 to weatherize 99 homes on the reservations in the last 18 months. This includes 37 homes on Turtle Mountain, 16 on Spirit Lake, 16 on Three Affiliated and 30 on Standing Rock.

The Community Services Block Grant program is an anti-poverty grant program administered through the Department of Commerce that helps low-income people address a wide variety of challenges including employment, education, housing, and nutrition. The funds are allocated through seven community action agencies statewide and all of our Indian reservations are included in the service areas of these agencies.

Some of the specific services available to tribes through Community Action Agencies and made possible through the Community Services Block Grant program are:

- Funding for three food panties at Spirit Lake and two at Turtle Mountain.
- Emergency services, to prevent shut-offs for heat, utilities and electricity
- A number of reservation families have received computers through the computer donation program for eligible families in need of a computer for educational purposes
- Self Reliance case managers, money management/budgeting assistance and Representative Payee services
- Clothing and food
- Energy Share, rental and deposit assistance, HOME Rehabilitation, utility assistance.



This gives you a rather quick overview of how we are trying to serve the state's Indian Reservations and help them address challenges, support entrepreneurs and new businesses, attract new business and help existing businesses remain competitive and positioned for growth.

Again, as a state-level agency, we see our mission as one of coordination. We have never sought to become the local staff people on the ground in these communities. Rather we work in partnership with organizations that have branch offices and seek to help local business people, elected leaders and economic developers in their efforts to grow their community.
