Sen. Flakoll opened the hearing on SB 2350, a bill to provide am ethanol council; to provide a penalty; and to provide a continuing appropriation. All members (7) were present.

Sen. Wanzek, district 29, testified in favor of the bill.

Sen. Wanzek- What this bill does, putting it very simply is establish a ethanol council and the intent without getting into detail is to basically pattern some of the other commodity councils that we already have in place.

Shane Goettle, Commissioner ND department of commerce, testified in favor of the bill. See attachment #1.

Randy Schneider, President of the ND ethanol producers association, testified in favor of the bill.

Randy Schneider- This bill is patterned after HB 1025. Our industry is maturing, we have had our ups and downs but there is a lot of opportunity within this state and to advance those we feel that we needed to establish this council. We think there is an advantage of having the blessing of the state and that is why we are looking at advancing the establishment of this council. The goal would be to envelop the activities of the ND ethanol association into the ethanol council and then that be the advocate for our industry in the efforts that we are trying to

pursue. With the ethanol council since it is modeled after the other councils we have the opportunity for ethanol producers that are not happy with what the council is doing they have the opportunity to get their dollars back and I think that is a important part of the bill.

Sen. Behm- can you tell me the difference in good corn and low grade corn when it comes to the production of ethanol?

Randy Schneider- a quality corn is essential as to any commodity production as to the maximum that can be produced. It boils down to test weights, moisture content those are all critical elements of defining what a good product is. Again depending on what the ethanol plant did with what price there were charging I would think that it afforded the farmers in that area another market for something that we wouldn't traditionally a quality grade of corn.

Sen. Taylor- Do you think that it is the intent that you would have a funded executive position? **Randy Schneider-** you are right, to date the efforts that our industry has undertaken has all been voluntary, we feel right now that those efforts need to continue to be voluntary because we feel there is greater opportunity in funding projects. We may revisit that if we get a opportunity to find a part or full time executive director we would take a look at that.

Sen. Flakoll- with respect to the refund assessment, that doesn't prohibit them from being on the council does it?

Randy Schneider- yes that is my understanding.

Sen. Flakoll- I see that this bill on the last page has the class B misdemeanor, is that necessary?

Randy Schneider- again this bill is drafted the same way all the bill are drafted and that is why it is that way.

Sen. Miller- why do you have to be put in statue, why do we have to have this council?

Randy Schneider- I just believe that it is significant in having the blessing of the state. It shows that this industry is important in this state and that we are supporting this industry and

Sen. Miller- how many other states do this if there are any?

Randy Schneider- there are states that have organizations that support the industry, I am not aware of the exact number.

Mik Miller, treasurer and CEO of Red Trail Energy, testified in favor of the bill.

again to allow the establishment of that and to be part of the ND century code.

Mik Miller- I stand in support of this bill, with working with other ethanol producers I think that we have all come to the same conclusion that it is very important that we have collaborative efforts to continue to promote and maintain the use of our product in the state of ND. Retroenergy loads about 40 ethanol tankers per week, that is about 55 million gallons of ethanol per year most of that product goes to the pacific northwest.

Sen. Wanzek- how low of a test weight can you go and still convert corn to ethanol? **Mik Miller-** somewhere between 50 and 52lbs corn is what we would like to see.

Tom Lilja, ND corn growers association and the corn utilization group, testified in favor of the bill.

Tom Lilja- we stand in support of this bill. The conversion rate is 1 bushel of corn equals 2.8 gallons of ethanol. As corn growers we will have the supply as of now and into the future and we look forward to upgrading.

No opposition to the bill.

Sen. Flakoll closed the hearing.

Chairman Holmberg called the committee hearing to order on SB 2350 to provide for the creation of an ethanol council.

Randy Schneider, President of the North Dakota Ethanol Research Association, spoke in favor of SB 2350. This bill has a fiscal note, of \$190,800, attached to it. Those dollars would come from the North Dakota Ethanol Producers Association. This is a vehicle that would allow us to fund certain activities of the ethanol industry in North Dakota. We think it is a good piece of legislation and hope that you support it.

Senator Warner, I am not entirely clear with the distinction between this and an industry charity group. Why do you need the government's involvement in this? It seems like it is entirely voluntarily.

Randy Schneider We feel that there is some credibility that the government brings to the organization. The state of North Dakota feels that this is an industry that contributes to the economic role of North Dakota.

Senator Christmann What does an ethanol plant pay to the state in terms of taxes?

Randy Schneider An ethanol plant basically pays income taxes, depending upon what format the entity is structured as. They will also pay property taxes. In today's world we are spending

about two dollars per gallon of production. We would be paying taxes just like any other business would.

Senator Grindberg is this proposal similar to other states with large volumes of crop corn? **Randy Schneider** absolutely, this is kind of modeled after some of the other commodity groups in North Dakota. It is also modeled after some of the other states.

Senator Grindberg to your knowledge do other states support these councils with tax payer money?

Randy Schneider it is my understanding that in most cases the industry supports itself.

Senator Grindberg so the vision of this council is not to lay the ground work for future state support.

Randy Schneider absolutely not, this is to create an infrastructure on a per gallon charge so we can advocate an advance in North Dakota.

Ryan Rauschenberger, Manager or Energy Development in the Department of Commerce, spoke in favor of SB 2350, see attached testimony #1.

Chairman Holmberg closed the discussion on SB 2350.

Senator Warner moved Do Pass.

Senator Krauter seconds the motion.

Senator Wanzek, Sponsor: This bill establishes an Ethanol Producers Council. It is very similar to all the other commodity councils. It's meant to be consistent with how they operate. Collecting an assessment would be on ethanol that would be produced. The amount would be 3/100ths of 1 cent/gallon. The amendment on back puts it into the State Treasurer's domain. The ethanol industry has a lot of promise. The State Agriculture World Leaders conference in January had sessions on the Sustainability in the Future of Ethanol. I always carry this newspaper headline with me, "Seed Companies Look to Increase Corn Yields." This is why I think there is a future in this industry. The ethanol industry is at the Model T stage. There is so much growth ahead of us. The national corn yield back in the 60's was in the mid 40 range. Last year the national corn yield average was almost 154 bushels. Seed companies are predicting by 2030 that the national average will be 300 bushels/acre. Pioneer Hybrid Seed in this article states they are working on corn varieties especially geared to the ethanol industry. In other words, genetically designed in a sense that they are more efficiently converted to ethanol. Seed companies are also looking at ways to increase the content of protein or improve digestibility of distiller's grains to help the cattle feeding industry. Mansanto in this

Farticle expects the U.S. to eventually achieve 10% ethanol use because there is no other alternative at this time.

Representative Mueller: Would you clarify the 3/100ths of 1 cent/gallon goes on where and who pays it?

Senator Wanzek: I am hoping someone from the industry can better answer that.

Shane Goettle, Commissioner of ND Dept. of Commerce: (Written testimony #1)

Randy Schneider, President of ND Ethanol Producers: (Written testimony #2)

There is value to having the State of ND bless our industry through the council and allows us to have a formal structure to gather those dollars to fund the efforts important to our industry. In answer to how we collect it, the 3/100ths of 1 cent is calculated on the gallons of production at each of the ethanol plants in ND.

Representative Holman: \$190,000 is in the budget. 3/10ths of a mill per gallon—how many gallons are being produced?

Randy Schneider: With VeraSun up and running, we are looking at about \$100,000. With new plants coming on, we will get closer to the fiscal note of \$190,000.

Representative Belter: Are there any provisions in the law that precludes you from political activities? I'm very much concerned about the new breed of renewables and they are bypassing corn in exchange for moldy corn stalks and wet bales of hay. Would these funds be available for U.S. producers to talk about the future of using corn as a viable base and look for new things?

Randy Schneider: I can't speak for the council. I can assure you of two things. We will follow the law and represent the ethanol producers of ND. They have a tool to make sure we do accommodate their wishes and that is they can ask for their money back.

Representative Uglem: Is this just another check-off for corn?

Randy Schneider: I would beg to differ. Let's assume we take some of the council dollars and we help fund the establishment of blender pumps. We spend about 20 cents/gallon moving ethanol, which is produced in the state of ND, out to other parts of the country. If we get the ability to keep 10 million gallons of ethanol in ND at 20 cents/gallon, that's \$2 million of additional revenue they don't have to spend in transportation. That is more money to pay for good quality of corn. So I think the exact opposite effect will happen with this.

Representative Vig: Section 1 talks about the producer and the membership of the council.

How many producers are over the one million gallons in ND? How many council members are on this ethanol council?

Randy Schneider: All ethanol plants are over that threshold. Therefore each plant would have a member on the council.

Representative Vig: So how many members on the council?

Randy Schneider: VeraSun, Tharoldson Ethanol in Casseslton, Red Trail in Richardton, Blue Flint in Underwood, if Grafton gets set up, and Walhalla—six total.

Jeff Zueger, Manager of Blue Flint Ethanol: There is a lot of positive that we in the industry feel can come from the joint effort of this group.

Vice Chairman Brandenburg: What is the biggest issue to get it to the pumps?

Jeff Zueger: Public perception and misinformation? We need to educate the public on the benefits of ethanol. This council can focus on these areas.

Mick Miller, President of Red Trail Energy in Richardton: As others have covered most of the information, we all have great ideas on how we can work together to build demand.

Representative Schatz: There are six facilities that produce over a million gallons? Walhalla,

Richardton, Underwood, and where were the other three?

Chm. Svedjan called the Full House Appropriations Committee to order.

Rep. Dennis Johnson approached the podium. SB 2350 would establish an ethanol council.

You will see an appropriation of \$190,800. That monies is going to be derived from a check off on ethanol that is produced at these plants. There is an assessment fee of 1/100 of 1 cent per

gallon to be taken off the ethanol at the plant before it goes to the retailer. Throughout the bill

it tells how they are going to come up with their membership for this council. There is one from

each plant.

Chm. Svedjan: The fiscal note indicates revenues of \$190,800. That is still the same. That

was drawn back in early February.

Rep. Johnson: That was projected with the capacity of 318 million gallons annually and 636

million gallons drained in 09-11 biennium.

Chm. Svedjan: Did this bill receive strong support from your committee?

Rep. Johnson: It was unanimous.

Rep. Delzer: 5:36. It looks like most members are employees of the plant.

Rep. Johnson: They could draw from their membership of employment at the plants.

Rep. Delzer: Who pays them from the day they go? And how many are going to take a pay

cut?

Rep. Johnson: They could be paid up to \$135 a day to be on this council. It would be at their

discretion if they are, sort of speak, double dipping it.

Rep. Delzer: What's this council going to do that's not already being done by the industry?

Rep. Johnson: To bring continuity between the plants that are in North Dakota.

Rep. Delzer: This is entirely different from commodity councils. This is promoting a byproduct

of the grains. I see that as being very different and not requiring the same need for a council.

Rep. Johnson: It is their industry and they felt they wanted this as a tool to sell their product

and come back and report like the rest of the commodity groups every session we meet as to

what is happening in their world.

Rep. Skarphol: What do you think the public perception would be if we authorize a council like

this for the oil industry in North Dakota? I am talking about the refineries and the producers.

This smacks of collusion.

Rep. Johnson: They're earmarking our commodities and they are reporting back along with the

rest of the commodity groups.

Chm. Svedjan: This creates another continuing appropriation and makes all the money

available to them and would pay their per diem and they wouldn't be able to exceed that

Rep. Berg: Can a producer receive a refund if they request a refund of this?

Chm. Svedjan: That was my question. It says on the Fiscal Note that it is assumed that no

producer will request a refund so that tells me the bill must indicate that refunds could be

requested.

Rep. Berg: How many producers are we anticipating to have?

Rep. Johnson: We have five producers and four are active right now.

Rep. Nelson: If it is appropriate, I move a Do Pass.

Rep. Meyer seconded the motion.

Rep. Wald: Section 13, Penalty. It's a Class D misdemeanor. That looks like a heavy penalty.

Rep. Johnson: That's the provision in all the commodity groups I believe.

Chm. Svedjan: Explain to us how that violation would occur. Many of these sections define the duties and the powers and so on. What is it that they would be violating?

Rep. Johnson: It spelled out what their duties are and if they violate any of those duties, wouldn't they be in violation of them?

Chm. Svedjan: I could see the possibility of the council itself violating something like this, but I am not sure about individuals.

Rep. Wald: It looks like there is additional penalty in Section 9 for 30 days. It goes on in Subsection 1 and 2.

Rep. Johnson: Section 9 is similar in all reporting procedures.

Rep. Delzer: Most of these we've got ethanol subsidies set up. You used to have to show a loss. If the plant is showing a loss, can they get out of paying this three cents a gallon?

Maybe three cents a gallon is wrong.

Rep. Johnson: It is 3/100 of one cent per gallon.

Rep. Delzer: That is what we heard in the past that these were all losing money. For a couple of years here they did real well. I don't know exactly how they are doing right now.

Rep. Johnson: The way the bill was brought into us they were doing well and wanted to invest their investment here as far as being able to sell products.

Rep. Delzer: Is our ethanol fund being used in the state?

Rep. Berg: What we're doing now is a program that is counter cyclical. It is really geared to kick in at times when corn prices are high and ethanol is low. Up until the last six months I don't think there has been any kick in of that in the last six months.

Rep. Nelson: Prior to the session, had it not been for the fact that VeraSun filed Chapter 11, the ethanol fund would have been completely deleted.

Rep. Delzer: If you only have five producers and two ask for it back, what is going to happen to the council? I would imagine if they asked for the refund back, they probably won't want be part of the council either.

Rep. Johnson: When there are not that many involved it would be significant if there is one or two that don't want to participate. I don't foresee why two would not want to participate when they brought the bill forward.

Chm. Svedjan: The producers were there and testified in favor of this?

Rep. Johnson: The folks that introduced this bill did it for the producers that wanted this bill.

Rep. Delzer: I have a continuing appropriations list here. It shows for the ethanol production incentive fund estimate, 07-09 beginning balance was right around \$2 million. Revenues and transfers were \$3,500,000. Total available expenditures is \$5,500,000. Ending balance would be 0, 09-11 beginning balance is 0. Revenues and transfers of \$3,500,000 and expenditures of \$3,500,000.

A roll call vote was taken on a Do Pass motion to SB 2350. That motion fails. 11 Yeas, 11 Nays, 3 Absent and Not Voting.

Rep. Johnson: We have the prime sponsor here if you would like to hear any comments from

him. The producers came to him. It is their money. They are the ones that wanted it.

Rep. Berg: Rep. Delzer hit the nail on the head. If oil prices stay low and corn prices stay

high, counter cyclical will kick in and burn through that money. In the past we have had

producers coming at the legislature from a lot of different directions and it would seem to me

that it might be appropriate to pull these producers together so there is kind of one point again

to address what our role is going to be in ethanol next legislative session. I think there is some

merit from policy so we have one point to deal with in the future.

Rep. Meyer: Was there any indication that any producers would request a refund?

Sen. Terry Wanzek, District 29: They have no intentions to ask for a refund. Whether you

pass this bill or not won't have any bearing on the counter cyclical fund. It's a way to pull their

thoughts together. As far as the penalties or fines, it's the same language with all

commodities.

Chm. Svedjan: What is the status of the counter cyclical fund?

Sen. Wanzek: This is a new industry. The ethanol industry is at the Model T stage - and I

mean that in a good way. There is tremendous potential in the future for this industry.

Rep. Nelson: One of the difficulties with the industry is transportation. Ethanol has not been

able to use the pipeline. Truck or rail is the means of transportation that has to be used. What

exactly will this council be doing that is not being done today?

Sen. Wanzek: I think there are a lot of challenges ahead. This puts a tax on their product and

it's meant to be used for research and promotion.

Rep. Nelson: With that information before us I would try a Do Pass again.

Sen. Wanzek: We drafted this to mirror what any other commodity organization would do. I personally do not have a problem, but the producers are not here.

Rep. Skarphol: Is a member required to have a plant in operation or could a member of the council have ownership of a plant that is not in operation?

Sen. Wanzek: I would believe the intent is you have to be in operation.

Chm. Svedjan: I think that is correct.

Rep. Kroeber: Section 1 says the producers must produce 1 million gallons annually.

Rep. Onstad: Don't you think that if more plants come on we are setting up a structure for the future? Try to get them all on board with participation.

Sen. Wanzek: Yes, that is how I would see it.

Rep. Wald: Page 4, Line 17, 20 percent goes to the state treasury. Is that interest off the fund or is that 20 percent of their revenue from the checkoff?

Sen. Wanzek: That's investment income added in the Senate to provide consistency with how the other commodity checkoff funds are handled under the state treasurer.

Good morning, Mr. Chairman and members of the committee, my name is Shane Goettle, Commissioner of the North Dakota Department of Commerce. I also serve as chairman of the EmPower North Dakota Commission.

The EmPower North Dakota Commission was established by the 2007 legislative assembly and its members were appointed by the Governor. It is an industry lead effort that allows all of our energy industries, both renewable and traditional, to have a voice into the state's energy policy. Their effort resulted in the creation of a revised EmPower North Dakota policy document which consists of 21 goals, 40 policy statements, and 98 recommended action items.

One of the EmPower North Dakota Commission's recommendations was the creation of a North Dakota Ethanol Utilization Council for the promotion of ethanol that would be funded by check-off dollars from ethanol plants. SB 2350 would accomplish this recommendation and provide funds from the ethanol producers themselves that could be used to promote the use of ethanol in this state.

I would also like to mention that the Department of Commerce has been involved in other recent efforts to promote ethanol. The GoE marketing campaign was launched in 2004 and included radio and television ads, billboards, and other promotional efforts for a total investment of \$500,000. Also, a proposal has received approval for \$167,764 from the Renewable Energy Program to be used in promoting ethanol in North Dakota. SB 2350 would build on these efforts using funds raised from ethanol producers.

Mr. Chairman and members of the Agriculture Committee, I ask for your support of SB 2350. That concludes my testimony and I am happy to entertain any questions.

Good evening, Mr. Chairman and members of the committee, my name is Ryan Rauschenberger, Manager of Energy Development in the Department of Commerce.

I am here today to speak in favor of SB 2350 on behalf of Shane Goettle, Commissioner for the Department of Commerce who serves as the chairman of the EmPower North Dakota Commission.

The EmPower North Dakota Commission was established by the 2007 legislative assembly and its members were appointed by the Governor. It is an industry lead effort that allows all of our energy industries, both renewable and traditional, to have a voice into the state's energy policy. Their effort resulted in the creation of a revised EmPower North Dakota policy document which consists of 21 goals, 40 policy statements, and 98 recommended action items.

One of the EmPower North Dakota Commission's recommendations was the creation of a North Dakota Ethanol Utilization Council for the promotion of ethanol that would be funded by check-off dollars from ethanol plants. SB 2350 would accomplish this recommendation and provide funds from the ethanol producers themselves that could be used to promote the use of ethanol in this state.

I would also like to mention that the Department of Commerce has been involved in other recent efforts to promote ethanol. The GoE marketing campaign was launched in 2004 and included radio and television ads, billboards, and other promotional efforts for a total investment of \$500,000. Also, a proposal has received approval for \$167,764 from the Renewable Energy Program to be used in promoting ethanol in North Dakota. SB 2350 would build on these efforts using funds raised from ethanol producers.

Mr. Chairman and members of the Appropriations Committee, I ask for your support of SB 2350. That concludes my testimony and I am happy to entertain any questions.

Page 1, line 2, replace "section" with "sections" and after "4-24-09" insert "and 4-24-10"

Page 1, line 3, remove "and" and after "appropriation" insert "; and to require a report to the legislative assembly"

Page 4, after line 22 insert:

SECTION 15. AMENDMENT. Section 4-24-10 of the North Dakota Century Code is amended and reenacted as follows:

4-24-10. Agricultural commodity promotion groups to report to legislative assembly – Report contents. Between the first and tenth legislative day of each regular legislative session, the North Dakota ethanol council, the North Dakota potato council, the North Dakota oilseed council...
