Senator Krebsbach: I am here today to introduce a simple bill. Today it behooves us to see the great effect to see the impact that the hospitality industry keeps us healthy. The request is for a \$5 increase per year per night until it reaches the rate of fed service rate. I have one amendment for the bill that I will pass. You will hear other testimony of others who are more affected by this bill.

Sheila Peterson: OMB, amendment does minor word changing relating to adopting rules rather than policy. In OMB we have established the policies for travel for all of state government. Because those amounts are part of statute it's not a rule making process it is just a policy statement that comes out of our office. We would really support this bill. We have had great deal of concern challenging in western part of state, they are filled and don't need to get state rate of \$55 a night. In eastern part of the state we are unable to get a state rate on weekends but we do have staff that has to travel to the eastern part of the state to do implementations, upgrades, that kind of thing over the weekends.

**Senator Dever**: Keep a list of places that honor state rate?Can you give us an idea of how many we lose/change over time.

Sheila Peterson: Not a specific list of hotels that honor the state rate, more though experience that an agency perhaps has to have an individual in a particular location, they call numerous hotels and no one is offering it. As you know, we did suggest there be an exception process

put in place to allow for paying above state rate. Agencies, about half a dozen, have to pay

over state rate over year and a half. It is not a large number but it is a challenge; we do know

that some places their government is the GSA rates.

Senator Horne: If we approve this as the US Gen Service rate, North Dakota would follow

federal guidelines?

Sheila Peterson: GSA sets rate for every state and in some cases city rates based on the cost

of living. North Dakota just has one rate, which right now I believe is \$70.

Senator Nelson: Would you favor GSA rate for meals and incidentals, too?

Sheila Peterson: Yes we would.

Senator Dever: Is this in the governor's budget?

Sheila Peterson: No it is not specifically in the budget our expectations is that within the budget as approved that agencies make adjustments based on travel. There are a few agencies that travel significantly, those that have auditors on the road, some that employees travel almost full time. Regular state agencies who travel occasionally wouldn't need additional appropriation.

Senator Dever: Some dip into own pocket?

Sheila Peterson: Yes, absolutely.

Senator Cook: What about hotels that their normal rate is lower than GSA rates?

Sheila Peterson: Then pay that rate; the maximum we would pay is the GSA rate.

Senator Dever: Thank you Sheila

Rudie Martinson: See attached testimony #1.

Senator Horne: Do you know what percentages of hotels do not accept state rates?

**Rudie Martinson**: It varies on availability and full service versus economy hotels. As we move forward, and as the average daily rate that these hotels can get on the open market rises and state rate doesn't, the percentage drops.

**Senator Dever**: Do you have an idea on the average what state rates represents versus normal cost.

Rudie Martinson: That depends on what part of the state you are in. By way of example, some of our members in the Fargo area that are limited service hotels that are doing an average daily rate of \$80-\$85 in some cases, so there we are talking \$25-\$30 a night. But that is by no means universal; it depends on when and where you are staying.

**Senator Nelson**: Do you think that this change will increase number of hotels available in eastern part of the state?

Rudie Martinson: Yes I do. That is a big part of the discussion that our board of directors had when we got together and decided what we were going to put before the legislature; how can we do this in a way that will allow us to increase the services as an industry that we offer to state employee and also not be too big of a bite for the hotel as we move forward.

**Senator Dever**: I suppose you don't know how many nights state employees stay in hotels? **Rudie Martinson**: That is probably a question for the Office of management and Budget **Senator Cook**: Hotel industry has multiple rates there is the off the streets rate, AARP rate, a

CSG rate, & a state rate. Don't you think it would be wise for us to get the lowest rate that the hotel does offer?

Rudie Martinson: I think it would be wise. The way the law works is that it reimburses, that is a top end limit on what the government will pay. I was in Bottineau last month and had a hotel

room for \$39 and that was the going rack rate. That is what is paid out if it doesn't reach that limit.

Dave Achtenberg: My name is Dave Achtenberg, I am the general manager of Ramkota Hotel in Bismarck. We do honor state rates at our hotel and always have; I am here to testify in favor of this bill which would allow the state per diem to mirror the current federal per diem rate by August 1, 2011. The current \$55 state per diem is \$13.13 lower than the average rate of \$68.13 for all rooms rented in the state of North Dakota for the calendar year of 2008. Those rates vary geographically and by season but that is the overall picture the average rate in Bismarck was \$69 for the past year. The fed per diem in North Dakota \$70, lowest rate allowed by the GSA. Rates range from \$70 in North Dakota to \$360 rates in New York. I feel SB2353 establishes a fair and equitable system determining North Dakota's state travel per diem.

Senator Dever: certain number of rooms that make available for state rate?

**Dave Achtenberg**: Based on availability, contract with the group at a state rate and set aside rooms based on what they need. Usually we try and honor it up to last room availability.

Senator Dever: Anyone else? Close public hearing on SB2353.



1. I am handing out a couple pieces of testimony this morning and the first one is my testimony and the second one is testimony from a member of our board of directors up in Minot who could not be here today. Handed out testimony for Pete Zimmerman, See Attachment # 2.

**Chairman Grande:** So we are looking at for 2009 we go to \$60, for 2010 we go to \$70, and after that whenever the Federal level increases we just go along with that .

**Rudie Martinson:** Actually Chairman Grande, 2009 would be \$60, 2010 would be \$65, 2011 would be \$70 and then after that it would rise or fall as the Federal rises or falls.

**Chairman Grande:** I see in 2010 it says a \$5 increase and then every year thereafter as necessary.

Rudie Martinson: Up to \$5 a year, yes.

Vice Chairman Randy Boehning: The only change that I could find in the amendment was that they "shall adopt rules" instead of "shall establish policies" is that the amendment?

Rudie Martinson: Yes, it is. OMB actually suggested that amendment because that is the language they use internally. OMB testified that they don't establish rules they use policies or whatever the language changed to. It had to with their internal language.

**Rep. Amerman:** Once we tie to the Federal rate, how has that been going up the last several years? How much has it been jumping year to year?

**Rudie Martinson:** We are now entering the third year were the Federal rate has not increased. It has not increased in 2009, it did not increase in 2008 or 2007 either. It has been \$70 for going on three years now.

**Rep. Amerman:** I don't know if you know how they base their scale, when they go up, being that they have not gone up for a number of years, do you know what they tie that too?

Rudie Martinson: I don't know the details of how they do that. I imagine it is similar to how they set rates for mileage reimbursement and that kind of thing. The GSA also sets those rates and they look at States differently. It has gone up for ND. They treat ND as one entity, CA by contrast there are three different Federal rates for if you are around LA, if around the Bay area or if you are anywhere else in CA, so they treat ND as one entity and they haven't raised our rate in three years. I imagine there is a very complicated Federal bureaucratic process to figure it out.

#### **COMMITTEE WORK ONE:**

Chairman Grande: We will discuss SB 2353.

Rep. Kasper: This one of the two that we had talked about amending and our committee wasn't getting together everyone was busy Monday, Tuesday, and Wednesday. So I called Legislative Council to do some amendments and I also asked Rep. Winrich to sort of do a checklist with this caucus on where the caucus might have a feeling on retro-activity on that lodging of a \$1000 because right now the bill we just passed will make the \$1000 lodging effective probably April 1. So the hotels get one month of lodging. The Senate had heartburn on retro-acting the lodging to January 1. But I thought if we could get some consensus here on both sides of the isle that maybe we could have one bill that would retro-act the lodging and pass the other one out. Which we did pass the other one out. There are amendments here that do retro-act the lodging to

January 1 for the \$1000 but I don't want to push the amendments if we don't have a somewhat bi-partisan agreement.

Rep. Winrich: If we like the provisions of this bill, which basically increase the daily room rate regularly until it gets up to the Federal GSA rate, I don't think it would be wise to amend any retro-activity into it because I don't think there is much support in my caucus and I am sure that if we send this back to the Senate they will retro-act it again. Since the one increase up to \$60 for the first year is in the other bill, this one could be killed and still increase the room rate. I think it would be good to pass it.

Rep. Schneider: I am not absolutely opposed to retro-activity but did you happen to have any conversations with Karen Mund or anyone at Legislative Council and how they would implement it. Just for example, I say, if it would be \$1000 a month but on all my reimbursements the last couple months I have only claimed \$900, would I just have to go back and show that I actually was paid (could not hear, coughing), I just don't know how they would implement it.

**Rep. Winrich**: There was a room rate bill that passed in like 2003 or 2001 that was retro-active in January and what Legislative Council did was simply add in the increase in the next monthly travel allowance that you got and so you got reimbursed for those first three months.

Rep. Schneider: Everybody?

Rep. Winrich: If you turned in receipts for more than the amount.

**Rep. Kasper:** I did not talk with Karen Mund but I think if everybody would go back and get a voucher from your Landlord that says you were billed a \$1000 they would accept it. But I don't have that verified.

**Chairman Grande**: I am sure the mechanism is in place but I don't think it is an issue because we have done the retro before. But it just needs to be a matter of whether or not the vote was there.

**Vice Chairman Randy Boehning:** Just referring back to SB 2064 that \$1000 is not in the Emergency Clause.

Chairman Grande: Correct.

Vice Chairman Randy Boehning: Rep. Kasper said it was in the Emergency Clause but it is not in the Emergency Clause because that section wasn't stated in there.

Rep. Wolf: Yes, it is.

**Rep. Winrich:** Yes it is. In Section 10 it has effective dates for various sections. Section 11 is an Emergency Clause for the whole bill. Section 4 is not listed in one of the effective dates so it would be under the Emergency Clause.

Chairman Grande: So it is retro in the first bill?

Rep. Kasper: No. It is an Emergency Clause effective April 1.

**Rep. Kasper:** If we don't retro-act this would you consider adding an amendment on this bill that would increase the housing allowance in 2011 to \$1100 a month so that we can be prepared for two years from now.

**Chairman Grande:** Do you know did the commission say that that is what they are going to decide on?

Rep. Kasper: This is supposed to go up to \$1254.

**Rep. Winrich:** This bill as it stands just applies to all State Employees and not just Legislators.

Rep. Nathe: But not Higher Education?

**Chairman Grande:** Higher Education's numbers are not in the budget but it applies to them too because theirs are in a separate budget.

Rep. Winrich: I would argue that it is not a good idea to send this back to the Senate with additional amendments on it or various things because with the provision in the other bill for an increase to \$60 a night. It doesn't have to pass and I really kind of like to see this one pass and get us in sync with the GSA rate.

Rep. Wolf: A flip side to that \$1100 proposal from Rep. Kasper, have you and Rep. Froseth talked about the apartments because there was some discussion about that too.

Chm. Svedjan called the House Appropriations Committee to order. Clerk, Holly Sand, called the roll and a quorum was declared.

Rep. Glen Froseth, District 6 approached the podium to explain SB 2353 and the Fiscal Note.

This bill raises the daily rate from \$55 to \$60 a day. This goes into effect Aug. 1 2009. The

next section raises the daily lodging reimbursement in increments of \$5.00 a year, starting in

August 2010, until it reaches the federal reimbursement rates of US General Services

Administration. Right now the federal reimbursement rate is at \$70 a day. It would reach that

federal rate by 2011. On the fiscal note in the 2009/2011 biennium it calls for \$153,689 in

general funds and \$264,449 in other funds. On the 2011/2013 biennium it is figured at the \$70

rate. The general fund is figured at \$307,000 and the other funds \$528,000. This does not

include the Higher Education reimbursement for lodging. That's in their budget. (7:13)

Chm. Svedjan: What is the GSA rate?

Rep. Froseth: It's \$70.

Rep. Williams: What was your vote in Committee?

Rep. Froseth: It was 11-2, Do Pass.

Rep. Williams moved a Do Pass on SB 2353.

Rep. Kempenich seconded the motion.

**Rep. Nelson:** How often does the GSA rate change? Once we use this system the legislature

will lose control of how this is paid moving forward, is that correct?

Rep. Froseth: Yes, it will. I don't know how it is determined.

Chm. Svedjan: Does GSA revise these numbers down occasionally?

**Rep. Bette Grande** approached the podium to clarify.

**Rep. Grande:** We are giving authority to OMB to make that adjustment. We cannot tie ourselves to them. It still has to be done by rule and the adjustment from OMB. If they choose not to by rule, they don't have to.

Chm. Svedjan: If GSA were to revise our rate down to \$65, would this bill follow suit?

**Rep. Grande:** It would give OMB the authority to change the rule.

**Rep. Glassheim:** My understanding is that this requires OMB to set it the same as the federal

Chm. Svedjan: It increased it by five dollar increments to reach the five dollar level.

Rep. Glassheim: Should it go up, they must increase it to the federal level.

**Rep. Martinson:** Does that mean that under the government guidelines they have different rates for different towns?

**Rep. Froseth:** I'm not sure. I thought it was by the whole state.

Rep. Dosch: They establish it by region. ND would be the same rate statewide.

**Rep. Nelson:** Does the Fiscal Note reflect all of state government? In Human Resources the travel budgets have increased in almost every area. The explanation has been that the reimbursement for lodging is a big part of the increase.

**Rep. Froseth:** SB 2064 deals with legislator's salary and monthly lodging rates and mileage.

Rep. Hawken: We have a lot of discussion about things that are out of our control. Would this

keep us from doing that?

**Chm. Svedjan:** To the extent that it would match with the GSA rate. You could argue that it

would.

**Rep. Hawken**: Is this self-serving for us? We're looking at reimbursing ourselves. We don't let other people do this, but we do it for ourselves.

**Rep. Delzer:** I don't plan to support this because it's tied to the GSA. This is not just for the legislators. It's for all state employees.

Rep. Glassheim move to make a substitute motion. I move to delete Section 2.

Rep. Nelson seconded the motion.

Rep. Dosch: When the federal government establishes these rates, they do it by region. It's not an arbitrary number. It is based on the average rates in that area. It tends to be a fair rate. Regarding Rep. Hawken's comment, this is for all state employees. If you go anywhere else in the country, the state of North Dakota will reimburse you for whatever that room rate is. It basically steps on the lodging industry in North Dakota and only will reimburse at the \$x level. If they treated us like everyone else, they would reimburse at corporate levels. We treat our own people in our own businesses differently than any other state in the country.

**Rep. Glassheim**: We may be a little bit lower. I've felt the hotels/motels have benefited even though they may take a discount. I don't think they are hurt too badly by getting a little less than market.

**Rep. Klein:** There is a disconnect. Sometimes while working for FEMA you are under the state system. You may not be able to stay at the same hotel as the federal employees because they wouldn't accept the state rate. Then the employees were separated, so it might not work very well.

Rep. Delzer: I don't like tying to the federal rate, but I also don't like going to \$60.

A voice vote was taken with an uncertain outcome.

# Testimony of Rudie Martinson ND Hospitality Association Executive Director SB 2353

Mr. Chairman and Committee Members, thank you for the opportunity to appear before you today. My name is Rudie Martinson, and I represent the ND Hospitality Association. I'm here today in support of SB 2353.

The ND Hospitality Association worked with Sen. Krebsbach to draft this bill in order to provide a mechanism by which the state rate can respond to changing market conditions in North Dakota without the need to come before the Legislature to adjust the rate. This bill provides for a \$5 increase in the state rate, from \$55 to \$60, in 2009. It then allows the Office of Management and Budget to increase the rate by up to \$5 per year until it reaches the rate established by the US General Services Administration for lodging in North Dakota.

By way of background, the state rate was raised by \$5 in both the 2005 and 2007 sessions. Prior to that, the rate had been stagnant for four years. Since 2005, the state reimbursement rate for hotel rooms has gone up \$2.50 per year.

By contrast, the Average Daily Rate in North Dakota rose anywhere from \$4 to \$6 in 2007 and \$6 to \$8 in 2008. These rates rise because of the rising cost of business. The cost of good and services continually rises with time. We have also had two minimum wage increases since the last legislative session, and North Dakota's economy has causes us to raise wage scales to compete for labor.

We understand these changes are the cost of doing business. For all of our other customers, we can raise rates in order to cover rising costs. For state business, we have to come before the legislature.

This bill will allow hotels and motels to better afford to serve state guests by bringing the state rate closer to the value of a room on the open market. It will also expand the number of businesses offering the state rate and make traveling easier and more hassle-free for state employees.

Mr. Chairman and Committee Members, the ND Hospitality Association supports SB 2353 because it provides a mechanism for the state rate to respond to changing economic conditions without having to come before the legislature for a rate change every legislative session. This will allow us to better budget for state business as an industry, and better serve our state customers as a whole. We ask you to give SB 2353 a "DO PASS" recommendation.

Madam Chair and Members of the Committee:

My name is Pete Zimmerman. I am the Managing Partner of the Holiday Inn Minot and the Holiday Inn Express and Suites in Minot. I present this written testimony to you in hopes that you will support SB 2353.

Having been in the lodging business in Minot for over 20 years, I have made the trip to Bismarck on several occasions to ask for the support of the ND Legislature as it pertains to the State Room Rate Per Diem for North Dakota. Each session, we ask for and receive your time and consideration in hopes of raising the per diem \$2.00 - \$5.00 per biennium. We have been successful on some occasions and not so successful on others. What we would like to do in SB 2353 is gradually increase the State Room Rate Per Diem for North Dakota each year until it reaches that of the Federal Room Rate Per Diem as it pertains to North Dakota. At that point, any future increases would be automatic. This, in my mind, will make the per diem rate much more competitive with what is actually going on in the marketplace. Our Average Daily Room Rates, for both of our hotels, is substantially higher than the current per diem rate. This makes it difficult, financially speaking.

We currently and will always value State of North Dakota business. Under the current rate system, we do not allocate more than 5-8 rooms per night for State of North Dakota travelers. We do this, not to be bad corporate citizens, but rather because we can not afford to sell large numbers of rooms for \$55.00 per night. It simply doesn't pay the bills in today's business environment. We feel that this "piggyback" to the Federal System would make the reimbursement much more equitable and keep us out of your hair on this issue each biennium. By having a more market competitive rate for the hotels, it should also, in theory, make more lodging facilities in North Dakota available at the State Rate for ND State Employees.
