Representative Elliot Glassheim: I lend my support to the bill. We lost between two and four thousand people when the base moved people out. It was a loss to the community in income tax sales. We need to do what we can to repopulate the base and improve Grand Forks and the surrounding region.

Senator Potter: What is BRIC, are they a corporation, are they going to go out of business?

Representative Glassheim: I don't believe that the BRIC is borrowing the money. This would be grants to the projects that are approved.

Senator Potter: Don't we provide funding to grant organizations right now without requiring a budget section authority and emergency commission authority?

Representative Glassheim: Yes.

Senator Andrist: I don't understand the language you're making a ten million dollar appropriation under a five million dollar appropriation. It seem to me that if we provided a ten million appropriation, five million payable in this biennium and five in the next. We wouldn't be obligating the next session. But we would be showing are balance sheet that we had this obligation and our surplus would appear to be five million less. Seems to me to be a better approach.

Representative Glassheim: I hate to speak because those who know better than I do may have better ideas. We just dealt with this before you came to get me in terms of center of excellence. We've done fifteen million appropriated and five million in borrowing authority. In house appropriations we voted against the separate bill giving the five million borrowing authority. We will deal on whether to increase the appropriation in the later bill in the commerce department. The point is it's a good project and we need all the ten million dollars now.

Chairman Holmberg stated people who were planning to be here for this hearing are having technical difficulties with the weather. The people can't be here from Grand Forks I would hope that you would let the bill go to the Commerce Department subcommittee for further work and further clarification. I have written testimony from them but they won't be here to answer the questions. You might consider the subcommittee having a conference call for those to reflect on their testimony. He presented written testimony #1 in support of SB 2408. You will hear testimony from others in writing concerning the economic impact of the Grand Forks Air Force Base on the area and the state. You will see in the written testimony #2 letters from Northwood, Larimore, Patton. We need to work together. The state needs to be a partner. SB 2408 provides a mechanism. It was drastically changed in IBL He continued to explain how the bill would work. As the packet would indicate there used to be 14,000 air force personal on base, by next year it will be 1600. There are two schools on the base. One used to be the largest school in the state and now the two schools together have less than 350 students and this next year might be the last year they run two schools. There are a number of proposals

because the impact affects the whole area. We have worked with the congressional delegation and the governor's office. One of the points that keep coming back when we look at working with the Feds is there are things that they can deliver but there are some things they can't and one of the first things that occurred when they go trying to get some involvement of the federal government is look at what the state and local community doing. If you don't have that kind of activity and buy in from the state and local activity it is much more difficult to present a package that will get through.

**Senator Mathern** If this is different from the bill introduced 15 years ago a whole lot of Grand Forks people voted against, as it would never happen.

Chairman Holmberg I recall it, there was a nice article in the paper, we were all chastised, that would cause the base to close, those same people 15 years ago now are supportive of this, because it has happened the base has been downsized dramatically. It is a huge asset, school districts like Larimore, Hatton, those places, anticipate 15% reduction a lot of families live off base and like the small communities.

**Senator Mathern** had more questions regarding the local involvement.

Chairman Holmberg stated the co chairmen are Mayor of Grand Forks and county commissioners. It has city county, economical people, this is a joint effort. They started this year and our problem was in timing because they won't get things going until June or July by then the leg would have been out of town. They have to go through the Department of Commerce, has to be competitive bidding. There has to be dollar for dollar cash match, has to be local involvement. Before they can get a budget from the state.



# FOR SB 2408 – One Time source of Funds for Base Realignment Opportunities at Grand Forks AFB.

- 1. The Grand Forks AFB tanker refueling mission is completed in 2010 causing a "bathtub" period of significant losses of base personnel and jobs as the UAS mission slowly develops. North Dakota heavily relies on the economic impact of miltary missions located in the state.
- 2. When the 2005 BRAC decision was made, more than 3000 personnel were directly employed at the GFAFB with a payroll of \$139 M plus \$186 M in local contracts. BRAC projects job losses of 4,929 jobs (2,645 direct and 2,284 indirect jobs) or 7.4% decrease in the local jobs which includes uniformed, civilian and contract jobs related to the base. Job losses were across the five-county region both rural and urban.
- 3. In the last decade GFAFB has benefited from \$438 M in infrastructure project investment, which includes a new runway, quality housing, and several new buildings. Currently the base is undergoing a significant upgrade in communication systems to handle the constant stream of data and images from the UAS fleet of Predator Bs and the Global Hawks. The GFAFB has outstanding facilities and infrastructure for growth
- 4. **GFAFB has lots of room to grow**, having the second most total available buildable acreage for airfield operations and maintenance of all the flying bases in the Air Force, behind only Eglin AFB. Grand Forks AFB has over 1,200 acres available for potential development, and the base will soon have a surplus of 224 dorm rooms and 273 family housing units (500 units).
- 5. There are **opportunities to secure high paying jobs** by leasing space to DOD and DHS contractors and subcontractors as well as private entities to attract high paying, high tech jobs. Have **chance to make lemonade from lemons.** Because of high paying jobs, the repayment in sales and income tax should be significant. Thus this is a good investment. Opportunities will be in maintenance, training, energy sources, advanced data, sensors, intelligence & surveillance, manufacturing, etc. Some may have university connection, most will not.
- 6. We are **competing with other states** for opportunities on military bases, like New Mexico, Missouri, Kansas, Colorado, California, and other states. Some opportunities will require matching funds, others will require construction or reconstruction, and some may require acquiring specialized equipment or infrastructure. Less than seven states have not weathered a base closure or realignment since 1988, as 150 military bases have been closed or downsized.
- 7. Current state economic development programs do not have the capacity to handle large development projects. Need another one-time source of funds to capture opportunities during the "bathtub period." We should do the same for Minot AFB is they ever face realignment or closure.
- 8. Significant base infrastructure, strategic advantages and political clout are very helpful in attracting and securing opportunities with an underutilized asset, but expect significant investments will be needed to capture an opportunity while competing with other states and air bases for these opportunities.
- 9. This fund to enhance economic development on the GFAFB makes sure there will be local review and approval, state review and approval, and accountability.

### The Redevelopment of Former Military Installations

The U.S. Department of Defense (DoD) plans to close or realign many military installations across the country as a part of the 2005 Base Realignment and Closure (BRAC) process. The closure of just one military base can have a profound effect on the economic health of a state and locality resulting in the loss of thousands of jobs and millions of dollars in economic activity and tax revenue. As a result, it is in the best interest of states and local communities that host military bases to put them back into productive reuse as soon as possible.

The redevelopment of a closed military base provides a wealth of opportunity as well as a series of challenges. Larger military installations are, in effect, self-contained cities and although they have the potential to be marketable pieces of real estate, they often suffer from environmental contamination as well as old and outdated infrastructure.

### What can States do to Prepare for the Closure and Redevelopment of Bases?

Once a state anticipates or is informed of a base closure, there are a variety of roles a state can play to advance the redevelopment of closed military installations. States should approach the reuse process in a way that best fits state and local views on land use and economic development. One of the first steps that should be taken when a military installation is identified for closure is to organize a Local Redevelopment Authority (LRA) which will be responsible for planning the base's reuse.

- 1. The state can send a representative to serve as a resource to the LRA: This approach provides the state the opportunity to participate, support, and guide the redevelopment process, but allows decisions to be made at the local level. A state representative could assist the LRA by:
  - Identifying and securing appropriate state funds, grants, loans, and financial incentives
  - Navigating the state and federal regulatory process on issues such as economic development, employment/labor, environmental contamination, transportation, housing, and historic preservation
  - · Sharing information about the efforts of other LRAs across the state
- 2. The state can help organize the LRA and provide it with the necessary land-use authority:

  Many military bases are surrounded by several jurisdictions which often leads to dispute and confusion as to who is in charge. Under these circumstances, a state could step in and identify the LRA membership and, when necessary, provide it with the requisite authority needed to make land-use decisions.
- 3. The state can become the LRA: The local government surrounding a closed military base can sometimes be overwhelmed by the impact of the closure and the significant responsibility of redevelopment. Often in rural areas, these local governments may not have the resources or manpower to effectively manage an LRA. In these cases, the local government may hand over redevelopment responsibility to the state who can assume the role of LRA.

# Governor Pledges Funding for BRAC Losses

### Governor lauds Arlington as smart growth model

ARLINGTON, VA -- Virginia Governor Tim Kaine reaffirmed a pledge to provide \$10 million in state funds to offset the BRAC (Base Realignment and Closure) impact on Arlington County. The governor's pledge came during his Nov. 27 visit in Arlington. During his visit, Arlington officials again requested the \$10 million in funds to meet federal security requirements for the Defense Advanced Research Projects Agency -- to help ensure this key research agency stays in Arlington.

Gov. Kaine's visit to Arlington, which focused on smart growth, was part of a day-long traveling cabinet meeting in Northern Virginia. "Arlington serves as a model for how other communities in Virginia -- and nationwide -- can incorporate smart growth principles," Kaine said.

At the briefing, Arlington County board members provided background on smart growth in Arlington and highlighted progress in the community. They discussed how the state can support smart growth development. County officials also asked for more state funding for transit-oriented initiatives.

"Gov. Kaine's visit provided a good opportunity for dialogue about the important links between transportation and land use, and how Arlington is making smart growth work. We look forward to working with the governor and state agencies on policies that build communities where people want to live and work -- and that ultimately make more sense both environmentally and fiscally," said County Board Chairman Christopher Zimmerman. "It is especially fortunate this governor comes from local government, so he understands the issues on the ground far better than many state officials."

# Gov. Perry Announces \$365 Million Package to Bring Navy Master Jet Base to South Texas

August 08, 2005

AUSTIN – Gov. Rick Perry today announced the state is committing \$50 million from the Texas Enterprise Fund as part of a \$365 million incentive package aimed at enticing the U.S. Department of Defense to move equipment and personnel and create a Navy Master Jet Base in the South Texas Coastal Bend Community.

The package of incentives, which is contingent upon the establishment of a Master Jet Base in the coastal bend area, was developed after the Base Realignment and Closure (BRAC) Commission last month placed Naval Air Station Oceana in Virginia Beach, Virginia on the list of military bases recommended for closure. NAS Oceana is home to a Master Jet Base and currently operates with approximately 10,000 military and civilian personnel and approximately 250 aircraft.

"Today I am proud to announce that should defense leaders decide to move the assets of NAS Oceana to Texas, we are prepared to commit more than \$365 million to improve facilities and infrastructure at Naval Station Ingleside, Naval Air Station Corpus Christi and Naval Air Station Kingsville," Perry said, noting that these new funds are in addition to the \$458 million recently committed by the state for infrastructure improvement projects in Coastal Bend defense communities.

Perry outlined the state's offer in a letter last week to Anthony Principi, Chairman of the Base Realignment and Closure Commission.

"The Coastal Bend is the ideal location for a Master Jet Base because we have plenty of available land, unencumbered air space, excellent weather and the strong support of the entire community, including environmental leaders such as the local chapter of the Sierra Club and the Coastal Bend Bays and Estuaries Program," Perry said.

In contrast, Naval Air Station Oceana in Virginia has severe urban encroachment problems, troubles with noise pollution and opposition from many citizen organizations that are working to see the base closed.

The package of incentives the state is offering includes:

- A \$50 million dollar grant, made available through the Texas Enterprise Fund, will be used to assist in land acquisition, environmental studies, range development or other infrastructure needs.
- The Texas Department of Transportation will build and operate a rail spur from Union Pacific's main rail line to Naval Station Ingleside. This project is estimated at \$15.2 million and upon completion the Department of Defense will have access to the line at no cost.
- At the governor's request, TxDOT has made available an additional \$100 million for transportation improvement projects on and around NAS Kingsville, including the expansion of

- Chapman Ranch Road from two lanes to four. This road connects NAS Kingsville to south Corpus Christi.
- A \$200 million low-interest loan fund financed by the sale of State of Texas General Obligation bonds has been made available to community leaders to meet other infrastructure and facility needs of the Navy and the local defense community.

"This \$365 million investment is a win-win for Texas and the U.S. Armed Forces," Perry added. "The military will benefit from modern and expanded facilities and save funds to spend on other critical priorities."

"The Coastal Bend and the entire state will benefit from increased economic activity. And our men and women in uniform will benefit because they will be living in a state and a community that supports and appreciates them like no other," Perry said.

Perry also praised the efforts of Secretary of State Roger Williams, who serves as the Chairman of Texas' BRAC Response Strike Force, federal officials and an unprecedented coalition of local leaders who are fighting to protect Coastal Bend installations.

"With one voice, we have delivered a clear message to defense leaders weighing the future of Coastal Bend installations: that these facilities have a military value beyond measure, and must be kept open for the interests of the War on Terror and the continued security of our homeland," Perry said.

Although Mothballs are much cheaper than financing SB 2408, it would be the wrong direction for this legislature to take. It would be a Classic case of being penny wise and pound foolish.

The Federal Base Realignment and Closure Commission (BRAC) has dramatically downsized the GFAFB. The local area has created a Base Realignment Impact Committee (BRIC) to assist the area in reacting too, and getting ahead of the game. You will hear testimony from others concerning the economic impact of the GFAFB on the area and state.

We need to work together. The state needs to be a partner in this endeavor. SB 2408 provides a mechanism to create such a partnership and assist the Northeast section of the state.

As amended in IBL, the bill provides \$5M from the general fund of one-time funding. As introduced, the bill would have allowed \$5M more in borrowing from the Bank of North Dakota with the approval of the budget section and the emergency commission.

The bill will be explained by others testifying today.

Dear Mr. Chair and Committee Members:

This letter is written on behalf of the Grand Forks County Commission, in regards to Senate Bill 2408 which would provide an avenue to offset the economic impact to our rural communities associated with the realignment of the Grand Forks Air Force Bases' mission. Department of Defense standards emphasize that a base must show the ability to reduce its operational costs in order to sustain base operations. This budget reduction allows the regional economy the ability to attract other sources of income that provide economic development in current and future state of the art technology. Grand Forks Air Force Base's new mission will host aviation and energy opportunities that will allow private industry a means to test and develop their new platforms. This could create an entirely new industry offering the potential for many high paying jobs. The regional community needs state assistance for this one time opportunity to stimulate economic growth that would benefit urban and rural communities impacted by the BRAC process and help secure the operation of Grand Forks Air Force Base.

In 2005 BRIC, with funding through the Office of Economic Adjustment, completed a regional economic impact study. The study clearly showed that Base realignment did present a negative impact on Grand Forks and its surrounding counties. This bill provides an avenue to offset the negative effects of created by the last BRAC proceedings.

The additional qualification that was added to Senate Bill 2408 that requires dollar for dollar cash matching funds from the city, county, federal government, or the private sector would not allow Grand Forks County to access these much needed funds. Unfortunately, Grand Forks County does not have funds available or the ability to levy for the needed funds to contribute a local dollar for dollar local match. Grand Forks County levied 22.98 for the 2009 budget and the maximum levy for the general fund is 23 mills according to NDCC 57-15-06. There would be no additional room for a levy to meet the matching requirement. We project at the end of 2009 that our cash carryover will be approximately \$1,300,000. This carry over will be needed to meet our cash requirements in 2010. Based on this information, Grand Forks County would not be able to take advantage of the grant funding if the dollar for dollar match requirement remains in the bill.

Please consider removing this language and return Senate Bill 2408 to the original format. Thank you for your time and consideration.



# FOR SB 2408 – One Time source of Funds for Base Realignment Opportunities at Grand Forks AFB.


- 1. North Dakota relies heavily on the economic impact of miltary missions, as we serve our nation. The Grand Forks AFB tanker refueling mission is completed in 2010 causing a "bathtub" period of significant losses of base personnel and jobs as the UAS mission slowly develops.
- 2. <u>Lost Jobs</u>: When the 2005 BRAC decision was made, more than 3000 personnel were directly employed at the GFAFB with a payroll of \$139 M plus \$186 M in local contracts. BRAC projects job losses of 4,929 jobs (2,645 direct and 2,284 indirect jobs) or 7.4% decrease in the local jobs which includes uniformed, civilian and contract jobs related to the base. Job losses were across the five-county region both rural and urban.
- 3. The GFAFB has <u>outstanding facilities</u> and infrastructure for growth. In the last decade GFAFB has benefited from \$438 M in infrastructure project investment, which includes a new runway, quality housing, and several new buildings. Currently the base is undergoing a significant upgrade in communication systems to handle the constant stream of data and images from the UAS fleet of Predator Bs and the Global Hawks. New missions can be attracted.
- 4. GFAFB has lots of <u>room to grow</u>, having the second most total available buildable acreage for airfield operations and maintenance of all the flying bases in the Air Force, behind only Eglin AFB. Grand Forks AFB has over 1,200 acres available for potential development, and the base will soon have a surplus of 224 dorm rooms and 273 family housing units (500 units).
- 5. There are <u>opportunities</u> to secure high paying jobs by leasing space to DOD and DHS contractors and subcontractors as well as private entities to attract high paying, high tech jobs. Chance to make lemonade from lemons. Because of high paying jobs, the repayment in sales and income tax should be significant. Thus this is a good investment. Opportunities will be in maintenance, training, energy sources, advanced data, sensors, intelligence & surveillance, manufacturing, cold weather testing, etc. Some may have university connection, most will not.
- 6. We are <u>competing with other states</u> for opportunities on military bases, like NM, MO, KS, CO, CA, and more. Some opportunities will require matching funds, others will require construction or reconstruction, and some may require acquiring specialized equipment or infrastructure need flexibility. Just 7 states have not weathered a base closure or realignment since 1988, as 150 military bases have been closed or downsized. We need \$10 M investment to compete. There will local leverage and match, limited to capacity by taxation.
- 7. Current state economic development programs do not have the capacity to handle large development projects. Need another one-time source of funds to capture opportunities during the "bathtub period." We should do the same for Minot AFB is they ever face realignment or closure.
- 8. Significant base infrastructure, strategic advantages and political clout are very helpful in attracting and securing opportunities with an underutilized asset, but significant one-time investments of \$10 M will be needed to capture the significant opportunities while competing with others for the same opportunities. This is about high tech for North Dakota.
- 9. <u>Process works.</u> This fund to enhance economic development on the GFAFB makes sure there will be local review and approval, state review and approval, and accountability.
