

# North Bay residents hoist an idea that's worth a look

nlike the recent attempt in Congress at a flag-burning amendment, there's nothing cynical about what Jim Parks and David Wishingrad of Sonoma County are doing. Americans of all stripe can get behind this flag initiative.


As Staff Writer Guy Kovner reported Wednesday, Parks, of El Verano, and Wishingrad, of Sonoma, are trying to get Congressional approval for a national flag honoring a vanishing breed — veterans of World War II. Actually, they're proposing that their Veterans Remembered Flag be used to honor all soldiers — in the past and in the future. Still, there's a sense of urgency to what they're doing. They note that of the 16 million Americans who were involved in World War II, just 3.5 million are still alive today. It's projected that by 2016, only 616,000 will still be around.

The proposal has already been unanimously endorsed by the California state Legislature, the California American Legion and Veterans of Foreign Wars.

It's not the most critical matter but neither should it be a controversial one.

This is one flag proposal that Congress can safely wrap itself around.
