ENGROSSED SENATE BILL NO. 2081

Introduced by

(At the request of the State Board of Higher Education)

1 A BILL for an Act to amend and reenact sections 15-52-03, 15-52-04, 15-52-30, and 15-52-31  
2 of the North Dakota Century Code, relating to the university of North Dakota school of medicine  
3 and health sciences advisory council.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. AMENDMENT.** Section 15-52-03 of the North Dakota Century Code is  
6 amended and reenacted as follows:

7 **15-52-03. ~~Medical-center~~ School of medicine and health sciences advisory**  
8 **council - Members, terms, meetings.**

9 1. To assure the proper coordination ~~and integration~~ of the ~~North Dakota state~~  
10 ~~medical-center~~ university of North Dakota school of medicine and health sciences  
11 with all other health ~~and welfare~~ activities of the state, a permanent ~~medical-center~~  
12 school of medicine and health sciences advisory council is established to ~~advise,~~  
13 ~~consult, and make recommendations to the university administration, and to the~~  
14 ~~several agencies represented on the council concerning the program of the North~~  
15 ~~Dakota state medical center, the adaptation of the medical center to the needs of~~  
16 ~~the state and to the requirements and facilities of the several agencies involved,~~  
17 ~~and the use of the North Dakota state medical center and its facilities by the~~  
18 ~~various institutions and agencies of the state and its political subdivisions~~ perform  
19 the duties in section 15-52-04.

20 2. The council consists of ~~fourteen~~ fifteen members:  
21 a. (1) Two members of the senate, one of whom must be from the majority  
22 party and one of whom must be from the minority party, selected by the  
23 chairman of the legislative council; and

- 1                   (2) Two members of the house of representatives, one of whom must be  
2                   from the majority party and one of whom must be from the minority  
3                   party, to be selected by the chairman of the legislative council;
- 4           b. One member selected by each of the following:
- 5                   (1) The department of human services;
- 6                   (2) The state board of higher education;
- 7                   (3) The state department of health;
- 8                   (4) The North Dakota medical association;
- 9                   (5) The North Dakota healthcare association; ~~and~~
- 10                  (6) The veterans administration hospital in Fargo; and
- 11                  (7) The university of North Dakota center for rural health; and
- 12           c. ~~One member~~ Four members selected by the dean of the university of North  
13                  Dakota ~~medical school~~ of medicine and health sciences, one from each of the  
14                  four ~~campus areas~~ campuses of the ~~medical school~~ of medicine and health  
15                  sciences with headquarters in Bismarck, Fargo, Grand Forks, and Minot.
- 16           3. The representatives named by the state agencies and boards must be selected to  
17                  serve as members of the ~~medical center~~ advisory council for periods of at least  
18                  one year, but may not serve longer than their term of office on the public agency.  
19                  The representatives from the North Dakota state medical association and the  
20                  North Dakota healthcare association shall serve a term of three years or until their  
21                  successors are named and qualified.
- 22           4. The council shall name its own chairman and the dean of the university of North  
23                  Dakota ~~medical~~ school of medicine and health sciences shall serve as executive  
24                  secretary of the council. The council shall meet not less than twice each year,  
25                  and, from time to time, on its own motion or upon request of the university  
26                  administration, ~~to consider plans and programs of action for the North Dakota state~~  
27                  ~~medical center and make its recommendations to the several agencies of the state~~  
28                  ~~and political subdivisions involved and to the legislative assembly.~~

29           **SECTION 2. AMENDMENT.** Section 15-52-04 of the North Dakota Century Code is  
30           amended and reenacted as follows:

1           **15-52-04. Duties of council.** ~~The medical center advisory council shall study,~~  
2 ~~consider, and formulate plans for facilitating and implementing, through the North Dakota state~~  
3 ~~medical center, a unified program for the improvement and maintenance of the health of the~~  
4 ~~people of the state in all of its phases. The study must include specifically ways and means of~~  
5 ~~bringing about the complete training of adequate numbers of qualified physicians and surgeons~~  
6 ~~for the people of the state, both in the general practice of medicine and surgery and the field of~~  
7 ~~public health, of allied health professionals, and all other personnel concerned with the~~  
8 ~~improvement and preservation of the health of the people of this state.~~

9           1. The advisory council, in consultation with the school of medicine and health  
10 sciences and the other agencies, associations, and institutions represented on the  
11 advisory council, shall study and make recommendations regarding the strategic  
12 plan, programs, and facilities of the school of medicine and health sciences.

13           2. Biennially, the advisory council shall submit a report, together with its  
14 recommendations, to the agencies, associations, and institutions represented on  
15 the advisory council, to the university of North Dakota, and to the legislative  
16 council.

17           3. a. The report must describe the advisory council's recommendations regarding  
18 the strategic plan, programs, and facilities of the school of medicine and  
19 health sciences as developed under subsection 1. The recommendations for  
20 implementing strategies through the school of medicine and health sciences  
21 or other agencies and institutions must:

22                   (1) Address the health care needs of the people of the state; and  
23                   (2) Provide information regarding the state's health care workforce needs.

24           b. The recommendations required under subdivision a may address:

25                   (1) Medical education and training;

26                   (2) The recruitment and retention of physicians and other health care  
27 professionals;

28                   (3) Factors influencing the practice environment for physicians and other  
29 health care professionals;

30                   (4) Access to health care;

31                   (5) Patient safety;

1                   (6) The quality of health care and the efficiency of its delivery; and

2                   (7) Financial challenges in the delivery of health care.

3           4. The council may consult with any individual or entity in performing its duties under  
4           this section.

5           **SECTION 3. AMENDMENT.** Section 15-52-30 of the North Dakota Century Code is  
6 amended and reenacted as follows:

7           **15-52-30. Contracts or agreements authorized - Legislative intent.**

8           1. The state board of higher education ~~upon the recommendation of the medical~~  
9           ~~center advisory council~~ is hereby authorized to enter into contracts or agreements,  
10           both interstate and intrastate, to provide medical education opportunities. These  
11           contracts and agreements must be made within the limits of available legislative  
12           appropriation and may be for such periods of time as the state board of higher  
13           education deems necessary.

14           2. It is ~~hereby declared to be~~ the intent of the legislative assembly that the state of  
15           North Dakota, through its state board of higher education, provide for a  
16           comprehensive program of medical education leading to a doctor of medicine  
17           degree.

18           **SECTION 4. AMENDMENT.** Section 15-52-31 of the North Dakota Century Code is  
19 amended and reenacted as follows:

20           **15-52-31. Admission of students - Qualifications.** The faculty of the school of  
21           medicine and health sciences at the university of North Dakota may, with the ~~approval~~ advice  
22           of the ~~medical center~~ school of medicine and health sciences advisory council and with the  
23           approval of the state board of higher education, adopt such rules and regulations governing the  
24           education and residency qualifications of applicants for admission to the ~~medical~~ school of  
25           medicine and health sciences as it deems necessary and proper.
