

**FIRST ENGROSSMENT
with Conference Committee Amendments**

ENGROSSED HOUSE BILL NO. 1016

Introduced by

Appropriations Committee

(At the request of the Governor)

1 A BILL for an Act to provide an appropriation for defraying the expenses of the office of the
2 adjutant general; to provide statements of legislative intent; to provide an appropriation; to
3 provide for transfers; to provide an exemption; to amend and reenact subsections 3 and 4 of
4 section 37-29-03 as created by section 1 of House Bill No. 1181, as approved by the sixty-first
5 legislative assembly, and section 54-06-27 of the North Dakota Century Code, relating to job
6 protections for volunteer emergency responders of the adjutant general's office and leave for
7 emergency service volunteers; to provide for a report to the budget section; and to declare an
8 emergency.

9 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

10 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the
11 funds as may be necessary, are appropriated out of any moneys in the general fund in the state
12 treasury, not otherwise appropriated, and from special funds derived from federal funds and
13 other income, to the office of the adjutant general for the purpose of defraying the expenses of
14 that agency, for the biennium beginning July 1, 2009, and ending June 30, 2011, as follows:

29 SECTION 2. APPROPRIATION - FEDERAL FISCAL STIMULUS FUNDS -

30 ADDITIONAL FUNDING APPROVAL. The funds provided in this section, or so much of the
31 funds as may be necessary, are appropriated from federal funds made available to the state

1 under the federal American Recovery and Reinvestment Act of 2009, not otherwise
2 appropriated, to the adjutant general, for the period beginning with the effective date of this Act
3 and ending June 30, 2011, as follows:

4 Military energy-related maintenance and repairs \$2,522,270

5 The adjutant general may seek emergency commission and budget section approval
6 under chapter 54-16 for authority to spend any additional federal funds received under the
7 federal American Recovery and Reinvestment Act of 2009 in excess of the amounts
8 appropriated in this section for the period beginning with the effective date of this Act and
9 ending June 30, 2011.

10 Any federal funds appropriated under this section are not a part of the agency's 2011-13
11 base budget. Any program expenditures made with these funds will not be replaced with state
12 funds after the federal American Recovery and Reinvestment Act of 2009 funds are no longer
13 available.

14 **SECTION 3. APPROPRIATION - FEDERAL FISCAL STABILIZATION - OTHER**

15 **GOVERNMENT SERVICES.** There is appropriated from federal fiscal stabilization - other
16 government services funds made available to the governor under the federal American
17 Recovery and Reinvestment Act of 2009, not otherwise appropriated, the sum of \$1,261,500, or
18 so much of the sum as may be necessary, to the adjutant general for the purpose of replacing
19 boilers, constructing an operations center, and enhancing security relating to the national crime
20 information center, for the biennium beginning July 1, 2009, and ending June 30, 2011. Any
21 federal funds appropriated under this section are not a part of the agency's 2011-13 base
22 budget.

23 **SECTION 4. APPROPRIATION - FLOOD-RELATED COSTS.** There is appropriated
24 from special funds derived from federal funds or other income the sum of \$50,000,000, or so
25 much of the sum as may be necessary, to the adjutant general for the purpose of defraying
26 expenses relating to 2009 flood disasters, for the period beginning with the effective date of this
27 Act through June 30, 2011.

28 **SECTION 5. APPROPRIATION - VOLUNTEER MANAGEMENT GRANT PROGRAM.**

29 There is appropriated out of any moneys in the general fund in the state treasury, not otherwise
30 appropriated, the sum of \$400,000, or so much of the sum as may be necessary, to the
31 department of emergency services to provide grants to political subdivisions for payments to

1 entities that have provided volunteer management services within that political subdivision for a
2 particular disaster in an amount that may not exceed \$50,000 for each disaster, for the period
3 beginning with the effective date of this Act and ending June 30, 2011.

4 **SECTION 6. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO**
5 **SIXTY-SECOND LEGISLATIVE ASSEMBLY.** The following amounts reflect the one-time
6 funding items approved by the sixtieth legislative assembly for the 2007-09 biennium and the
7 2009-11 one-time funding items included in the appropriation in section 1 of this Act:

17 The 2009-11 one-time funding amounts are not a part of the entity's base budget for the
18 2011-13 biennium. The adjutant general shall report to the appropriations committees of the
19 sixty-second legislative assembly on the use of this one-time funding for the biennium
20 beginning July 1, 2009, and ending June 30, 2011.

21 **SECTION 7. VETERANS' CEMETERY MAINTENANCE FUND - APPROPRIATION.**

22 In addition to the amount appropriated to the adjutant general in the veterans' cemetery line
23 item in subdivision 1 of section 1 of this Act, there is appropriated any additional funds which
24 are received and deposited in the veterans' cemetery maintenance fund pursuant to sections
25 37-03-14 and 39-04-10.10 for the operation of the North Dakota veterans' cemetery for the
26 biennium beginning July 1, 2009, and ending June 30, 2011.

27 **SECTION 8. MAINTENANCE AND REPAIRS - TRANSFERS.** The adjutant general
28 may transfer to the operating expenses and capital assets line items contained in section 1 of
29 this Act up to the sum of \$500,000 from the various other line items contained in section 1 of
30 this Act, as determined necessary by the adjutant general to provide for the maintenance and
31 repair of state-owned armories in this state during the biennium beginning July 1, 2009, and

1 ending June 30, 2011. Any amounts transferred pursuant to this section must be reported to
2 the director of the office of management and budget.

3 **SECTION 9. EXEMPTION.** Funding of \$980,000 from the general fund appropriated
4 for the computer-aided dispatch project, as contained in subdivision 2 of section 3 of chapter 42
5 of the 2007 Session Laws, is not subject to the provisions of section 54-44.1-11, and any
6 unexpended funds from these appropriations or related revenues are available and may be
7 expended during the biennium beginning July 1, 2009, and ending June 30, 2011.

8 **SECTION 10. LEGISLATIVE INTENT - REINTEGRATION PROGRAM.** It is the intent
9 of the sixty-first legislative assembly that the adjutant general use all federal funds available for
10 the reintegration program before using the \$1,377,409 appropriated for the program in
11 subdivision 1 of section 1 of this Act. The funding for the program is to be used for providing
12 support for all service members and their families for the biennium beginning July 1, 2009, and
13 ending June 30, 2011.

14 **SECTION 11. REINTEGRATION PROGRAM - REPORT TO THE BUDGET**

15 **SECTION.** The adjutant general shall provide a report to the budget section during the
16 2009-10 interim regarding reintegration program expenditures and the program's impact on
17 service members.

18 **SECTION 12. LEGISLATIVE INTENT - STATE RADIO COMMUNICATIONS**

19 **COVERAGE.** It is the intent of the sixty-first legislative assembly that the funding of \$500,000
20 appropriated in the radio communications line item in subdivision 2 of section 1 of this Act is for
21 improving state radio communications coverage in the state. Of the \$500,000, \$100,000 is for
22 conducting a study of the effects of next generation 911, \$75,000 is for alternatives to
23 constructing new state radio towers, and \$325,000 is for implementing a new state radio tower
24 site near Wales.

25 **SECTION 13. LEGISLATIVE INTENT - DISASTER FUNDING.** It is the intent of the
26 sixty-first legislative assembly that 2009 flood disaster payments to political subdivisions be
27 made allowing for a six percent local share. The difference between current federal funding
28 and anticipated federal funding is to be made by the state until federal reimbursement funds are
29 received for the period beginning with the effective date of this Act through June 30, 2011.

1 **SECTION 14. AMENDMENT.** Subsections 3 and 4 of section 37-29-03 of the North
2 Dakota Century Code as created by section 1 of House Bill No. 1181, as approved by the
3 sixty-first legislative assembly, are amended and reenacted as follows:

4 3. Subsection 1 does not apply if due to serving as a volunteer emergency
5 responder, the employee is absent or tardy from the employee's place of
6 employment for a period that exceeds ~~ten~~ twenty regular ~~business~~ working days in
7 a calendar year.

8 4. In order to receive the protections of subsection 1, an employee who will be absent
9 or tardy from the employee's place of employment while serving as a volunteer
10 emergency responder in the case of a disaster or emergency shall make
11 reasonable efforts to notify the employer of that service ~~and shall continue to make~~
12 ~~those reasonable notification efforts over the course of the absence.~~

13 **SECTION 15. AMENDMENT.** Section 54-06-27 of the North Dakota Century Code as
14 amended in section 2 of House Bill No. 1181, as approved by the sixty-first legislative
15 assembly, is amended and reenacted as follows:

16 **54-06-27. Emergency service volunteers - Leave.** Upon issuance of an order or
17 proclamation declaring a state of disaster or emergency pursuant to chapter 37-17.1, a search
18 emergency by the air force rescue coordination center or by the department of emergency
19 services, or a declaration of at least a level II disaster by the American red cross in this or any
20 other state, the executive officer in charge of a state agency or the governing body of any
21 political subdivision may grant a leave of absence to any full-time employee of that
22 governmental entity who is an emergency medical service provider, a member of the civil air
23 patrol, a firefighter, police officer, volunteer member of the North Dakota army or air national
24 guard, or emergency radio operator, or who performs other services necessary in an
25 emergency. The leave of absence must be for the purpose of allowing that employee to
26 provide voluntary emergency services. An individual on leave under this section is not deemed
27 to be an employee of the governmental entity for the purposes of workforce safety and
28 insurance. The cumulative leave granted under this section may not exceed ~~ten~~ twenty
29 working days during any calendar year. The leave may not result in a loss of compensation,
30 seniority, annual leave, sick leave, or accrued overtime for which the employee is otherwise
31 eligible.

1 **SECTION 16. EMERGENCY.** Sections 2, 3, 4, 5, 13, 14, and 15 are declared to be an
2 emergency measure.
