Bismarck, January 19, 2009

The Senate convened at 1:00 p.m., with President Dalrymple presiding.

The prayer was offered by Pastor Dale Emery, The United Methodist Church, New Rockford.

The roll was called and all members were present except Senators Grindberg, Holmberg, Krauter, Taylor, and Warner.

A quorum was declared by the President.

POINT OF PERSONAL PRIVILEGE

SEN. FIEBIGER: Mr. President: I rise on a point of personal privilege.

As we gather to do the people's work today, January 19th, let us lift up and recognize the day set aside to honor the birthday of Dr. Martin Luther King, Jr. Let us recognize and celebrate Dr. King's contributions to the advancement of human rights in this great nation. Dr. King dedicated his life to working to make justice a reality for all our citizens and to remind us that the time is always right to do what's right. He worked tirelessly to advance the rights of Blacks and all who were victims of injustice. He was instrumental in the passage of the Civil Rights Act of 1964 and the Voting Rights Act. And as we recognize Dr. King's legacy, we lift up all those who worked tirelessly and without recognition, those who marched and those who chose to walk rather than ride the bus, and those who also gave their lives.

Dr. King spoke eloquently that the ultimate measure of a man is not where he stands in moments of comfort and convenience, but where he stands at a time of challenge and controversy.

Mr. President, as we are poised on the eve of the historical inauguration of the forty-fourth President of the United States of America, the son of a Black man from Kenya and a white woman from the state of Kansas, let us remember Dr. King for his action and ultimate sacrifice that are a part of our history. Dr. King understood and spent his life educating others that we must judge people by the content of their character and that we must continue to work to change hearts, not just laws.
