Approve any agreement between a North Dakota state entity and South Dakota to form a bistate authority (NDCC § 54-40-01)

Receive report from the Commissioner of Veterans' Affairs by December 1, 2009, July 1, 2010, and December 1, 2010, regarding the number of county veterans' service officers accredited by the National Association of County Veterans' Service Officers and the use of funds for accreditation training for county veterans' service officers (2009 S.L., ch. 302, § 4)

Receive report from the board of county commissioners of each county by December 1, 2010, on the status of the county's compliance with the county veterans' service officer accreditation requirements (2009 S.L., ch. 302, § 4)
