- Receive annual report from the Department of Human Services describing enrollment statistics and costs associated with the children's health insurance program state plan (NDCC § 50-29-02)
- Contract with a private entity, after receiving recommendations from the Insurance Commissioner, to provide a cost-benefit analysis of every legislative measure mandating health insurance coverage of services or payment for specified providers of services, or an amendment that mandates such coverage or payment (NDCC § 54-03-28)
- Receive periodic reports from the State Health Officer and the Regional Public Health Network Task Force during the 2009-10 interim on the protocol for the regional public health network (2009 S.L., ch. 225, § 2)
- Receive annual reports from the Department of Human Services during the 2009-10 interim regarding the status of the alternatives-to-abortion services program (2009 S.L., ch. 412, § 2)
- Receive accountability report from the North Dakota Fetal Alcohol Syndrome Center before September 1, 2010, with respect to the use of funds granted to the center by the State Department of Health (2009 S.L., ch. 63, § 2)
