I am a "musher" from the Iron Range of Northern Minnesota. My friendship with Jim and Mary Ann Miller began in 1998, when Mary Ann and her son Mike, traveled to my dog sled kennel to adopt three of my retired dogs. Since then I have had the pleasure of visiting Jim and Mary Ann in all seasons of the year. After the last 2 visits I have seen a change in their environmental quality of life. The new wind turbines create a noisy, unsettled atmosphere

at their home. After walking outside around their property, I have noticed noise similar to an interstate highway loaded with traffic. They don't live near an interstate highway. The noise created by the turbines is constant and annoying. The visual disturbance is substantial. The "shadow flicker" and the constant motion of the turbines produces an unsettled feeling in me. There is an uneasy feeling within me about these large structures and their constant noise and motion so close to a home. The close proximity of these turbines has damaged the

"pristine" quality of the Miller's home and surrounding property. This once rural property has now been altered environmentally and visually. It now has the look and feel of an industrial property, not a beautiful rural piece of North Dakota. I had once considered buying property and retiring close to this area. I am disappointed with the change and I am no longer considering retiring here.




