## Goal of North Dakota Centers of Excellence Program

Encourage collaboration between public universities and private businesses to bring new products and services to the marketplace that result in new higher paying jobs for the citizens of North Dakota.




#### **Status of the Centers**

- Our program is still in the early stages of development. No center has yet reached its maturity.
  - 7 centers in operation 1 fiscal year
  - 3 centers in operation for 2 fiscal years
  - 9 centers in operation for 3 fiscal years
  - 1 center in operation for 4 fiscal years





### **Economic Impact**




- \$19.9 million in state funding has resulted in an economic impact of \$329.4 million through June 30, 2009.
- Includes direct impact of \$115.5 million generated by the Centers and their partners.





#### **Job Creation**



- 2,060 total jobs.
- 922 direct jobs at an estimated annual payroll of \$44.5 million.
- 1,138 jobs supported by the Centers and partners.

## Private Sector Partners



- The Centers have partnerships with 135 companies.
  - Target industries (advanced manufacturing, energy, technology, and value-added agriculture.
  - Emerging industries (life sciences and unmanned aircraft systems).





#### **New Businesses**




- Centers have been involved in 17 new or expanded businesses.
  - 7 new spinoff companies.
  - 5 companies that expanded to North Dakota.
  - 5 companies that have expanded within the state.





#### **Funding**



- One-third of the investment allocated as of June 30, 2009.
- Projected impact should reach \$1 billion when projects are funded and mature.





### **Matching Funds**



• \$134.8 million of matching and leveraged funds obtained as of June 30, 2009.





## **Enhancement Grants**



- \$2.254 million for UND UAS Research,
   Education & Training Enhancement Grant
- \$4 million for NDSU Research 1 Expansion
- \$1 million for NDSU Materials and Nanotechnology Centre
- \$200,000 for GFAFB Realignment Business Transition Enhancement Grant



#### **2010 Monitoring Process**

- The legislature will receive the 2010 Annual Report in January after the following:
  - Functional reviews completed by each Center by September 1<sup>st</sup>
  - "Agreed upon procedures" conducted by third party auditors and reports provided by September 22<sup>nd</sup>
  - Site visits conducted at each Center in September and October
  - Economic Impact study completed in November



## Performance Audit Recommendations

- Action has been taken to address all 15 recommendations
- Requesting legislative help on the recommendation dealing with the annual audit requirement
  - COE Commission has recommended that the legislature change statute to allow for continuation of "agreed upon procedures"



#### **Centers of Excellence Future**

- Centers of Excellence Best Practices Review was conducted
- Interim Workforce Committee has received recommendations
