At this time, no additional state match funding is anticipated on the grants noted above.

In addition, since the American Recovery and Reinvestment Act funds were first announced, the North Dakota University System has remained in close contact with JobService ND and the Workforce Development Council regarding the availability of grants related to workforce training and development. All information received about potential grants is immediately forwarded to our community college presidents for review and distribution to appropriate departments on their campuses. As the community colleges submit ARRA grant proposals, they will keep us apprised during the monthly Community and Technical Education Council (CTEC) meetings.

To date, the eligible applicants for the majority of such grant opportunities are the state workforce investment boards (North Dakota Workforce Development Council) and JobService North Dakota rather than colleges. However, partnering is encouraged, and the Workforce Development Council and JobService are aware that the North Dakota University System is ready and willing to collaborate with them as appropriate to bring ARRA competitive grant funds to the state.

Later this year, the US Department of Education will conduct a national competition among states for a \$4.35 billion state incentive "Race to the Top" fund to improve education quality and results statewide. The Race to the Top fund will help states drive substantial gains in student achievement by supporting states making dramatic progress on the four reform goals and effectively using other *ARRA* funds. The guidelines and applications for these competitive grants are not yet available. They are expected to be released later this summer or fall.
