1 A BILL for an Act to amend and reenact section 15.1-27-03.1 of the North Dakota Century
2 Code, relating to the determination of weighted average daily membership.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. AMENDMENT.** Section 15.1-27-03.1 of the North Dakota Century Code
5 is amended and reenacted as follows:

6 **15.1-27-03.1. Weighted average daily membership - Determination.**

- 7 1. For each school district, the superintendent of public instruction shall multiply by:
- 8 a. 1.00 the number of full-time equivalent students enrolled in a migrant summer
9 program;
 - 10 b. 1.00 the number of full-time equivalent students enrolled in an extended
11 educational program in accordance with section 15.1-32-17;
 - 12 c. 0.60 the number of full-time equivalent students enrolled in a summer
13 education program;
 - 14 d. 0.50 the number of full-time equivalent students enrolled in a home-based
15 education program and monitored by the school district under chapter
16 15.1-23;
 - 17 e. 0.25 the number of full-time equivalent students enrolled in an alternative high
18 school;
 - 19 f. 0.25 the number of full-time equivalent students enrolled in an isolated
20 elementary school;
 - 21 g. 0.25 the number of full-time equivalent students enrolled in an isolated high
22 school;
 - 23 h. 0.20 the number of full-time equivalent students attending school in a
24 bordering state in accordance with section 15.1-29-01;

- 1 i. 0.17 the number of full-time equivalent students enrolled in an early childhood
2 special education program;
- 3 j. 0.14 the number of full-time equivalent students enrolled in a new immigrant
4 English language learner program;
- 5 k. 0.067 the number of students enrolled in average daily membership, in order
6 to support the provision of special education services; and
- 7 l. 0.02 the number of full-time equivalent students, other than those provided for
8 in subdivision j, who are enrolled in an English language learner program.
- 9 m. _____ the average annual enrollment of full-time equivalent students who
10 were eligible for free or reduced lunches under the Richard B. Russell
11 National School Lunch Act, 42 U.S.C. 1751 et seq., as determined over the
12 period encompassing the preceding three school years.
- 13 2. The superintendent of public instruction shall determine each school district's
14 weighted average daily membership by adding the products derived under
15 subsection 1 to the district's average daily membership.
