1 A BILL for an Act to provide an appropriation for defraying the expenses of the office of the
2 governor; and to amend and reenact sections 54-07-04 and 54-08-03 of the North Dakota
3 Century Code, relating to the salaries of the governor and lieutenant governor.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the
6 funds as may be necessary, are appropriated out of any moneys in the general fund in the state
7 treasury, not otherwise appropriated, and from special funds derived from federal funds and
8 other income, to the office of the governor for the purpose of defraying the expenses of the
9 office of the governor, for the biennium beginning July 1, 2009, and ending June 30, 2011, as
10 follows:

SECTION 2. APPROPRIATION - AUTHORIZATION - LIMITATION - GOVERNOR'S

OFFICE. In addition to the amounts appropriated to the governor's office in section 1 of this Act, there is appropriated any additional income from federal or other funds which may become available to the agency for the biennium beginning July 1, 2009, and ending June 30, 2011. Any federal funds made available to the governor's office resulting from federal action to provide funding to the states to stimulate the national economy or to address state fiscal recovery may be accepted under this section but may not be spent until appropriated by the legislative assembly.

SECTION 3. AMENDMENT. Section 54-07-04 of the North Dakota Century Code is amended and reenacted as follows:

54-07-04. Salary of governor. The annual salary of the governor is ~~ninety-six one hundred five thousand one hundred eighty-three and thirty-four~~ one hundred eighty-five thousand dollars through June 30, ~~2008~~ 2010, and one hundred ~~ten thousand thirty-one~~ two hundred eighty-five dollars thereafter.

SECTION 4. AMENDMENT. Section 54-08-03 of the North Dakota Century Code is amended and reenacted as follows:

54-08-03. Salary of lieutenant governor. The annual salary of the lieutenant governor is ~~seventy-four eighty-one thousand six hundred sixty-eight thirty-eight~~ eighty-one thousand six hundred dollars through June 30, ~~2008~~ 2010, and ~~seventy-seven eighty-five thousand six hundred fifty-five~~ eighty-five thousand six hundred fifteen dollars thereafter.
