- 1 A BILL for an Act to provide an appropriation for defraying the expenses of the department of
- 2 human services; and to amend and reenact sections 50-06-29, 50-24.1-02.3, and 50-29-04 of
- 3 the North Dakota Century Code, relating to the establishment of an aging and disability
- 4 resource center, the exempt amount of designated pre-need funeral service contracts in
- 5 considering eligibility for medical assistance, and eligibility under the state children's health
- 6 insurance program.

7 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds as may be necessary, are appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, and from special funds derived from federal funds and other income, to the department of human services for the purpose of defraying the expenses of its various divisions, for the biennium beginning July 1, 2009, and ending June 30, 2011, as follows:

27	SECTION 3. FUNDING 1	RANSFERS - EXCEPT	TION - AUTHORIZ	ZATION.
28	Notwithstanding section 54-16-04, the department of human services may transfer			
29	appropriation authority between line items within each subdivision of section 1 of this Act and			
30	between subdivisions within section 1 of this Act for the biennium beginning July 1, 2009, and			
31	ending June 30, 2011. The depart	rtment shall notify the o	ffice of manageme	ent and budget of

- 1 any transfer made pursuant to this section. The department shall report to the budget section
- 2 after June 30, 2010, any transfers made in excess of \$50,000 and to the appropriations
- 3 committees of the sixty-second legislative assembly regarding any transfers made pursuant to
- 4 this section.
- 5 SECTION 4. ESTIMATED INCOME LIMIT HEALTH CARE TRUST FUND. The
- 6 estimated income line item in subdivision 2 of section 1 of this Act includes \$3,000,000 from the
- 7 health care trust fund for nursing facilities. The department of human services expenditures
- 8 from this fund may not exceed this amount for the biennium beginning July 1, 2009, and ending
- 9 June 30, 2011.
- 10 **SECTION 5. AMENDMENT.** Section 50-06-29 of the North Dakota Century Code is
- 11 amended and reenacted as follows:
- 12 **50-06-29.** Application for aging Aging and disability resource center funding. No
- 13 later than December 31, 2007, the The department of human services shall seek federal funds
- 14 for the planning plan and implementation of implement an aging and disability resource center
- 15 for the state. The resource center will be a single point of information program at the
- 16 community level which will help people make informed decisions about the full range of
- 17 long-term care service and support options, including both institutional and home and
- 18 community-based care, and which will provide unbiased information and assistance to
- 19 individuals needing either public or private resources, to professionals seeking assistance on
- 20 behalf of their clients, and to individuals planning for their future long-term care needs. Upon
- 21 receipt of federal funds, the The department of human services may establish the aging and
- 22 disability resource center or it may request bids and award a contract for the provision of this
- 23 service. The duties of the aging and disability resource center must include all duties required
- 24 to receive federal funds, including by the 2006 amendments to the Older Americans Act [Pub.
- 25 <u>L. 109-365; 120 Stat. 2522; 42 U.S.C. 3001 et seq.]</u>, providing information about the full range
- of long-term care service and support options available in the state to assure that consumers
- 27 may make informed decisions about their care. The resource center must be free from a
- 28 conflict of interest which would inappropriately influence or bias the actions of a contractor, staff
- 29 member, board member, or volunteer of the resource center to limit the information given to a
- 30 consumer to steer the consumer to services that may also be provided by the resource center.

11	1 may designate all or a portion of the three thousand dollar asset limitation for funeral pre-need				
12	contracts, p	orepa	yments, or deposits. Interest or earnings retained in a funeral fund also may		
13	3 not be considered as an available resource. A pre-need funeral service contract, prepayment,				
14	4 or deposit designated under this section is not a multiple-party account for purposes of chapter				
15	5 30.1-31. No claim for payment of funeral expenses may be made against the estate of a				
16	6 deceased medical assistance recipient except to the extent that funds maintained in				
17	accordance	e with	this section total less than five seven thousand dollars.
